Two more candidates announce run for Kenley's seat

Two more candidates announced they will be running for Indiana's District 20 Senate seat, which is being vacated by Luke Kenley.

Current Hamilton County Council member Brad Beaver made the announcement on Thursday, as did Noblesville resident and businessman Joe Morris.

"I have served on the Hamilton County Council for 20 years," said Beaver. "I have never missed a County Council meeting and during my tenure I have never raised property taxes. Yet the Council has still managed to accumulate a \$50 million surplus. Hamilton County is one

of the most fiscally sound governmental entities in the State. While some politicians may claim to be conservative - I have proven my commitment to taxpayers over the last 20 years. I feel this record clearly sets me apart from other candidates."

"Indiana is the envy of the Midwest, in large part because it has elected state representatives and senators who have exercised fiscal restraint while making our State a beacon for economic development. We must ensure that we send another proven conservative to the Statehouse – one who will be a good steward of taxpayer money and pursue a truly conservative agenda. I am confident that I am the candidate that is most prepared to do this."

Beaver was born and raised in Noblesville, graduating from Noblesville High School in 1977. After college, he started his own heating and cooling business. Nickel Plate Rail saga gets more complex

The Nickel Plate saga seems to get more complex by the day. With owners of the railroad considering proposals for the tracks' future use, and a tort claim by the Indiana Transportation Museum (ITM) for

damages pending in court, a new wrinkle has developed.

The City of Logansport wants the museum to have a location in that city. Whether this means the museum completely pulling out of Noblesville is unclear. But, opening in Logansport while unable to operate its trains on the Nickel Plate would seem to mean the focus of the museum's efforts would be headed north.

The ITM has been in Noblesville's Forest Park for many years and has operated excursion trains on the Nickel Plate rails for 20 years or more. But, since March 2016 the organization has been unable to run their

trains due to safety concerns expressed by the Hoosier Heritage Port Authority, owners of the tracks.

Local officials at the city and county level have indicated they would like to convert the railroad to a walking and jogging trail. This idea has become controversial as supporters of retaining the railroad have organized to make the issue a political "hot potato."

Last year it appeared the ITM might not be able to afford to make safety corrections,

Celebrating 50 years of Health

It's not often that a person serves for 50 years as a member of a governmental body. But, Noblesville's Garrick Mallery holds that honor, possibly a record in the state if not the nation. Not only that, but Mallery has been president of the Hamilton County Health Board almost the entire time

The health department is celebrating its 50th anniversary this year. An open house for the public is planned from 9 to 11 a.m. on Thursday, July 27 at the health office. There will be a display of historic vital records going back 135 years. Cake and coffee will be served. The department was actually organized in 1966, but the following year was its first full year in business. Operating out of a room in the basement of the old Courthouse, there were initially three employees: a nurse, a sanitarian and a secretary.

The first board, appointed by county commissioners, was composed of Dr. John

Haywood, Dr. Haldon Kraft, Max Hunter, James Morris, Gerald Johnson and Garrick Mallery, who said recently, "It's been interesting. I've done a lot of things, but this was one of the highlights of my life seeing it [the department] come along" to where it is today

The health department has expanded dramatically as the county has grown. Health inspectors now check hundreds of restaurants and other food handlers to protect the public from unsanitary conditions, provide immunizations for the county's children, maintain all county birth and death records, seek to eliminate dangerous mosquito breeding grounds and provide public education on best health practices among other services.

Mallery believes the health department does more good for Hamilton County than perhaps the public sometimes gets from the news. Thursday the doors will be open to show the public what all they have in the field of public health.



Caucus to fill Kenley's spot should be public

It is beginning to look like a crowded field of candidates later this summer when precinct committeemen choose a new state senator to fill out retiring State Sen. Luke Kenley's term. But, if tradition is maintained



the public and the press won't be witness to it. Kenley announced earlier this month he will resign Sept. 30 from the Senate where he has been an influential member for 25 years. Up to a half-dozen local Republicans have either announced they want the District 20 seat or are considering running for it

The new state senator will be selected by a caucus of the precinct committeemen and women of the district. And, due to the lack of state law guaranteeing a public and open caucus, the selection process will likely be closed to the public.

It is even possible that a person could file for the vacant seat, win in the caucus and be be sworn into office before the public knows who that person is. There is no public call for interested persons to file, no requirement that names of candidates be public, and no requirement that the caucus vote be public.

State law allows political parties to hold private meetings to discuss political strategy, elect officers, and apparently by omission, hold closed sessions to fill vacancies in public office. It is a glaring example of the lack of transparency that most politicians claim to oppose.

In the current case, five candidates have come forward to announce their intentions. Megan Wiles, Victoria Spartz, Sue Finkam, Brad Beaver and Joe Morris have made their plans known. Others may do so, but are not required to tell anyone except the party leadership which will notify committee members and hold the caucus at a yet to be determined date. In the past, Hamilton County Republican Chair Laura Campbell must be credited with revealing the date and location of a caucus, names of those running, and the winner, none of which she would be required to make public.

Mrs. Campbell has said, however, that doors will be closed because she believes such action could prevent undue influence being exerted on committeemen.

This writer believes an office as important as state senator, and any public office for that matter, should not be filled in secret. The law that seems to allow it should be amended to open the doors when choosing a public official who will be representing all the people of his or her jurisdiction. It is the right thing to do.

HUD investigation in Noblesville could impact entire county

What is the correct term for the federal government investigating a community for being too successful? Government overreach? The increasingly short march towards socialism? The Fair Housing Center of Central Indiana (FHCCI) would probably call it fighting housing discrimination. Towards that end they filed complaints with the U.S. Department of Housing and Urban Development (HUD) against the City

of Noblesville and Hamilton County.

The complaints allege that the City and the County are proactively erecting significant barriers to "racial and ethnic integration and to keep out families with children." FHCCI maintains that they did this by blocking affordable housing for development and limiting housing opportunities for families. The problem? Noblesville has more subsidized housing than any oth-

er community in Hamilton County. The complaint and investigation are not really about housing options at all, it's about Noblesville being too successful. Residents of other communities should take note. If Noblesville is guilty of housing discrimination then so is Carmel, Fishers and maybe even Westfield.

The inevitable conclusion from FHCCI's logic is that if a community is suc-

cessful, it must be discriminatory. Because property values are too high they claim that people of color are unable to live here, which of course is false. For residents this should be concerning not just because a HUD decision against Noblesville and the County could impact their own property values, but because of what it would do to local government and school funding. In Indiana property tax rates are capped


in the constitution, meaning that in order for a city to increase their revenue, they must find ways to raise the assessed value of its properties. Those same taxes go to fund local schools. If having high property values is discriminatory, then having well funded schools and cities is discriminatory

Properties with low assessed value cannot provide the same revenue as properties with higher assessed values, meaning less money for sidewalks, roads, infrastructure, policing etc. In every city space is limited, so the cost to the taxpayers for low income housing is more than just a federal subsidy, it's the cost of not having a more revenue producing building there. For communities in Hamilton County, which are growing at a breathtaking pace, this opportunity cost to the taxpayer could be both enormous and impossible to calculate.

Under the Fair Housing Act, housing discrimination includes practices that make housing unavailable to persons because of race or color, religion, sex, nation-

al origin, familial status or disability. Note that this does not include practices that increase property values of homeowners and protect the taxpayer. If high property values are discriminatory, success is discriminatory. Discrimination is wrong and we must always stand up against it whenever we find it. But this is clearly not discrimination. This is protecting the taxpayer. Affordable housing is an important piece in urban planning, and that is why Noblesville has subsidized housing. The FHCCI doesn't care about the existing housing though, they're only worried that Hamilton County is too successful.

The government that is closest to you can affect you the most, so it is critical that we elect prudent men and women unafraid to grapple with the Federal government to serve as mayors and sit on our city councils. In your day to day life, City Hall is more important than Washington D.C. The FHCCI's allegations are false, but the HUD investigation could have a significant impact on our communities.

We headed out to Icy Straight Point and we were able to see both bears (from a distance) and we also had quite a few whale sightings. One of our stops was in Juneau — the capital







The roster for this year's Fishers team will include a healthy mix of experienced

seniors and juniors. The 12th-graders coming back on the offensive end include running back Michael Noble, who is the leading returning rusher with 341 yards in

Wide receiver Will Syrus, another senior, returns the most catches with 13 and the most yardage among his position with 233. Also back are two quarterbacks who saw varsity action: Senior Matt Wolff and junior Jon Vore, who threw for 658 yards last season. Both Wolff and Vore threw four touchdown passes last season.

Also back are senior tight ends Isaiah Dunnuck and Bryce Gee and right tackle Luke Martin. Juniors on the offensive end returning are center-offensive guard Nathan Pairitz, left guard Andrew Voskuhl, junior running back HL Lewis and junior wide receiver Collin Statz.

The defensive end will be very experienced, with the top three in total tackles returning, all linebackers. Senior Mike Nettleton made 107 tackles last season (72 solo and 35 assists) with 11 tackles for a loss. May calls his offense "young/new," although there are a few key players returning on that side of the ball.

"We have a lot of seniors that have a shot," said May.

One of those seniors will be a standout: Running back Jackson Sweeney. As a junior, Sweeney was easily HSE's overall rushing leader, gaining 874 yards on 160 carries, as well as scoring seven touchdowns. Another running back returning is junior Lance Stephens, who got some solid playing time with 89 yards on 29 carries.

On the receiving end, tight end Nick Mutchner is a key returner as a senior. Mutchner had 30 catches last season for 382 yards.

Southeastern's defense looks to be very
