# Home Place annexation . . . Residents to decide on continuing the fight

Will Home Place soon cease to exist as a somewhat independent though unincorporated community?

The answer appears to be yes, based on the outcome of an Indiana Court of Appeals decision Tuesday. In a 12-year annexation battle with Carmel, the court ruled that Carmel is capable of providing fire protection and other city services to the Home Place community.

But, in the short term annexation depends on the outcome of a vote by residents Nov. 19 on whether or not to appeal the Tuesday ruling to the state Supreme Court. Homeowners opposed to annexation have 30 days to either proceed to the higher court or give

up the fight.

There were indications this week that the fight might go on. Review by the Supreme Court would likely take months as did the case when it was being considered by the Appeals Court.

Carmel wants Home Place in order to complete incorporation of all of Clay Township. The Home Place area is generally bounded by 111th Street on the north, Interstate 465 on the south, Westfield Boulevard on

the east and Pennsylvania Street on the west. The estimated population is slightly under 5,000.

Home Place was somewhat unique when it was platted 103 years ago as an interurban commuter community. The Union Traction Company had completed its electric train route through the area a few years earlier. The Orrin Jessup Land Company created Home Place along the

# Fishers road construction updates, week of Nov. 6

**116th Street**  
**Grand Openings**

With the recent openings of IKEA, Top Golf and Portillo's, please expect delays along the 116th Street corridor. Residents and visitors are encouraged to visit this [website](#) for directional maps and suggestions on how to navigate the area. The **Fishers** and **Drive Fishers** Twitter accounts will both be updated in an ongoing fashion should any immediate updates be shared.

**146th Street**  
Westbound 146th Street east of Allisonville Road in the right turn lane to northbound Allisonville Road will be restricted for test borings, as well as the right eastbound lane of 146th Street west of Allisonville Road. Traffic control will be in place from 9 a.m. to 3 p.m. for the next seven days. Please contact Hamilton County Highway Department at 317-773-7770 with any questions.

**141st Street**  
Lane shifts will occur on 141st Street west of State Road 37 to allow for the construction of a turn lane along the north side of the roadway. Barrels and cones will be in place to direct traffic through the shift.

**116th Street**  
Periodic lane restrictions will occur on 116th Street east of Allisonville Road as the contractor repairs concrete curbs and ramps and begins resurfacing work on the roadway. Restrictions will be in place from 9 a.m. to 3 p.m. Please note that overnight work will occur while traffic volumes are reduced. The City greatly appreciates residents' patience with construction noise.

**Interstate 69**  
Improvements are currently underway to rehabilitate existing bridges, pavement and drainage structures along the 15-mile stretch of interstate. Two lanes of traffic in each direction of I-69 are currently shifted to accommodate construction of the additional travel lanes. Signs direct large trucks to use the left lane while traffic is shifted toward the right shoulder through the work zone. The speed limit is reduced to 60 mph and further reduced to 50 mph when workers are present.

I-69 is expected to open to three lanes in each direction between State Road 37 and State Road 38 before the end of this year. Questions about this project should be directed to INDOT at [east-centralin@indot.in.gov](mailto:east-centralin@indot.in.gov) or 1-855-463-6848.

**State Road 37**  
Geotechnical drilling began along the SR 37 corridor in May as part of the final design phase of SR 37 Improvement Project. Lane and shoulder restrictions will be active through November as crews finish drilling.

The SR 37 improvement project is a \$124 million joint project between Fishers, Hamilton County, Noblesville and INDOT. Questions or concerns may be directed to [drivefishers@fishers.in.us](mailto:drivefishers@fishers.in.us).

**Outside of Fishers**  
Cyntheanne Road between 146th Street and 156th Street will be closed until Dec. 1 to replace the bridge over Keiser Drain. Please contact Hamilton County Highway Department at 317-773-7770 with any questions.

interurban tracks in 1914 with the idea that residents could have rapid access to Indianapolis employment.

A few dozen homes were built over the next 15 years, but the Great Depression followed by the demise of the interurban and World War II virtually halted development until the 1950s when suburban subdivisions were first developed in the area. Home Place was never incorporated as a town.

In recent decades an expanding Carmel virtually surrounded Home Place. Residents opposed being a part of Carmel, and the legal struggle began in 2005. Opponents of annexation say have the public services they need without paying the Carmel city tax rate.

Some Home Place residents also believe Carmel wants to redevelop the area in the city's image with its commercial and dense residential areas. Most of Home Place is composed of older residential areas and only a small commercial area around the main intersection of 106th and College Avenue.

For any liberal to entertain winning the Democratic nomination for president these days, there are some important boxes to be checked, including taking on America's system of law and order. Now Facebook CEO Mark Zuckerberg has begun checking the boxes.

Zuckerberg has hired Hillary Clinton's pollster. He's hired Barack Obama's campaign manager. He's even visited the first presidential caucus state of Iowa. And he's pandering to the left's machine by funding a campaign that aims to get rid of our nation's bail system.

In the dangerous push to end our current bail system, liberals like Zuckerberg are arguing that people across America are being wrongly held in jail because they can't afford to post bail. This is ridiculous. Our bail system is in place to keep law-abiding Americans safe and to ensure that a person accused of a crime actually appears in court so justice is served.

States that have attempted to pass bail reform policies are seeing the failures of unsecured release up close. Harris County in Texas is fighting a federal lawsuit claiming its bail schedule is unconstitutional and that it keeps poor people in jail.

Chief U.S. District Judge Lee H. Rosenthal issued a **federal order** re-

quiring Harris County to make immediate changes to its pretrial release system. The order requires the sheriff's office to release anyone charged with a misdemeanor offense on unsecured release within 24 hours.

According to Harris County data since the order took effect, 32 percent of defendants released on unsecured bond have failed to appear for court, compared to only 4 percent released on a surety bond. Failures to appear cause havoc and long delays in the criminal justice system. Justice cannot be served if the accused does not appear for court.

Examples of such releases are occurring in other jurisdictions around the country. A New Jersey theater employee was **arrested** after law enforcement officers found a bullet-proof vest, grenade, guns and ammunition in his vehicle, causing the theater to be evacuated. He was determined not to be a danger to the community and released on unsecured bond under the new law.

New Jersey's liberal bail reforms caused one state legislator to send a letter to the speaker of the state Assembly in California regarding a similar bill circulating in his state. The letter states that "dangerous and career criminals are released daily within hours of arrest" with no accountability. He urged the California Legislature not to make the same mistake.

While everyone is innocent until proven guilty, judges are right to set bail for individuals who are

charged with a crime. Too many are simply being sent back into the poorest neighborhoods, which proponents of bail reform like Zuckerberg don't live in.

These released individuals, many of whom are repeat offenders, walk out of jail and continue to victimize the very people proponents of bail reform claim to protect – the poor and indigent.

Unsecured release methods and the use of flawed risk assessment tools are coming under fire every day. The Arnold Foundation, which developed a risk assessment tool being used by several jurisdictions such as New Jersey, is a defendant in a federal lawsuit seeking damages in a wrongful death case.

A **career criminal**, who had been arrested on felony gun charges days earlier, was released on unsecured means using the Arnold Foundation's risk assessment tool and then allegedly committed murder.

Elitists like Zuckerberg try to make the argument that the bail system is unfair to poor people, but fail to understand that law-abiding citizens regardless of income level expect laws to be enforced that will keep them safe.

There is nothing safe about the bail reforms currently being implemented and under consideration. Liberals roll out examples of people being held for minor and non-violent crimes who are forced to be away from their families because they couldn't afford monetary bail. Some

such examples do exist.

However, for every one of those stories, there are also stories regarding serious and violent offenders who walk out of jail with no accountability. Headlines such as "**Eastside** restaurant manager, employees accused of raping woman" and "**Jackson** zoning board member grabbed gun before child porn arrest, cops say" are all too common.

What is Zuckerberg's answer to these headlines? Like so many other items on the left's wish list, bail bond reform might sound good at first. However, in the real world where the rest of us live, there are plenty of concerns for tens of millions of Americans who wish to raise their families in a safe society.

Americans expect that when people are accused of stealing, selling illegal drugs, abusing others, driving drunk and otherwise breaking the law, they will appear in court. If convicted, such individuals will be punished for their crimes so that justice will be served.

As the bail bond reform debate continues and Mark Zuckerberg continues his multimillion-dollar quest to boost his standing with the far left's power structure, I hope most Americans can understand that when it comes to thinking about reforming our bail system, it's better to be safe than sorry.

# Carmel stops Bronchos for 29th sectional championship

With everything that the Carmel High School football program has accomplished over the past half-century, it's hard to imagine the Greyhounds doing something they haven't done before.

Carmel found something Friday night. The Greyhounds beat Lafayette Jefferson 41-20 to win the Class 6A Sectional 4 championship, which took place at Carmel Stadium. With the victory, the 'Hounds clinched their fifth straight sectional title, an unprecedented streak for Carmel.

"Definitely awesome," said senior quarterback Jake McDonald. "This tradition at Carmel High School is something special, and to be a part of it is unbelievable."

The Greyhounds' win extends their record number of sectional trophies to 29. Next up for Carmel is the regional; the 'Hounds will play at Fort Wayne Snider next Friday.

In order to win that fifth straight sectional, Carmel had to beat an undefeated Bronchos team. Lafayette Jeff came barreling into Carmel Stadium with a 10-0 record and an offensive average of 46.2 points per game.

But the 'Hounds have a good offense, too. They put it in on display right away when Camari Hunt broke loose and streaked into the end zone for a 62-yard touchdown run. Just 93 seconds into the game, Carmel was ahead 7-0.

The Bronchos answered right away, though. Bishop Johnson made a 52-yard return into Greyhound territory, then worked their way to the two-yard line. On fourth down, Mathew Wilkerson tossed a pass to Zion Austin in the end zone. Jeff went for two, and a Marquis Munoz run put the Bronchos ahead 8-7 midway through the

first.

Neither team scored for a while, until Carmel finally hit pay dirt on a short drive with 2:53 left in the second. McDonald found Aiden Ellison for a 24-yard pass play touchdown. Matt Fortier kicked the extra point on both Greyhound touchdowns, and Carmel led 14-8 at halftime. Fortier also helped out on defense, making an interception in the end zone to deny the Bronchos a late touchdown.

The 'Hounds began to take control of the

# Tigers beat Pike for Sectional 5 title

There's no better place to avenge a regular-season loss than in the sectional championship game.

Fishers did just that on Friday. The Tigers won the Class 6A Sectional 5 title by beating Pike 28-7 at Reynolds Tigers Stadium. This marks the third sectional championship for Fishers in its still-young football history; the Tigers also won in 2010 (on their way to a state title) and in 2012.

Fishers will host Ben Davis for next week's regional championship.

The Red Devils beat Fishers 43-0 in Week 2 of the regular season. According to John Harrell's website, there are eight teams that avenged regular-season losses in the sectional, and the Tigers' victory was the biggest swing of all - 64 points.

"I feel like we were capable of playing

this way," said Fishers coach Rick Wimmer. "It's kind of the way we have to play. We have to control the ball. We're not going to score a lot of points, but we possess the ball and not give the other team too many possessions, too many opportunities and we're playing good defense."

The Tigers scored a touchdown each quarter. The scores in the first half both were on short passes from Matt Wolff to Isaiah Dunnuck. The duo connected on a five-yard pass play late in the first period, then on a six-yard throw with 1:40 left in the second.

Fishers then scored its second-half touchdowns from the ground, both times punching it in from the one-yard line. Wolff ran the ball into the end zone late in the third quarter, then Dylan Scally wrapped things up with a TD at the 4:19 mark of the fourth

period. Ben Norton successfully kicked all four extra points.

The Tigers' defense stepped up big time. Pike averaged 33 points per game coming into the sectional final, but Fishers allowed the Red Devils a lone touchdown in the third quarter. The seven points Pike scored was its lowest output of the season.

"Defensively we didn't give up big chunk plays for touchdowns," said Wimmer. "We planned much better. Guys just playing better. Our defensive coaches have done a tremendous job of getting problems fixed that we had early in the year. They get a lot of the credit for this one. We've been playing better and better defense the last few weeks."

Wimmer also credited the offensive line for playing well, saying that his offense is

being "pretty efficient." The Tigers were almost perfectly balanced between the two phases: Fishers rushed for 132 yards and Wolff threw for 126 yards on 9-of-17 passing. Scally ran for 98 yards.

"Best game our offensive line has played," said Wimmer. "That's the first time this offensive line played together, and this is what we thought we'd be getting to."

The Tigers are now 7-4 for the season.

game in the third quarter, and gained steam on offense as the second half progressed. Fortier got the first points of the third quarter on a 22-yard field goal, then McDonald threw an eight-yard touchdown pass to Atticus Clouse with 4:09 left in the period. Jefferson answered that score with a remarkable drive that saw Wilkerson make seven consecutive pass completions, the last to Jay Segal for a 16-yard score. The Bronchos again tried for a two-point conversion, but Carmel stopped that one. "I think our pass rushing in the second half really made a difference," said Carmel coach John Hebert. "It took a little while to settle it on what we were doing. We played a little more man coverage in the second half, blitzed them more. We had some kids make some really good plays for us." Instead, the 'Hounds moved into the fourth quarter with a nice drive. McDonald hit Clouse with a 43-yard pass that got Carmel to the Jeff 4. Three plays later, McDonald flipped the ball to Zachary Bradley from the one-yard line, another Greyhounds touchdown.

"There's no better feeling than playing on this field, especially on Friday nights with all my guys," said McDonald. He wound up with three touchdowns on the night in his first game back after being injured for several weeks. "Those few weeks out weren't fun, but I did my job to help out Gabe Quigley, who did a great job, came home with his first sectional win and got me another chance to play for this team, because when this is over, I don't know what I'm going to do, honestly," said McDonald. Carmel's last touchdown of the game was score by Dylan Downing, who jogged in from the one-yard line midway through the fourth. Fortier made the subsequent kick, making him 5-for-5 in extra points for the game. Connor Coghlan, who was also out with an injury, came back during this game, and got the Greyhounds' final points with a 24-yard field goal with 1:41 left. "Our kids just stayed with the game plan," said Hebert. "We made a few adjustments and we were able to pull it out in the end." McDonald finished the game 12-of-16 for 173 yards, with Atticus Clouse making seven of those catches for 114 yards. Hunt carried the ball 11 times for 96 yards. Carmel is now 7-4 for the season.

# No. 4 Monroe Central ousts No. 6 Sheridan in sectional championship

For the No. 6 Sheridan Blackhawks and the No. 4 Monroe Central Golden Bears, it looked to be a sectional championship game that would come down to the wire, at least that's what head coach Bud Wright and his team were hoping would be the case.

Unfortunately, things didn't turn out how Sheridan would have liked on Friday night, as they dropped the Class 1A Sectional 44 championship game to Monroe Central, 26-7.

Monroe Central head coach John Hochstetler made it known to his team following their sectional championship that they had just won a sectional title on hallowed ground and that Sheridan is one of the best program's in the state of Indiana.

"It had to be a team thing, because they are a really good team. We were not going to beat them with individuals tonight," said Hochstetler on his Golden Bears playing a complete team game in their sectional championship game at Sheridan.

The first possession of the game was a quick one for Sheridan and it ended like plenty of other did throughout the season, with a Joe Callahan touchdown, in typical fashion from 38 yards away for an early 7-0 Blackhawk lead.

Monroe Central made quite the impression on the ensuing drive as they would use up just over six minutes of clock in the first quarter before Israel Nash would punch it in from the one-yard line for the first Golden Bears score of the night. The two-point conversion pass attempt failed, leaving Sheridan still up 7-6.

After the Golden Bears put a stop to the Blackhawk offense, they punted the ball right back to Monroe Central.

Casey Conatser and his offense found ways to make things happen and they did it the rest of the night.

Fullback Keegan Kane bowled his way, with the help of his offensive line, into the end zone for a six yard touchdown run. Conatser completed the two-point conversion pass to Seth Wilson to put Monroe Central on top with a 14-7 lead, one they wouldn't give back.

On the first play of the third quarter, Monroe Central continued making a statement. Nash would take an inside handoff and rushed his way 49 yards into Sheridan

territory down to the 24, setting up another pivotal score.

Three plays later, the visiting Golden Bears were faced with a fourth and 18 from the 20 and converted it into a 20-yard touchdown pass to Matt Poole. The two-point pass failed for the second time, but Monroe Central extended its lead to 20-7.

The biggest thing that Monroe Central accomplished as a team on Friday night was bottling up leading rusher Joe Callahan and preventing him from his normal dominance.

"The thing about them is, they're so good up front that it was gonna be tough and our guys battled," Hochstetler said on his team's tremendous effort to keep Callahan's offensive output well below his normal game average.

Showing a little different scheme in the fourth, Wyatt Snyder lined up under center and scored on a four yard bootleg, pretty much sealing the game with 6:43 left in the

game, pushing the score to what would be the final score of 26-7.

For a majority of the night, Sheridan's offense looked completely uncharacteristic compared to normal.

"On offense, we blocked wrong. Play after play, we didn't block here or we didn't block there," Sheridan head coach Bud Wright said on Sheridan's offense playing out of sync for a majority of the night in their sectional title loss to Monroe Central on Friday night.

"The fact is, you can't make mistakes in big ball games and win and that's what we did. That, along with penalties. I think every touchdown drive they had, we had a penalty on it," Coach Wright said on his teams costly penalties leading to each Monroe

Central score.

Midway through the fourth with the Blackhawks driving down the field, the drive fell apart when quarterback Drake Delph tossed an interception to Israel Nash.

From that point forward, the Golden Bears ran the ball, eating up all the clock they could en route to their sectional win.

The Sheridan Blackhawks ended their season at 9-3. Joe Callahan capped off his senior season with 260 carries for 1803 yards and 28 touchdowns to lead Hamilton County, but was held to just 76 yards on 15 carries in his final game.

Monroe Central (11-1) advances to the Regional Championship next week at home against Southwood (11-1), who beat Adams Central on Friday, 50-27.

# Philly ruins Turner's return, rains 3s on Pacers

J.J. Redick and the Philadelphia 76ers made it rain on Friday night in Philadelphia. The Sixers (5-4) made 18 3-pointers — eight by Redick — in a 121-110 win over the Pacers (5-4), spoiling a 31-point night from Victor Oladipo and Myles Turner's return.

Philadelphia extended its winning streak to four games with the victory, snapping Indiana's three-game win streak in the process.

Oladipo scored nine straight points for the Pacers to give the visitors a late lead

before Philadelphia moved back in front on Robert Covington's open three off a loose ball with 2:41 remaining.

Domantas Sabonis answered with a jumper on the other end to tie the game at 110, but Redick knocked down his sixth triple of the night to give Philly the lead for good with 2:06 remaining.

Sabonis was whistled for an illegal screen on the ensuing possession, fouling out in the process. Redick then buried a fallaway 3-pointer as the shot clock expired to give the 76ers a six-point lead with 1:08 to play, then later added one more to put the finishing touches on the Sixers' victory.

"They were just tough down the stretch," Oladipo said after the loss. "J.J. hit a lot of big shots for them, obviously...It just feels like the ball kind of didn't bounce our way as it has been the past couple of games on the road."

The Pacers got good news before tipoff when Pacers center Myles Turner was cleared to return to the court. The 21-year-old rising star had missed the past seven games after sustaining a concussion in a season-opening win over Brooklyn. Pacers head coach McMillan elected to bring Turner off the bench on Friday, a move designed to help monitor Turner's minutes

as he regains his conditioning.

Philadelphia started the game hot, racing out to a 27-19 lead on Redick's 3-pointer with 3:55 remaining in the first quarter. But the Pacers' second unit shut down the Sixers from there, holding the hosts to just a single field goal over the remainder of the quarter as they trimmed the deficit to 30-28.

Turner got it going over that sequence, getting a pair of dunks on back-to-back possessions for his first points of the night.

The Blue & Gold carried over the momentum into the start of the second quarter, opening the frame with a 9-0 run to take the lead. The two teams traded the lead four times over the remainder of the period before Indiana used another 9-0 run in the closing minutes to secure a 63-56 advantage heading into the break.

Philadelphia, however, responded in the third quarter by heating up from beyond the arc. Redick and Covington combined for five 3-pointers during a 25-8 run by the Sixers that turned an eight-point deficit into a nine-point lead.

"That's what (they do)," McMillan said. "We know (they're) very capable of making those shots. You have to find both (Redick) and Covington in transition. They got loose a couple times and made us pay when we lost them."

The Sixers remained in front for an extended stretch, but Oladipo kept Indiana within striking distance. The former Indiana University All-American scored 14 points in the third quarter and knocked down a 3-pointer with 4:40 remaining in the fourth to give the Pacers their first lead in over 15 minutes of game time.

Oladipo finished with a team-high 31 points (23 in the second half) on 12-of-20 shooting to go along with five rebounds and seven assists.

Bojan Bogdanović added 21 points on 8-of-14 shooting, Thaddeus Young had 15 points, and Sabonis contributed 14 points and six rebounds.

Turner finished with 11 points on 4-of-14 shooting, nine rebounds, and three blocks in 24 minutes in his first game back.

Redick scored 31 points while going 8-for-12 from beyond the arc and also dished out six assists. Covington added 22 points for Philadelphia, while Joel Embiid had 18 points, nine rebounds, and five assists.

Sixers rookie guard Ben Simmons registered his second triple-double of his young career in the victory, tallying 14 points, 11 rebounds, and 11 assists.

Indiana concludes a three-game road trip on Sunday evening in New York, where they'll take on the Knicks at 7:30 p.m.


