Heights Bookmobile making reading fun

Hamilton Heights' new bookmobile is bringing books to children and adults in Arcadia, Atlanta, Cicero and Walnut Grove each Wednesday through July 25. The bookmobile evolved from a desire to help encourage students to keep reading over the summer by providing greater access to books.

"The more access our Huskies have to books, the more reading will increase," said Emily Beechler, Hamilton Heights Middle School Media Specialist, who is spearheading this effort. "The bookmobile is also helping to support a summer reading initiative offered through the Hamilton North Public Library. Studies show students can potentially lose 25 percent of their reading level between the end of the school year and the beginning of the next. This is one way we can help encourage reading over the summer."

"We were thrilled by

the first bookmobile night during its stops in Arcadia and Cicero," continued Beechler, who encourages students to read 20 to 30 minutes a day to keep their minds active. "We checked out 96 books during our two stops and that's a lot of books in the community that were not there before Wednesday! Thanks to the generous donation from the Hamilton Heights Educational Foundation we were able to purchase about \$1,000 worth of new books offering a great selection on topics for every age."

Bringing the bookmobile to life was a collaborative effort. The corporation donated the use of an older maintenance bus and fuel. The Hamilton Heights Educational Foundation provided a start-up grant to fund a portion of the books, tables and tents. Erin Goodman, Hamilton Heights Middle School Art Teacher, and members of her Art Club created the promotional

Grand Run in Westfield raises money for Hoosier veterans

IU Health pulls out of contract with HSE Schools health center

On May 31, representatives of Hamilton Southeastern (HSE) Schools sat down with IU Health to discuss the contract with the school district providing the employee health center. According

to the school corporation's Chief Financial Officer, Mike Reuter, "That meeting did not go really well."

IU Health informed HSE Schools that the physicians staffing the school system's employee health centers would be reassigned as of July 2018, and temporary doctors would be assigned to the health center, at a higher cost to HSE Schools.

The school corporation

said there would be a response to that proposal soon once the fee structure was clarified, but soon thereafter, Reuter received a message from IU Health that their contract to provide the HSE Schools Health Center would be canceled, with the closure of the facility set for Sept. 2.

The contract between IU Health and HSE Schools was set to expire at the end of 2018, with Community

Health likely to pick up the health center contract beginning Jan. 1, 2019. The current IU Health contract allows either party to cancel with 90 days' notice.

According to Reuter, IU cited a non-solicitation clause in the pact. Reuter told the school board he did reach out to the IU doctors at the health center in March, telling those phy-

sicians the contract with IU was not being renewed due to any lack of service on their part, in fact, school officials have been very pleased with the service the IU doctors have provided. Reuter told the board he explained to those doctors, "If you want to have a conversation we would be willing to sit down and have that conversation."

Reuter said he didn't offer the doctors any jobs because he doesn't work for Community Health and cannot offer any jobs. IU cited that contact from Reuter to the health care physicians as a violation of the non-solicitation clause of their contract.

"But the reality is, we would've probably canceled (the contract) anyway," Reuter told school board members, "because there would be no reason for them to bring in temporary doctors, we pay them more, and (the health center) would be no different than a Med Check at that point."

School officials have talked to Community Health about providing services between Sept. 2 and Dec. 31 of this year. Community is scheduled to open an employee health center for HSE Schools on Jan. 1, 2019, pending final contract approval. Reuter says moving up the opening of the Community Health Center may not be possible, but administrators are trying to

work out stopgap measures to provide health services from Sept. 2 to the end of the 2018 calendar year.

The new pact with Community Health should be ready by the next school board meeting on June 27, which will include the health center and taking over the nursing program in the school buildings. Nurses would switch from being HSE School District employees to employees of Community Health. That change would happen in the 2019-2020 school year.

Several HSE Schools nurses spoke in opposition of this proposal when it was first discussed at a school board meeting, but no one chose to speak at Wednesday night's session.

School officials say having Community Health take over the nursing program in the school buildings will save the school corporation \$4.6 million over four years.

Also, Methodist Sports Medicine is proposing to continue sports medicine services from July 1, 2018 through June 30, 2019. Methodist would no longer provide strength coaches, requiring the school corporation to provide that service.

"It feels like (IU Health) is thumbing their nose and saying, we're done with you guys," said HSE School Board President Matt Burke. "It's as though IU is saying, we don't want to work with you anymore."

OneZone calls for 'common sense' concerning alcohol laws

Dear Editor:

Life was simple back in 2017 when you could walk into one of two Ricker's convenience stores and order a burrito and beer. Eventually, the state cried, "Foul!" There was discussion about a "loop hole" in the Indiana alcohol laws that Ricker's had walked through.

How can this crisis be solved? The answer from the General Assembly was to form a committee, and the Alcohol Code Revision Commission was born. Former State Senator Beverly Gard, appointed by Senate Pro Tem David Long, was named chair of the commission. Recently Speaker Brian Bosma replaced Gard with former State Representative Bill Davis. We hope that this change in leadership does not also signal a change in momentum for the commission.

The mission of the Alcohol Code Revision Commission is important to the business community. The 17-member commission was tasked with spending two years thoroughly studying Indiana's alcohol laws and subsequently making recommendations for changes during the 2018 and 2019 legislative sessions. Recommendations from the commission last summer resulted in Senate Enrolled Act 1 allowing for Sunday sales of alcohol in Indiana. However, they did not address the sale of cold beer by convenience stores.

According to Speaker Bosma's statement on this change of leadership, "This year, the Legislative Council charged the commission with examining ways to reduce complexity and improve consistency in Indiana's alcohol licensing system, evaluating the current quota structure for providing alcohol licenses, and studying over-consumption



at retail outlets, hours of sale, and the impact on DUI rates, sexual assaults and public safety."

The work of this commission is very important because it is about more than cold beer.

- Package liquor retailers have invested significant dollars to purchase an operating permit. How will their investment be protected if the rules are changed?

- An alcohol distributor can only distribute two of the three categories of alcohol: Wine, beer and hard liquor. One company is not permitted to distribute all three varieties. Does this make sense?

- Local brewers are capped by the state on how much product they can produce. Why?

- Indiana businesses that ship gift baskets are unable to include wine as part of the shipment. However, you can go into the store and make the purchase.

These are just a few of the questions we have. OneZone supports common sense legislation that levels the playing field for businesses in the alcohol industry. The agenda for the Alcohol Code Revision Commission, with Bill Davis as chair, should be open, progressive and move us into the 21st century.

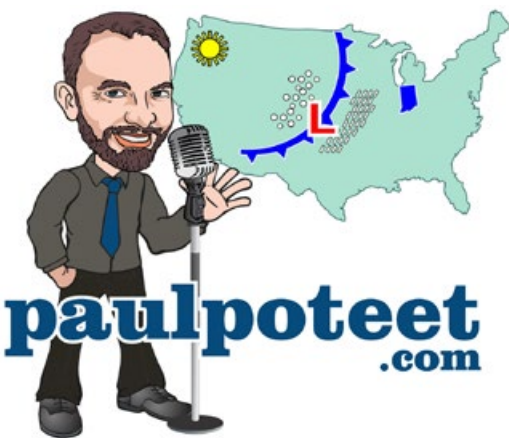

New cards being sent out this month . . .

Medicare card changes could trigger new scams

In June, the Centers for Medicare & Medicaid Services (CMS) began mailing new, more secure cards to Medicare beneficiaries in Indiana. Beneficiaries do not need to do anything to get new cards, and they are being mailed at no cost to the recipient. If you receive Medicare, your benefits will not change with your new card.

The new cards are much more secure to use. The old cards displayed the beneficiary's Social Security number (SSN). Identity thieves frequently use SSNs to steal identities, open credit cards or take out loans in someone else's name. While the new cards do not have SSNs, scammers may use this transition period to try to steal your personal information.

The Indiana Department of Insurance provides the following information for Medicare beneficiaries:

- You do not need to pay for a new Medicare card. If anyone claiming to represent Medicare, the CMS or the government tries to charge you for your card, it is a scam. NEVER give your SSN, bank or credit card information, or send cash to anyone who says it is required to get your Medicare card.
- Do not give your Medicare number to people you do not know or have

not contacted first. Some scammers call pretending to be from the CMS or Medicare. However, these organizations will NEVER require your personal information in exchange for your Medicare card. Only share your Medicare number with your doctors or Medicare personnel that you contacted directly. Do not let strangers help complete applications or forms that include personal information.

- Do not give financial information to people you do not know. If someone asks for bank or credit card information, promising to deposit a rebate or bonus into your account because of your new Medicare card, that is a scam.
- Do not believe anyone who tells you that your Medicare will be canceled unless you give them your Medicare number. If someone asks for your Medicare number and threatens to cancel your health benefits if you do not provide it, hang up. If you receive a suspicious call, contact 1-800-MEDICARE (1-800-633-4227; TTY: 1-877-486-2048).
- Destroy your old Medicare card. Once you receive your new Medicare card, destroy your old Medicare card by shredding or cutting it into pieces, and start using the new one right away.

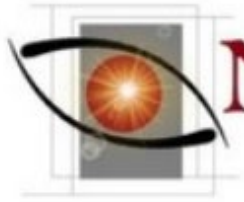

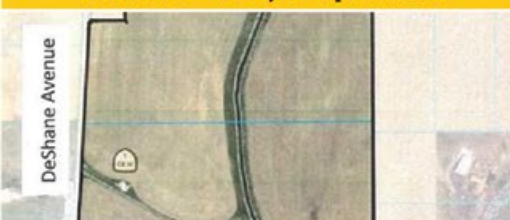

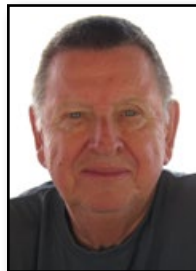

Boys baseball state finals

Tigers play Irish tonight for 4A championship

A popular quote has been used in the Fishers baseball team over the past couple years.

It comes from a man who, in October of 2016, helped a certain Major League Baseball team end one of sports' most (in)famous streaks. The quote: "Don't ever let the pressure exceed the pleasure."

The author of that quote, Chicago Cubs manager Joe Maddon, saw both emotions first-hand as his team finally kicked the "Curse of the Billy Goat" out to pasture and won the World Series. Every high school team playing in this weekend's IHSAA state baseball finals is going through that now, starting with the Tigers, who take on defending state champion Cathedral in tonight's Class 4A championship game at Victory Field. The first pitch is scheduled for 7:37 p.m.

"We were hoping we would be playing Friday night," said Fishers coach Matt Cherry. "The crowds for 4A Games have been huge in the past few years, and we are hoping we reach the attendance record again like they did in 2014 when they broke the attendance record and again in 2016 when they set the current record of 6,799."

"We don't mind the one less day of rest," said Cherry. "We are used to playing four games a week and three games in a row in our conference, so the sooner we can play the better."

Every emotion associated with the state finals will be a new one for Fishers, as this is the first time the Tigers are playing at this level. Cherry and his assistants met with the players on Tuesday before practice to "mentally prepare them for this opportunity and the huge crowd" - the 4A games have traditionally garnered several thousand fans at Victory Field.

At the same time, the Tigers are going to keep doing what they do - "stay loose, embrace the moment," said Cherry. Whenever Fishers does that, it tends to win.

The Tigers will be taking on a Cathedral team that is steeped in tradition. The Irish have appeared in the state championship

game seven times, winning a 3A title in 2001 and 4A titles in 2007 and 2017. Cathedral was the 4A runner-up in 2006, 2010, 2012 and 2013.

All but last year's state finals appearances came under then-coach Rich Andriole, who is now the coach at Guerin

Catholic. In 2017, Ed Freije became Cathedral's coach, and promptly took the Irish to an undefeated season at 29-0.

This season, the Irish come in to state with a 23-8-1 record. Cathedral's April 9 game with West Vigo ended with the score 2-2, thus the tie. In the post-season, the Irish won the Warren Central sectional with victories over the host Warriors 5-4 and New Palestine 5-3.

Cathedral triumphed in the Decatur Central regional by beating Roncalli 6-3 and Terre Haute South 5-0. The Irish needed an extra inning to take the Plainfield semi-state, but did so over Castle 5-1 in eight innings.

Cherry lists simple reasons as to why Cathedral is such a good team: "Jared Poland, tradition, understanding of how to win." Who is Jared Poland? The Irish's senior pitcher, who is 5-3 for the season.

Poland has been very efficient on the mound, with a 1.16 earned-run average. He has 69 strikeouts for the year out of 201 batters faced, putting his strikeout rate at 34 percent. Cathedral has a solid bullpen as well: Junior Derek Haslett is 7-0 with 50 strikeouts, junior Peyton Schofield also has struck out 69 this season, and junior Mitch Bertrand has seven saves.

Poland also leads the way in hitting, with a team-high .386 average. The senior also is first in home runs (eight), triples (11), runs batted in (28), hits (39), and is tied for first in runs scored (27). Senior Mack Murphy also has scored 27 runs. Junior Cole Vassilo leads the doubles list with 11.

"Success breeds success and their players, fans, community have won, are winners, and know how to win," said

Cherry. "They have made the absolute most of opponent's mistakes. We have to focus on us and compete against the game of baseball....take care of the baseball, limit our mistakes...play our game."

Fishers will come in to the championship game with a 28-7 record, including a championship in the Hoosier Crossroads Conference. The Tigers won the tough Noblesville sectional over North Central 4-2 and the host Millers 5-3.

That put Fishers into the Lafayette Jefferson regional, where it edged Zionsville 6-5, then broke away from Fort Wayne Carroll in extra innings, scoring seven runs in the ninth to win 12-5. The Tigers held off Chesterton 5-3 to win the Plymouth semi-state.

Senior Craig Yoho is Fishers' leading hitter, with a .413 average. Yoho is on top of the Tigers' runs scored list with 48 and is tied for first in doubles with 13. Junior Kiel Brenzewski, who averages .375, leads the hit parade with 45. Senior Matt Wolff is batting at a .398 clip.

Senior Alex Jamieson leads Fishers in RBIs (40) and home runs (six) and joins Yoho on top of the doubles list with 13. Senior Grant Richardson and junior JJ Woolwine both have the most triples with two each.

Senior Luke Albright is one of several talented pitchers for the Tigers. He comes into state with an 8-2 record, a 2.98 ERA and 88 strikeouts. Richardson, at 5-0, holds a 2.86 ERA and has struck out 75. Wolff has six saves and has stepped up big time for Fishers as a closer during the Tigers' tournament run.

University takes on Daleville Saturday...

‘Blazers keep relaxed as they prepare for 1A championship game

The University baseball team is one day away from the biggest game in the program's history.

The Trailblazers will take on Daleville for the IHSAA Class 1A state championship; the game is scheduled for 11 a.m. Saturday at Victory Field. It's the first appearance ever for University in the baseball state finals, but the 'Blazers are doing their best to stay cool for this big occasion.

"We have tried to keep everything very, very relaxed," said UHS coach Chris Estep. "A normal work week, in terms of getting prepared for whatever contest. We started turning up the intensity a little bit on Wednesday."

Estep said his team had "a really, really good workout" on Thursday and was looking for another good workout Friday morning. With the game starting early in the morning, the Trailblazer players have been getting out of bed early this week as well.

"They've been sticking around doing some extra work," said Estep. "It's been great. It's been a good week."

And the early start time isn't bothering the 'Blazers one bit.

"The venue's pretty awesome," said Estep. "The time's great. I think that day it's supposed to be 96 degrees, so playing early is probably better than playing later. We're excited about the process of getting ready for this."

University will play a Daleville team that has enjoyed recent success. The Broncos won the 1A state championship two years ago, in 2016.

This year's Daleville team is 21-9 going into state and has cruised through the post-season with little resistance. The Broncos won the Anderson Prep sectional over Cowan 12-0, Liberty Christian 10-2 and

University won its first sectional in five years on May 28, and the Trailblazers have followed that up with a trip to the Class 1A state championship game. University plays Daleville at 11 a.m. Saturday at Victory Field.

Southern Wells 16-0, the Fort Wayne Carroll regional over Rossville 6-3 and Union City 11-1, and the Kokomo semi-state 8-2.

Daleville has two players hitting over .400: Sophomore pitcher Evan Etchison is batting .407, and right behind him is junior Josh Price with a .406 average. Price leads the Broncos in hits with 41, and runs scored with 43.

Senior Ryan Hale tops the Daleville list in three categories: Runs batted in (34), doubles (10) and home runs (five). Hale and Price each have one triple, as does sophomore Jimmy Bowen. The pitcher

Etchison holds a 10-2 record, with a 2.03 earned-run average and 68 strikeouts.

Meanwhile, University hosted its own sectional at RoundTripper Academy. The Trailblazers sailed past Bethesda Christian 7-0 and Indiana Deaf 11-0 to claim its first sectional title since 2013. After that, University triumphed at the Morristown regional over Indianapolis Lutheran 9-4 and Hauser 3-0, then won a dramatic game at the Plainfield semi-state, scoring four runs in the seventh inning to beat Tecumseh 7-4.

The 'Blazers have several big hitters. Freshman Tyler Galyean is batting at a .483 clip, while senior Garrett Hill hits .473, leading UHS in hits (53), runs scored (45),

RBIs (43), doubles (11) and home runs (10). Junior Dawson Estep bats .414 and has the most triples with four.

Senior Cade Carlson has been solid on the mound, with a 7-2 record, 2.47 ERA and 95 strikeouts. Not far behind is junior Brock Moore, who is 7-0 for the year. Moore's ERA is 2.81 and he has tossed 66 strikeouts.

Estep is also quick to credit his assistant coaches for their help this season as well.

"Without Reid Andrews, we would not be in this position that we're in today," said Estep, referring to one of his many assistants. "The assistant coaches have done a fantastic job."
