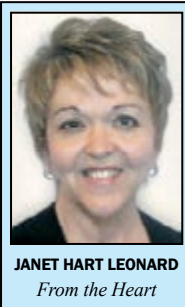
Welcome Home, Grindstone!

I live just four blocks from the corner of 10th and Logan streets. For the past few months I have watched, with great anticipation, the building on the northwest corner

being transformed into the Grindstone Public House.

I know that I tend to exaggerate but I am not, this time, when I say that if you have never had the opportunity to taste a Clancy's Topper, you have missed out on a culinary delight.

It was in May of 1965 when Clancy's opened the doors at 10th and Maple streets. I was just finishing up the fourth grade at First Ward School. Back then we would walk home for lunch and then walk back to school. I would venture to say that a few students

Mayor John Ditslear has announced that Noblesville West Middle School student Ella Whistler and seventh-grade science teacher Jason Seaman will serve as the grand marshals for the 2018 Noblesville Fourth of July Parade.

"On May 25, the Noblesville community was rocked at our foundation. Jason and Ella's words and actions have assisted many dealing with the tragic event. As grand marshals, the community has the opportunity to show our love and support for them and everyone impacted as we continue to cope with the actions of that day," said Ditslear. "The Seaman and Whistler families are humble and private people so we appreciate them accepting this role and leading our Fourth of July celebration."

Seaman recently finished his fourth year teaching at Noblesville Schools. Seaman played football at Southern Illinois University, where he graduated in 2011. He serves as a middle school football coach and has been a track and field coach. The Seaman family are members of Cornerstone Lutheran Church and enjoy being outdoors. He and his wife, Colette, have been married seven years and have two young children.

"It's a great reflection that the community wants Ella and me as grand marshals and that we are both physically able to participate," he said. "Noblesville continues to pull together to show we are one unified community."

"It is an honor to be asked to be grand marshal for the Fourth of July," added Whistler. "It's very thoughtful and I'm

honored to do it with Mr. Seaman."

Whistler, who will be an eighth grade student at NWMS this fall, loves dancing, music, playing volleyball and cheer-leading. She performs in the school's choir and show choir and is active in her church. Whistler also enjoys being outdoors, camping, shopping and furthering her relationship with God.

"Noblesville is our hometown and we've been touched by all the thoughts, prayers and support we've received from our community and across the nation and globe," said Cory Whistler, Ella's father.

The parade also will include Noblesville West Middle School Nurse Megan Schlueter and Noblesville Police Officer Michael Steffen, who serves as the school resource officer, as guests of honor.

"Megan and Officer Steffen played a pivotal role on May 25 and their quick actions saved lives," said Ditslear. "They are unsung heroes so it will be wonderful to have them recognized by the Noblesville community as well."

To end the parade, the Noblesville Fourth of July Planning Committee is inviting all NWMS students, parents, teachers and staff that wish to walk to participate. No registration is necessary. The parking lot between Ivy Tech and the Noblesville Boys & Girls Club (17th Street entrance) will serve as the meeting spot for this group before and after the parade. Participants

"This year's parade will start and end with West Middle School and be a great reminder of the love and support the community has for all those affected," said Ditslear. "Due to anticipated numbers, parents are strongly encouraged to walk with their child or a group of children to provide supervision and help with keeping the group organized. Again, the group will have the same meeting point before and after the parade to help with coordination."

The City of Noblesville is waiving the entry fee to all nonprofits organizations that want to participate.

Democrats rename annual dinner event

Hamilton County Democrats have discarded the names of Jefferson and Jackson for their annual county dinner and rally. This year the event will be called the Triple J Dinner. The name comes from the first name initials of the party's state ticket: Jim Harper, candidate for Secretary of State; John Aguilera, running for state treasurer and Joselyn Whittaker, for auditor.

The three will all be speaking at the dinner July 21 at the Carmel American Legion Post 155. They will oppose Republican incumbents who currently hold the three Statehouse offices.

The name of the dinner party is being changed because party leaders believe political correctness dictates the names of former presidents Thomas Jefferson and Andrew Jackson should no longer be used because both men were slave owners. Next year another more permanent name will be chosen for the event.

Meanwhile, as the deadline arrived for filing Democratic candidates, County Chairman Joe Weingarten reported the names of four township candidates added to the party ticket. The political party has the right to appoint candidates when none filed for an office in the primary election.

David Russ will be running against incumbent Republican Douglas Callahan for Clay Township Trustee. Marie DeMore was named a candidate for Noblesville Township Board, Rachna Greulach will run for the Fall Creek Township Board and Janet Searce is a candidate for the Jackson Township Board.

In countywide races, most Republican candidates will be elected without opposition in November. Democrats are running Jason Straw for sheriff against Republican nominee Dennis Quakenbush, and Rosemary Dunkle for county commissioner against incumbent Christine Altman. Weingarten candidly noted his party has a very tough time getting candidates to run for major office in Hamilton County due to the well-known Republican political tradition.

Sheriff deputy, Cicero officer charged in prank call case

A Hamilton County sheriff's deputy and a Cicero police officer are due in court next month after admitting to investigators that the pair had been drinking during a party on May 1 and making two prank phone calls to the Hamilton County 911 dispatch center.

In an affidavit filed by a Hamilton County sheriff's investigator, Deputy David Needham is alleged to have made the first call when he attempted to disguise his voice to sound like a female, "Jessica,"

who called 911 to report that her boyfriend was stalking her at the time. Needham, sounding like "Jessica," reported that her boyfriend had left the location and fled on foot before ending the call without providing any other information.

Investigators say that Bradley Gorgas, an officer with the Cicero Police Department, made the second prank call at approximately 1:55 a.m., just minutes after Needham's prank call. Gorgas told the 911 dispatcher about a fight involving 10 people at the Speedway gas station in Cicero.

Gorgas said that he was scared and that officers needed to arrive quickly before ending the call. Responding officers found no evidence of a fight at the gas station.

Investigators interviewed both men at different times in the weeks following the calls and each man admitted to having been drinking during a party at Gorgas' house on May 1 and confessed that they were aware that they were making prank phone calls.

Both are due in court for their initial hearings on July 11.

Fishers man dies in SUV-bicycle crash

A Saturday morning crash involving a Buick SUV and a bicycle resulted in the death of a Fishers man.

Robert Lackey, 61, died in the crash. No one else was hurt. The crash happened around 10 a.m. near Brooks School Road and Broadmoor Drive.

Fishers Police say it appears the bicyclist and the Buick were both traveling northbound on Brooks School Road. The driver of the Buick told officers she did not see the bicyclist

in time to avoid the crash. Lackey was taken to Eskenazi Hospital in Indianapolis, but died from injuries

suffered in the crash.

The driver of the SUV, identified as Deborah A. Sundstrom, 59, Indianapo-

lis, is said to be cooperating with authorities.

Fishers Police say this is still an active investigation.

Fishers road construction updates, week of July 2

The REPORTER

141st Street

Beginning July 2, there will be lane restrictions along 141st Street between Allisonville Road and SR37 for resurfacing work. Flaggers will be in place to direct traffic.

Allisonville Road

Allisonville Road construction is in full swing. Traffic has been shifted to the east to allow for widening on the west side. Restrictions may be in place between 8 a.m. and 4 p.m. and flaggers will be on site directing traffic, as necessary. Through September, all southbound left turns from Allisonville Road onto 126th Street will be prohibited.

This will be an active construction site with reduced speed limits. For more info on this project, view the [Fact Sheet](#).

116th Street

Eastbound 116th Street from Allisonville Road to Fishers Pointe Blvd. is reduced to one lane between 9 a.m. and 3 p.m. for resurfacing of the path on the south side of the roadway. Westbound 116th Street from Fishers Pointe Blvd. to Hague Road will be reduced to one lane between 9 a.m. and 3 p.m. for work on the street lights on the north side of the roadway.

There will be temporary lane restrictions on Eller Road south of 106th Street for pavement restoration. Flaggers will be in place to direct traffic.

116th Street & Brooks School Road

There will be lane restrictions on 116th Street and Brooks School Road this week for resurface work on both streets.

131st Street

The intersection of 131st Street and Cumberland Road is currently closed for 45 days to construct a new roundabout. See the [detour map](#).

Expect lane restrictions, weather permitting, along 131st Street between Allisonville Road and Lantern Road for the construction of the Conner Trail from Conner Prairie to the Municipal Complex. Lane restrictions will also take place on Lantern Road between 131st Street and Municipal Drive.

Nickel Plate District

For the Tuesday evening concert on Central Green, Municipal Drive in front of City Hall will be closed for stage construction beginning at noon. Also beginning at noon, North Street and Municipal Drive will become a right turn only, and Fishers Center Drive and Municipal Drive will become a left turn only. Beginning at 5 p.m., there will be road closures on Municipal Drive at 116th Street, on Municipal Drive at Fishers Center Drive (vehicles will still be able to turn left), and on Municipal Drive at North Street (vehicles will still be able to turn right). Roads will reopen at midnight. Street parking on Municipal Drive will be restricted from 2 p.m. until midnight. Guests can access the event from Fishers Center Drive, Municipal Drive (north), and North Street. Parking is available at The Switch garage, accessed from North Street.

ipal Drive will become a right turn only, and Fishers Center Drive and Municipal Drive will become a left turn only. Beginning at 5 p.m., there will be road closures on Municipal Drive at 116th Street, on Municipal Drive at Fishers Center Drive (vehicles will still be able to turn left), and on Municipal Drive at North Street (vehicles will still be able to turn right). I-69 South will be temporarily reduced to two lanes to allow space for the State Road 37 and 116th Street entrance ramps to safely merge while construction continues on the southbound auxiliary lane between the 116th Street and 106th Street ramps.

Attorney General Hill takes part in healthcare fraud investigations

The REPORTER

Attorney General Curtis Hill announced Thursday that his office has participated in a major nationwide enforcement action against

doctors, nurses and other licensed medical professionals for alleged participation in health care fraud schemes. The Office of the Attorney General's Med-

icaid Fraud Control Unit (MFCU) played a key role in 12 criminal investigations that uncovered more than \$200,000 in alleged Medicaid fraud, leading to

charges against 14 individuals. Three of those cases involved individuals in and around Marion County.

These investigations are part of a nationwide initiative led by the U.S. Department of Justice (DOJ) and the U.S. Department of Health and Human Services (HHS). According to these federal agencies, this national effort is the largest ever health care fraud enforcement action.

The Indiana Attorney General's MFCU investigated licensed healthcare professionals and medical offices where suspected illegal activity occurred. Federal agencies involved in one or more of the investigations include the DEA, DOJ, FBI and the Department of Health and Human Services-Office of Inspector General (HHS-OIG).

"Medicaid fraud leaves in its wake many victims," Hill said. "Any licensed providers who commit this offense are taking advantage of those for whom they are supposed to provide care, including the disabled

and less fortunate who rely on Medicaid. In addition, they are also fleecing taxpayers whose hard-earned money is used to fund these programs. The investigators and lawyers in our Medicaid Fraud Control Unit are doing good work to help bring lawbreakers to justice. At the same time, we respect the due process to which all are entitled, and all those who stand accused of crimes are certainly presumed innocent until a court finds otherwise."

Following are summations of three cases in which Indiana's MFCU investigators participated in Marion and Hendricks counties. In each case, the fact that a person has been charged with a crime is merely an accusation, and these persons are presumed innocent until and unless proven guilty.

- In Indianapolis, Aaron Amos allegedly billed the Indiana Medicaid Program for youth mentoring services he did not actually perform. The Marion County Prosecutor's Office

has charged Amos with the felonies forgery, Medicaid fraud and theft.

- In Hendricks County, Licensed Practical Nurse Charolette Moody (aka Charolette Martin) allegedly forged timesheet documents for hours she did not work, which caused false claims to be submitted to the Indiana Medicaid Program. This activity allegedly occurred while she was employed by Maxim Healthcare Services. Moody also allegedly neglected a dependent minor whom she was being paid to provide care. Moody faces felony charges of forgery, neglect of a dependent and Medicaid fraud. [Click here](#) to see the charging documents.

- In Marion County, Dentist Kevin Welch allegedly changed and/or removed records after he became aware that authorities were investigating his billings to the Indiana Medicaid Program. He faces charges of obstruction of justice, a felony. [Click here](#) to see the charging documents.

What was Indiana's first state park?

The REPORTER

1890 – The statue of Thomas A. Hendricks was unveiled in a grand ceremony on the southeast corner of the Indiana Statehouse grounds. Hendricks, who had been Governor of Indiana from 1873-1877, died in 1885 while serving as Vice President of the United States. Indiana Governor Alvin Hovey welcomed thousands to the ceremony, including New York Governor David B. Hill, Missouri Governor David R. Francis and Ohio Governor James E. Campbell.

1916 – McCormick's Creek was dedicated as Indiana's first state park. Governor Samuel Ralston spoke at the Fourth of July ceremony. The park was named for John McCormick, an early settler who had lived along the canyon by the waterfall.

1923 – Famed orator and politician William



Jennings Bryan visited the Gennett Record Company in Richmond. He recorded excerpts of his famous "Cross of Gold" speech, which he had delivered many times around the nation.

1935 – Movie Actress Irene Dunne, who grew up in Madison, was named one of the world's 10 greatest contemporary ladies. Others on the list, compiled by famous columnist Elsa Maxwell, included Alice Roosevelt Longworth, Roberta Brooke Astor and the Marchioness of Carisbrooke.

1947 – Cowboy movie

star Roy Rogers called on Governor Ralph Gates at the Indiana Statehouse. The governor stepped outside to meet the cowboy's famous horse Trigger, who entertained the Chief Executive with a few of the tricks he often performed on the silver screen.

1965 – The Fort Wayne Children's Zoo opened on five and a half acres in Franke Park. Over 6,000 people came on the first day to see the 18 animal exhibits. Today the zoo has more than 1,500 animals, including kangaroos, giraffes, hyenas, zebras and more.

Clay Township Regional Waste District celebrated its 43rd anniversary on June 3. It has grown to serve customers in four townships within three counties. To better reflect this demographic, today the District's name becomes TriCo Regional Sewer Utility.

The District was created in 1975 to provide effective and efficient sanitary sewer service to address a long-standing health problem in Home Place caused by poor soils and failing septic systems. Another benefit of the creation of the District was its ability

to provide the sanitary sewer infrastructure needed for environmentally sound development as Clay and Eagle Townships experienced exponential growth.

The District has grown to provide service in portions of Hamilton, Boone and Marion counties. Due to the regional nature of the sewer service provided by the District, the Board of Trustees petitioned the Indiana Department of Environmental Management to change the District's name. On May 7, IDEM issued the order to change the District's name to TriCo Regional Sewer Utility.

A look at 2018 football schedules...

Franklin Central joins the HCC lineup, major changes for Heights

When the 2018 high school football season begins in mid-August, fans of the Hoosier Crossroads Conference teams will see a new opponent on the schedules.

Franklin Central joins the HCC this fall, making the league an eight-team conference once more. With the addition of the Flashes, a conference that has become one of the tougher leagues in Indiana will get even tougher.

While Franklin Central had several years of struggles, the Flashes have turned things around, compiling an 8-2 record last season and winning the championship in their finale of participating in Conference Indiana.

The addition of Franklin Central means changes for the other HCC schools' schedules, although none of those changes will be dramatic. In fact, the conference lineup for the four Hamilton County football teams

will remain the same as last season.

Fishers will play at the Flashes' field in Week 7, but otherwise the Tigers' schedule stays the same. Fishers had hosted different opponents that week in the past two seasons, welcoming Arsenal Tech in 2014, Cathedral in 2015-16 and Roncalli last year.

Hamilton Southeastern has a trip to Franklin Central scheduled for Week 8. The Royals have a change for the season's first game: Southeastern will open its season at Lucas Oil Stadium, taking on Lawrence Central. The Royals played Kokomo in their opener last year, and Carmel in the previous three years.

Noblesville will play the Flashes in Week 6, replacing Hamilton Heights. The Millers will also be opening their season at Lucas Oil, taking on Cathedral. This ends a four-season series with Lawrence North.

Westfield will finish its season with Franklin Central, hosting the Flashes at Riverview Health Stadium. The Shamrocks will thus end a three-season series with Brebeuf Jesuit. Also ending is a four-season series with Southport in Week 2. This year, Westfield will host Decatur Central that week.

As for the other Hamilton County schools...

Hamilton Heights, has by far the most changes of any school. The only game on its schedule that is the same for the Huskies is its opener: Mount Vernon.

Kokomo is out from Heights' Week 2 slot, replaced with North Montgomery. The Huskies also replaced Noblesville with West Lafayette, and moved that non-conference opening from Week 6 to Week 3. After that, it's all Hoosier Conference East Division games for Heights.

Northwestern moves up a week to Week 4, while Western goes from Week 8 to Week 5. Twin Lakes is pushed up a week to Week 6, and Tipton and Western both move back three weeks to Week 7 and Week 8, respectively. The Huskies will play a team from
