# IU Health celebrates 10 years of keeping Hamilton County healthy

When Alicia Schulhof, president of the IU Health North Suburban Area, addressed the two groups of her hospital associates that had assembled with park staff at Cool Creek Park on Sept. 14, she explained the purpose of the day: "Our Day of Service effort this year really

aligns with our healthy weight and nutrition efforts in addressing the community need."

To advance that key initiative, more than 170 inspired IU Health volunteers, with the help of Hamilton County Parks staff, went to work. In two shifts throughout the unseasonably warm day, they add-

ed four new play elements to the popular Nature Play Area – an innovative outdoor play area the volunteers and park staff created last year in Cool Creek Park. The day's coordinated efforts also included fortifying the brush barrier surrounding the play

# Early voting starts today

In the wake of the controversial Supreme Court confirmation hearings, voting in this year's Nov. 6 general election is now expected to be heavier than in most off-year elections. This may encourage early voting which is now allowed in Indiana.

Early voting starts today at the County Government and Judicial Center in downtown Noblesville. Then, starting on Oct. 24, there will be early voting offered at remote locations in Carmel, Westfield and Fishers.

At the county elections office any registered voter may cast his or her ballot during

# Off-duty Fishers officer injured in weekend crash

Fishers police officers are keeping watch over a fellow officer injured in an off-duty motor vehicle crash over the weekend.

Fishers Police Officer Binh Dennis and his wife, Mary, were injured shortly before noon on Saturday morning when their 2016 Harley Davidson motorcycle left the roadway and struck a tree along State Road 135 in Brown County, Ind. Medical personnel and the Brown County Sheriff's Department responded.

Paramedics transported Mary to an area hospital with non-life-threatening injuries. Binh was air lifted to an Indianapolis Hospital for potential life-threatening injuries. Mary has since been released from the hospital. Binh remains in critical condition and his long-term prognosis is unknown. According to Binh's medical team the next few days are critical as they continue to closely monitor his condition.


Fishers police ask that the community continue to keep Binh and his family in your thoughts and prayers. The outpouring of support has been greatly appreciated.

# Major rework for State Road 32 in Westfield

On Tuesday, the City of Westfield and the Indiana Department of Transportation (INDOT) announced a major reconstruction of State Road 32 in downtown Westfield. The \$15 million project is a 50-50 cost split between the city and the state. The Westfield City Council approved an interlocal agreement paving the way for the collaboration.

"Partnering with the state on this work is a huge win for our city," said Westfield Mayor Andy Cook. "Anyone coming in to Westfield knows that something needs to be done to State Road 32. It simply cannot safely and efficiently handle the traffic of a growing community."

"INDOT's position has always been to work in collaboration with local communities when it comes to the future of the way people and goods move on our state roads," said Todd May, District Deputy Commissioner for the Greenfield District of INDOT, who will be the state's primary point of contact for this project. "Mayor Cook and his team in Westfield are excellent partners. We look forward to working with them in developing the next phase of safe, efficient and effective transportation in this vibrant and growing community."

The State Road 32

project will address congestion and capacity concerns along the SR 32 corridor from Shamrock Boulevard to East Street. The design process will look at all possible alternatives to provide efficient traffic flow through downtown Westfield. As part of the project, the City and INDOT will assess options to determine the best solution for all stakeholders. The Grand Junction Task Group, a volunteer citizens group, included the road improvement as an integral part of its master plan designed over the last 10 years.


"Improving the accessibility to downtown West-

field is the first big step as we build the Grand Junction District-the new heart of the city," said Teresa Skelton, Executive Director of the Downtown Westfield Association. "Public and private sector developments are in the works but getting this commitment from the city and state is critical. This is exciting for our community."


The City and INDOT, in a collaborative Request for Proposals process, selected American Structurepoint for Engineering and Design services. A topographic survey and traffic data collection will begin this fall, followed by roadway design. Construction is expected to begin in late 2022 with a completion date in early 2024.

## DNR launches grassland, pollinator habitat program

Private landowners can benefit from a new grassland and pollinator habitat development program while improving the environment.

The DNR Division of Fish & Wildlife, in partnership with the USDA Natural Resources Conservation Service has officially launched the program, called the “Grasslands for Gamebirds & Songbirds” initiative, or GGS for short.

GGS will provide technical and financial assistance to private landowners hoping to improve their properties by developing grassland and pollinator habitat throughout focal regions of the state. This habitat development will benefit species

such as bobwhite quail, ring-necked pheasant, Henslow’s sparrow and loggerhead shrike.

The Indiana DNR was selected for the funding through the Regional Conservation Partnership Program (RCPP), which is administered by the Natural Resource Conservation Service. The program has a total budget of more than \$2 million. This budget includes multiple funding sources that can provide financial incentives and other benefits to landowners interested in grassland or pollinator habitat development or improvement.

The program is focused in five focal regions across the state. DNR is actively

seeking landowners who are interested in working with biologists to improve grassland habitat on their lands within these focal regions. Financial assistance for creating habitat is available, as is the opportunity to work one-on-one with a DNR biologist to achieve landowner goals.

Notice is hereby given that the Town Council of the Town of Sheridan, Indiana will convene on Monday, October 22, 2018, at 7:00 P.M. at the Sheridan Town Hall, 506 S. Main Street, Sheridan, Indiana 46069, to conduct a public hearing.

The purpose of the hearing is so that users of the Sheridan Municipal Sewage Works Utility ("Sewage Works"), owners of property served or to be served by the Sewage Works, and other interested persons may be heard concerning the proposed changes to the rates and charges for the Sewage Works contained in Sheridan Municipal Code § 50.072 as outlined below:

**§ 50.072 BASE MONTHLY RATE; VOLUMETRIC CHARGE**

(A) The sewage rates and charges shall be based on the quantity of water used on or in the property or premises subject to such rates and charges, as the same is measured by the water meter there in use, plus a base charge based on the size of the water meter installed, except as herein otherwise provided. For the purpose of billing and collecting the charges for sewage service, the water meters shall be read monthly and the users shall be billed each month (or period equaling a month).

(B) The water usage schedule on which the amount of said rates and charges shall be determined is as follows:

(1) All users, treatment rate per 1,000 gallons of usage per month: \$9.14, plus

(2) Monthly base rate as follows:

(C) For users of the sewage works that are unmetered water users or where accurate meter readings are not available, the monthly charge shall be determined by equivalent single family dwelling units, except as herein provided. Sewage service bills shall be rendered once each month (or period equaling a month). The service on which the rates and charges shall be determined are as follows:

Unmetered Monthly Rates Based on Equivalent Single Family Dwelling Unit: \$60.09

(D) For the services rendered to the Town, the Town shall be subject to the same rates and charges herein provided, or to charges and rates established in harmony therewith.

(E) In order to recover the cost of monitoring industrial wastes, the Town shall charge the user not less than the cost thereof. This charge will be reviewed on the same basis as all other rates and charges in this chapter.

ORDINANCE NO. 2018-10  
AN ORDINANCE ESTABLISHING A TOWN COURT

WHEREAS, Indiana law provides for the establishment of a Town Court;

WHEREAS, the Town of Sheridan would benefit from the establishment of a Town Court to hear and dispose of various matters, including ordinance violations, misdemeanors, and infractions;

WHEREAS, it is in the best interests of the residents of the Town to establish a Town Court; and

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Sheridan, Indiana, that:

1. Establishment of a Town Court

There is established, pursuant to Indiana Code § 33-35-1-1, the Town Court of Sheridan, Indiana, which shall come into existence on January 1, 2020.

2. Appointment and Election of Judge: Term and Bond.

a. The Judge of the Town Court shall be elected at the municipal election in November 2019.

b. The term of the judge elected shall be four years beginning at 12:00 noon on January 1, 2020, and continuing until a successor is elected. Before beginning the duties of office, the judge shall take and subscribe to the same oath of office as judges of circuit courts and, in the manner prescribed by Ind. Code § 5-4-1, execute a bond in the penal sum of \$5,000, conditioned upon the faithful performance of the duties of the judge's office with good and sufficient surety. The bond must be approved by the Town Council and filed in the office of the Clerk-Treasurer.

c. The judge must be an attorney in good standing admitted to practice law in the State of Indiana.

3. Powers and Duties of Judge.

a. The judge shall have all powers outlined in Ind. Code § 33-35-21, including adopting rules for conducting the business of the court. The judge has all power incident to a court of record in relation to the attendance of witnesses, the punishment of contempt, the enforcement of its orders, and the issuing of commissions to take depositions in cases pending in the court. The judge may administer oaths and give all necessary certificates for the authentication of the records and proceedings.

b. If the judge is temporarily unable to act, he or she shall appoint a reputable practicing attorney to preside in his or her absence. His special judge shall have all the powers and rights, and shall perform all the duties, of the judge of the court as fully as the regular judge appointing the special judge.

4. Compensation of Judge.

The judge is entitled to receive compensation as prescribed by the Town Council.

5. Court Jurisdiction.

The Town Court shall have exclusive jurisdiction of all violations of the ordinances of the Town. The Town Court shall also have jurisdiction of all misdemeanors, infractions, and all other ordinance violations described in any interlocal agreement.

6. Court Sessions.

The judge shall hold sessions of the Town Court as the business of the court demands, at a place to be provided and designated by the Town Council.

7. Court Seal.

The judge shall provide, at the expense of the Town, a seal for the court that must contain on the face thereof the words: "Town Court of Sheridan, Indiana." A description of the seal, together with an impression of it, shall be affixed to the records of the court.

8. Town Court Officers.

The clerk is an officer of the Town Court. The judge may act as clerk and perform all duties of the clerk of the court or appoint a clerk of the court. If the judge does not act as a clerk of the court or appoint a clerk of the court, the Town Clerk-Treasurer elected under Ind Code § 3-10-6 or Ind. Code § 3-10-7 shall perform the duties of the clerk of the Town Court. The clerk may not receive any fees or compensation other than the clerk's salary.

9. Service of Process.

The town marshal or a deputy marshal shall serve all process issuing from the Town Court.

10. Books, Dockets, Papers, and Printed Blanks.

The judge shall provide, at the expense of the Town, all books, dockets, papers, and printed blanks necessary for the discharge of the duties of the court.

11. Judgments, Orders and Proceedings.

All judgments, decrees, and proceedings of the court have the same force as those of the circuit court. A judgment becomes a lien on real estate when a transcript of the judgment is filed with the clerk of the circuit court.

12. Appeals.

An appeal from a judgment of the court may be taken to the superior, circuit, or probate court of the county within 30 days after the rendition of the judgment and tried de novo.

## Volleyball sectional preview

# Tough matches await those in Sectional 8

Sectional 8 is tough in every sport, and this season's volleyball tournament will be no exception.

In fact, this year the sectional, which is hosted by Westfield, will be a challenge right from the beginning. The first match is between old rivals Hamilton Southeastern and Fishers, both of which are ranked in the top 10 in Class 4A. That contest begins at 6 p.m. Thursday, to be followed by a match between Carmel and Anderson.

The Thursday winners will play the semi-finals on Saturday morning against the two teams that received byes. The host Shamrocks will take on the Royals-Tigers winner, while defending champion Noblesville will play the Greyhounds-Indians winner. The semi-finals start at 11 a.m., with the championship match at 7 p.m.

If one needs proof of how tough the sectional is, take a look at the MaxPreps Class 4A rankings. Four of the teams in Sectional 8 are rated in the top 25: Southeastern is ranked No. 4, Fishers is No. 6, Carmel is No. 11 and Westfield is No. 21.

So, that means the two highest-ranked teams will play each other in the opener. The Royals and the Tigers met back on Sept. 6 for their regular-season match, which Southeastern won in a sweep, 25-17, 25-21, 25-18.

The Royals finished their regular season 25-7 and tied for the Hoosier Crossroads Conference championship with Avon, both teams had 6-1 HCC records. Senior Taylor Shelton has led the HSE attack, with 308 total kills. Junior Grace Hunter is right behind with 286 kills; those are averages of 3.4 per set for Shelton and 2.9 per set for Hunter.

Shelton also leads the way in aces, serving 51 for the season. Sophomore Olivia Phillips has done well setting the ball, dishing out 937 assists, an average of 10 per set.

On defense, sophomore Carly Mills has collected 447 digs. Sophomore Delaney Garner has 69 total blocks (combined solo and assist), with junior Maddie Cole making 46 blocks. Garner also has hit 182 kills on a

hitting percentage of .392.

Fishers will come into the match with a 21-4 record and a third-place finish in the HCC with a 5-2 record. The Tigers are on

an 11-match win streak, with their last loss to Brownsburg in five sets on Sept. 13. Since then, Fishers has only dropped two sets while winning 29; this includes a four-set victory over 4A No. 3 Avon on Sept. 20 and a three-set sweep of 3A No. 3 Brebeuf Jesuit just last Tuesday.

Sophomores Jada Allen and Camryn Haworth are leading the Tiger hitting. Allen has 197 kills, an average of 2.7 per set, on a hitting percentage of .406. Meanwhile, Haworth has put down 185 kills, or 2.6 per set. Camryn Haworth also has served 39 aces, with senior Audrey Haworth hitting 37 aces for the season.

Senior Rose Duffy has handed out 664 assists, an average of 9.2 per set. Defensively, senior Emma Rosenberg has made 260 digs (4.1 per set), while senior Haley Soper has been a force at the net with 77 total blocks (1.2 per set). Allen has 70 blocks, or 1.0 per set.

### CARMEL-ANDERSON

The Greyhounds will come into their first-round sectional match also on an 11-match win streak. Carmel is 23-8 for the season and has not lost since Sept. 8, when it fell to 4A No. 7 Castle in five sets.

The 'Hounds finished play in the Metropolitan Conference with a 6-1 record, behind only Center Grove's undefeated 7-0. The Trojans are ranked fifth in 4A and beat Carmel in four sets on Aug. 28.

Senior Elana Brueggemann has been a powerful hitter for the Greyhounds, averaging 3.4 kills per set. (Complete stats are

unavailable.) Senior Sophie Oliphant is averaging around 4.5 digs per set, while senior Lauren Van Remotel is handing out 5.1 assists per set.

Anderson is 3-20 for the season. The Indians have wins for the season over Marion, Anderson Prep Academy and Edinburg.

### WESTFIELD

The Shamrocks are 19-14 and finished their regular season with a big win at the Lawrence North Wildcat Invitational. Westfield took down Blackhawks Christian, Roncalli, Lawrence North and Muncie Burris to win the event.

The 'Rocks are led on offense by two consistently big hitters. Sophomore Kenzie Daffinee has 334 kills to her credit, an average of 3.3 per set. Senior Kinsey McAfee is next in line with 276 kills, 2.8 per set. Daffinee also leads in service aces with 73 this season.

Sophomore Sarah Weglarz has dished out 823 assists, an 8.5 per set clip. As for the defense, junior Anna Johnsey has 72 total blocks, while senior Bailey Medler has collected 467 digs, 4.9 per set.

### NOBLESVILLE

The Millers finished the regular season 11-22. Junior Lexie Almodovar is far and away the leading hitter with 527 kills, a remarkable 4.8 per set. Senior Kayla Thompson has 53 aces, with Almodovar right behind, totaling 46. Sophomores Bella

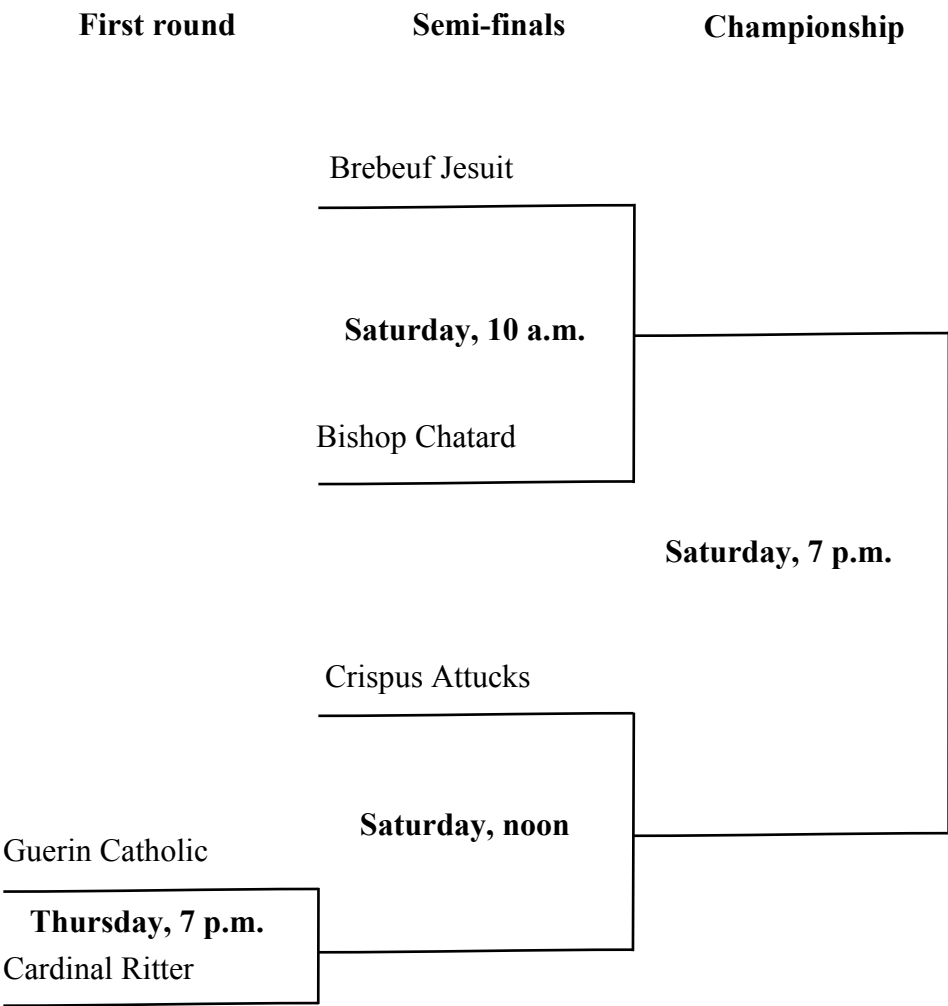

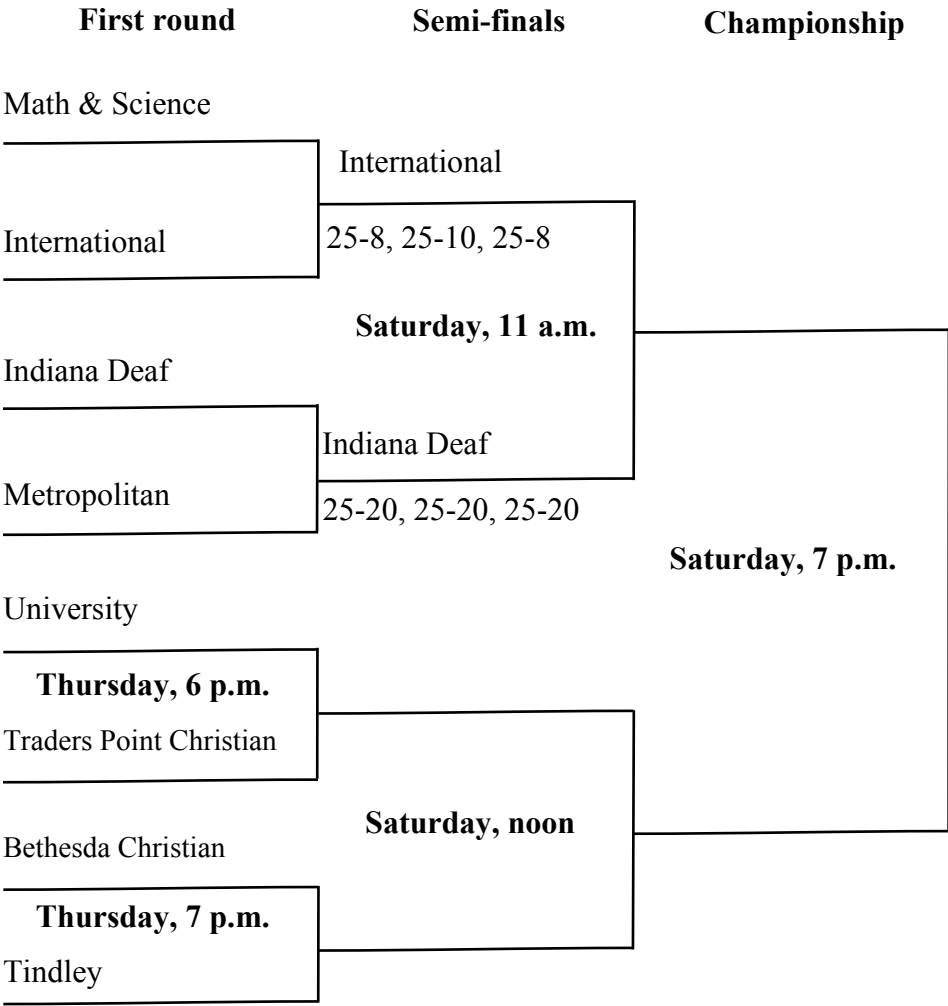
