## Clint Wilson named to HSE School Board

The Hamilton South-eastern (HSE) School Board appointed Clint Wilson Wednesday night to fill the remaining term of Mike Bottorff, through December 31, 2020. Wilson was approved by a vote of 5-0.

Board member Janet Pritchett chose to abstain, saying she has nothing against Wilson, but abstained out of “principle.” After the board meeting, Pritchett chose not elaborate on what she meant by “principle,” but may say more later.

Wilson will be sworn in as a member of the school board at the July 10 meeting. Former Board President Bottorff announced his resignation from the board in late May.

There were 24 applications filed to replace Bottorff, and the board named four finalists that were publicly interviewed June 18. The other three finalists were Travis Brown, Peter Griffin and Jeff Lantzer.

During his public interview, Wilson told board

members he has three children, with two enrolled in HSE Schools. His family moved to Fishers six years ago.

He is an agent with State Farm Insurance.

Wilson’s involvement as a volunteer for the Youth Mentoring Initiative and participation in the Finance Academy motivated him to seek this board seat, he said during the interview session. He has observed many of the challenges students face in school these days.

As an insurance agent, Wilson collaborated with other agents to establish programs bringing potential clients into the office to discuss what is needed in each individual case.

Even with the many positive parents in the HSE Schools, Wilson said students face challenges in dealing with social media. He has found that students learn much differently compared to when Wilson was in school. He says critical thinking is very important for students to learn.

The board seat Wilson assumes will be up for election in November 2020.

## Noblesville Fireworks Festival to offer shuttle rides for July 4<sup>th</sup> event

The Noblesville Fireworks Festival will offer free shuttle routes throughout and after the event to assist guests in getting to its new location in Forest Park from designated off-site parking lots. The Noblesville Fireworks Festival, presented by IDI Composites International, is 4 to 10 p.m. Thursday, July 4. The fireworks show will begin at 10 p.m. from the Forest Park Golf Course.

Only handicap parking will be available on marked spaces along Cicero Road. Proper tags must be displayed to be able to park in this area while spaces are available. Forest Park Aquatic Center and parking will be open for normal business.

“Limiting the parking spaces was necessary for public safety. With so many

activities and people walking around the park and on the road, we need to make sure it is safe for all of our guests and their children,” said Mike Hoffmeister, festival co-chairman.

A map of the trolley routes and park festivities has been created to help guests plan where to park and what attractions they will want to visit during the festival. Shuttle routes will drop-off and pick-up guests at the two ends of the park and include multiple stops in designated parking lots.

**East Route**

Stops include North Elementary, Ivy Tech Community College, First United Methodist Church and Evans Street at 10th Street. The trolley will drop-off guests near the main stage on the north entrance of Forest Park (near

Field Drive).

**South Route**

Stops include River-view Health, the Riverview Overflow Lot and the Hamilton County Government Employee Lot off Conner Street. The trolley will drop-off guests near the Kids Zone on the south entrance of Forest Park (from State Road 19).

“Trolley rides will run continuously throughout the festival. Following the fireworks, Noblesville Schools’ buses will be added to the routes to assist guests leaving the park as quick as possible,” Hoffmeister said.

Those attending the festival should know that Noblesville High School and East Middle School parking lots are currently under construction and parking will

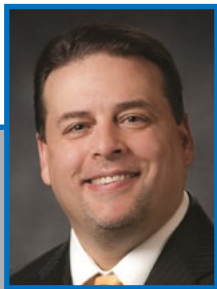

partment garage for individuals with a disability license plate, parking placard, or Police Garage parking pass. [Click here](#) to find more info on parking.

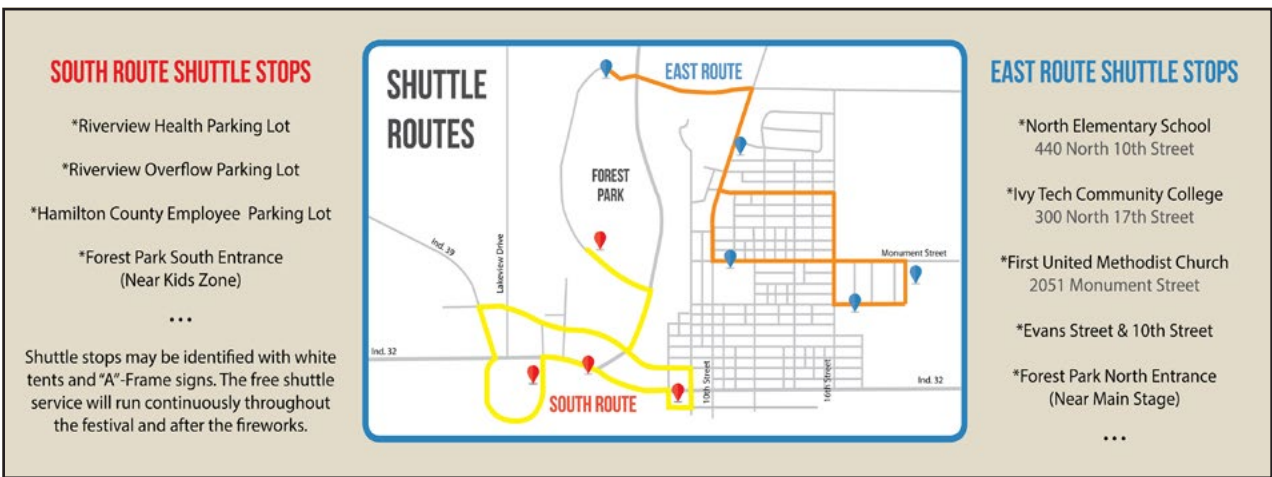

not be available to the public during the Fourth of July festivities. All downtown public lots will be available and free to park in on the holiday.

"We are encouraging guests to utilize the numerous downtown parking lots and on street parking and walk to the festival using the pedestrian bridge across the White River or State Road 19," said Hoffmeister. "Due to their proximity, Federal Hill Commons and

the Moose Lodge will be park and walk lots."

Starting at 4 p.m., State Road 19 will be closed from Field Drive to Logan Street. This was recommended by the Indiana State Police and local law enforcement to provide safe passage of walkers from nearby parking. Vehicles will be detoured around the event site.

Schwartz's Bait and Tackle and U-Haul rental at 118 Cicero Road will be

open for business during the closure. Their parking lot is for customers only and violators may be towed away.

In preparation of the event and to allow vendors, barricades and activities to be setup safely and without obstruction, the city will restrict parking within Forest Park prior to the festival start time. Beginning at noon on July 4, vehicles parked throughout Forest Park, other than the Aquatic Center lot, will be

towed away at the owner's expense.

"We think the minor inconvenience of walking a little further than what we're accustomed to at the high school will be worth it to Noblesville families when they experience all that the expanded festival has to offer in its new location. Although it will be a little more walking, we are providing shuttles to help with the extra distance," Hoffmeister said.

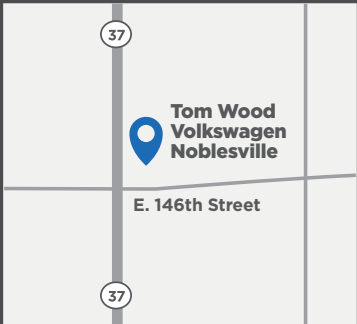

And I'll never forget the pull on my heart that day before Dad put his arm around Mom's shoulders to lead her down the hallway for their drive home. Tears sprang to her eyes and we hugged tightly before saying goodbye.

Of course, I cried a little as well, but I soon got caught up in meeting new people and exploring my home for the next four years. Homesickness didn't last long and I went on to enjoy four of the best years of my life.

As I look back on that

# AG Hill joins federal authorities in national robocalling crackdown

Indiana Attorney General Curtis Hill joined federal authorities on Tuesday at a Chicago press conference announcing a national robo-calling sweep organized by the Federal Trade Commission (FTC). In "Operation Call it Quits," the FTC and its law enforcement partners announced 94 actions targeting operations around the country.

In 2018, Americans lost an estimated \$10.5 billion to phone scams. That same year, Indiana residents reported losing more than \$16 million to such scams. The actual amounts lost are probably much higher because many of the most vulnerable citizens – the elderly – don't report their losses. Often, they're embarrassed or intimidated, or they don't even realize they've been scammed.

"Every year, our office gets more consumer complaints about unwanted robocalls than just about any other issue," Hill said. "At best, these calls represent a nuisance for families just wanting to enjoy peace and privacy without needless disturbances interrupting their routines. At worst, they represent scams that successfully steal people's identities or hard-earned money. In Indiana, we are quite serious about stopping illegal robocalls, and our alliances with such partners

as the FTC are valuable assets in this mission."

Hill was the only state attorney general attending the national press conference in Chicago.

"We're all fed up with the tens of billions of illegal robocalls we get every year," said Andrew Smith, director of the FTC's Bureau of Consumer Protection. "Today's joint effort shows that combating this scourge remains a top priority for law enforcement agencies around the nation."

At the press conference, Hill also discussed his office's recent civil complaint against a Maryland company and two individuals after receiving dozens of consumer complaints.

Anthony and Michael Valenti – doing business as American Health Services – persistently robocalled Hoosiers from Maryland-based phone numbers to pitch various insurance products. All of the calls began with prerecorded messages rather than a live speaker. Of the consumers who complained to the Office of the Attorney General, all but one had telephone numbers registered on the Indiana Do Not Call List. Further, the Valentis had no valid Indiana insurance licenses and had never registered the business with the Indiana Secretary of State.

In the complaint, the Office of the Attorney General alleges that these individuals and their company violated three Indiana statutes. As a result, they now could face up to \$1.17 million in civil penalties, plus fees and costs.

"These are the kinds of actions we must continue to take against violators of laws intended to protect consumers," Hill said. "We will never stem the tide of illegal robocalling until we prove we have the resolve and wherewithal to make offenders pay."

## Cops Cycling for Survivors bike tour sets out on July 8

### The REPORTER

Monday, July 8 marks the start of the 18th annual Cops Cycling for Survivors bicycle ride around Indiana. A departure ceremony is scheduled for 8:30 a.m. at the Law Enforcement and Fire Fighters Memorial on the capital grounds in downtown Indianapolis. The cyclists will depart shortly after comments by Amy Elson, survivor of fallen Indiana State Police Trooper Cory Elson, EOW 4/03/1999.

After the 9 a.m. departure from the memorial, the cyclists will head north to the Boone County Sheriff's Office in Lebanon where they will meet with family, friends and co-workers to honor and remember Deputy Jacob Pickett's ultimate sacrifice for Hoosiers on March 5, 2018. July 8 continues with a ride across Hamilton County to end in Lapel to meet with survivors of DNR Sgt. Edward Bollman, EOW February 13, 2018.

Later in the ride the cyclists will visit the survivors of other Indiana law enforcement officers killed in the line of duty, including 2018 officers Patrolman Robert Pitts, Terre Haute Police Department, EOW May 5, 2018; Officer David Tinsley, Fort Wayne Police Department, EOW September 11, 2018; and Sgt. Benton Bertram, Charlestown Police Department, EOW December 12, 2018; as well as survivors from throughout Indiana's history. The cyclists' journey will last 13 days and cover nearly 1,000 miles bicycling the perimeter of Indiana honoring fallen police officers and their families.

The Cops Cycling for Survivors Foundation, Inc. annual bike ride consists of active and retired police officers, law enforcement survivors, law enforcement family members and friends of law enforcement riding their bicycles around the perimeter of Indiana to raise funds and awareness of the sacrifices made by Hoosier law enforcement families across Indiana. Funds raised from this event are used to perpetuate the memories of officers killed in the line-of-duty and to aid surviving family members and co-workers of officers killed in the line-of-duty. Previously raised funds have been directly donated to foundations, scholarships and camps started in memory of fallen officers or by Indiana survivors in honor of their fallen heroes and to provide immediate financial assistance following a line of duty death.

The ride is scheduled to conclude the afternoon of Saturday, July 20 at Crown Hill Cemetery, Heroes of Public Safety Section. The closing ceremony begins at 2 p.m. Phil Garrison, Paul Garrison and

Lori Garrison Boggs, surviving children of fallen Indiana State Police Trooper Robert Garrison, EOW December 14, 1959 will provide the closing message. All are welcome to attend.

- July 16: Princeton to Huntingburg (Lunch Jasper)
- July 17: Jasper to Jeffersonville (Lunch Marengo)
- July 18: Jeffersonville to Madison (Lunch Madison)
- July 19: Madison to Bloomington (Lunch Brownstown)
- July 20: Bloomington to Indianapolis (Lunch Mooresville)

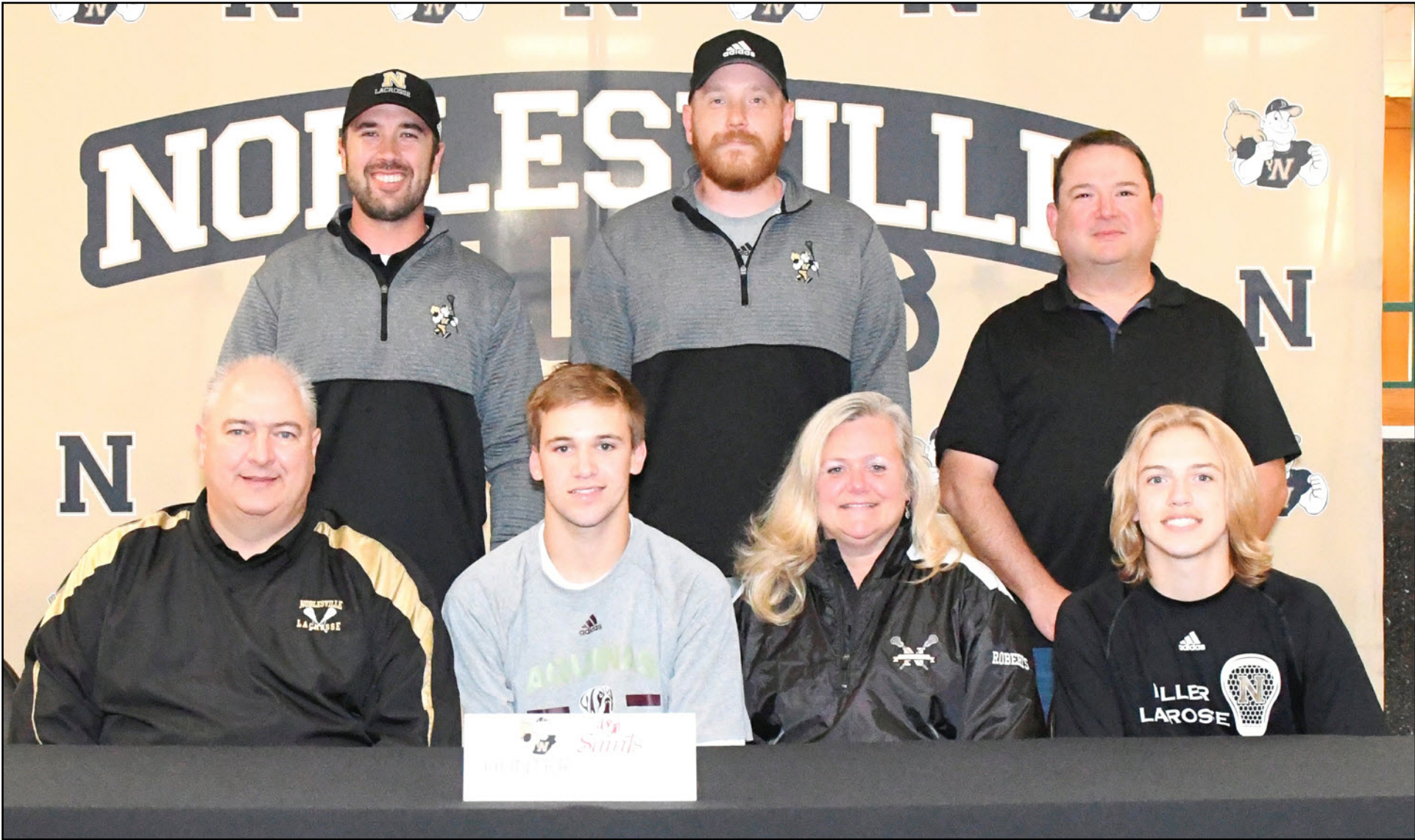
