# McMillan challenging Dillinger's commissioner spot in primary

Nine candidates file for three At-Large county council seats

Filings for the upcoming May Primary Election ended on Friday with a surprise last minute filing by Noblesville resident Charley McMillan for the Hamilton County Commissioner District 2 seat.

District 2 has been represented by the state's longest serving county commissioner, Steve Dillinger. Dillinger was first elected to the position in 1989.

The county's four judges up for re-election will not see an opponent on the Republican ballot.

Circuit Court Judge Paul Felix and Superior Court judges William Hughes, Richard Campbell and David Najjar will be running for new six-year terms.

The three other Superior Court judges, Michael Casati, Jon Brown and Gail Bardach,

are not up for election this year.

The Treasurer position will see a contested race with Kim Good and Susan Byer running.

Byer, a former Treasurer's office employee, has filed suit against the county for allegedly being unjustly fired after making allegations of late property tax payment penalties not being charged to family members of Treasurer's Office employees.

Good, the county's current

Chief Deputy Treasurer, has filed a defamation lawsuit against Byer.

Nine people have so far filed for the county council At-Large position, including one Democrat. Those individuals are: Ralph F. (Rick) McKinney (R), Brandon (Brad) Beaver (R), Sue Maki (R), Jeff Hern (R), Steven R Nation (R), Lyneen Burrow (R), John Ditslear (R), Gardiner P. Bink III (D) and Tony Scott (R).

# Westfield Lions help at-risk veterans

The Westfield Lions Club hosted Robert White, community engagement director for the Hoosier Veterans Assistance Fund of Indiana (HVAF), at the club's program meeting for February.

The mission of HVAF is to house, support and advocate for all veterans and their families in order to help them achieve the best possible quality of life. Founded by three Veterans Administration staffers, the HVAF has a unique partnership with the VA to help and support at-risk American military veterans.

Director Robert White, an Air Force veteran himself, said, "We have around 500 homeless veterans right here in Central Indiana. We have both transitional housing where we provide not only homes, but also substance abuse counseling services, as well as more long-term apartments for our vets."

HVAF's Veteran Services Center at 964 N. Pennsylvania St., Indianapolis, provides food, clothing, furniture, household items and personal hygiene supplies to all vets in need.

HVAF has over 200 beds now, but the need greatly exceeds this capacity. At the meeting, the Westfield Lions donated a huge amount of food and supplies as well as \$1,500 to the organization. Several Lions opened their hearts and wallets with additional donations to HVAF. The Lions also supported HVAF with a donation at the last Lions Poker for Sight tournament this past fall.

# New football stadium coming to Noblesville

Facility expected to open in 2022

Noblesville Schools has announced the construction of a new, larger community stadium for football, band, track and other activities without the use of referendum funds or an increase in the tax rate. The facility will be located off of Field Drive behind Noblesville High School where the district's former Transportation building sits.

The new on-campus stadium will be larger than the existing space, with 50 percent more seating, expanded concessions and restrooms, and on-site parking. It will also be designed to maximize traffic flow and provide a safer environment for appropriately monitoring and managing crowds. Enhanced lighting, locker rooms for home and away teams, up-to-date broadcast technology capabilities, practice fields, athletic training space and additional storage are also included in the plans.

The need for a new multipurpose stadium has existed for some time. Beaver Materials Field at the Dale V. Swanson Sports Complex was built in 1969 when the population of Noblesville

was approximately 7,500 (12 percent of today's approximately 63,000 residents). The 4,200-seat facility is regularly over capacity and many fans are currently forced to stand or be turned away.

"This new stadium has been a long time coming for Noblesville and we're excited to be making it happen," said Dave Mundy, associate superintendent for Noblesville Schools. "We have outstanding support in our community for both athletics and performing arts, and the demand for more space to accommodate our programs has continued to increase as we have grown to be one of

the largest high schools in the state."

The district has studied the issue of a new stadium for several years and new construction was determined to be a more-cost effective option than trying to expand the current facility. Construction will be approximately \$14 million, financed through a bond without the use of referendum dollars or an increase in the tax rate. It's expected to be completed in the spring of 2021 for track and fall of 2022 for football and band.

# Carmel releases updates on Hotel Carmichael costs

The City of Carmel and Pedcor Companies is releasing an update on hotel construction costs and finances, as well as announcing details of a new French restaurant concept planned for the boutique hotel that is under construction at City Center. The Hotel Carmichael is still on scheduled to open in May of this year, in time to welcome the International Making Cities Livable conference, which will make its first appearance ever in Indiana.

The City of Carmel says due to a variety of economic factors, including the national increase in construction costs and local spikes in labor costs and tariffs on materials and goods imported

from abroad, the overall cost of the hotel has increased from the time of the original estimate provided in 2017. The new estimate on construction is \$58.5 million, which includes a new "hard construction" budget of \$41.9 million, \$3 million for the land and \$13.5 million for soft costs.

"The same factors that have led to a building boom across the nation, the state and the City of Carmel itself have unfortunately also led to increases in costs of materials and labor that have impacted the hotel," said Henry Mestetsky, Executive Director of the Carmel Redevelopment Commission. "As we tracked these construction cost increases

reported by various construction-related sources, we anticipated the challenge. Fortunately, the Redevelopment Commission has filled those gaps with additional funding that will have no risk or impact on local taxpayers and be largely reimbursed to the Commission out of the revenues of the Hotel."

A variety of additional financing through existing bond revenue and new mortgages on the James Building and Monon Square secured by the CRC, will allow Pedcor and the City to cover the additional costs with no risk or impact to local residents. This

# Cicero officer awarded for saving child's life

On Jan. 27, Cicero Police Department Captain Grishaw answered a call from dispatch of a report of someone hearing a cry for help around the lake area in Hidden Bay. Grishaw responded to the call and searched the area diligently. After a few minutes, he heard a weak cry for help and began heading toward the sound of the cry. He then found a little boy who had fallen into the icy water of Morse Reservoir. The boy was holding on to the bottom of a dock and told Grishaw that he couldn't hold on much longer. Grishaw radioed dispatch and requested medical assistance, then proceeded to pull the boy from the water. According to the Cicero Police Department, the boy had been five feet deep in 36-degree water for more than 15 minutes. Captain Grishaw was awarded the Department's Live Saving Pin for going above and beyond the call of duty during the rescue.

# New state laws affect property tax deductions, exemptions

Newly-enacted laws have changed some qualifying limitations for Property Taxes Deductions and Exemptions, and as such, Hamilton County Auditor Robin Mills wants the citizens of Hamilton County to know about them and the effects they will have.

“People hear about legislation being passed all the time and may not truly understand the ramifications and what that legislation means for them,” said Mills. “Senate Enrolled Act 280 is one of those. It not only provides changes to qualifying limitations to the Over 65, 65 Circuit Breaker and Disabled Veterans Deductions, it also increased the deduction amount from \$12,480 to \$14,000 for both the Disabled Veteran De-

duction as well as the Over 65 Deduction.”  
Prior to enacting the new law, the Over 65 Deduction assessed value limitation was \$182,430. Under the new law, it is now \$200,000 and the income limitation went from \$25,000 to \$30,000 for single and \$40,000 for married/joint tenants.  
Previously, the Over 65 Circuit Breaker Deduction assessed value limitation was \$160,000 and it is now \$200,000. The income limitation stayed the same at \$30,000 for a single and \$40,000 for married/joint tenants.  
The assessed value limitation for Disabled Vet-

erans (totally or partially disabled over 62), goes from \$175,000 to \$200,000. The deduction amount increases from \$12,480 to \$14,000. SEA 280 also added some qualifying factors for surviving spouses that include:  
The individual:  
• Was killed in action  
• Died while serving on active duty in the US Military or Naval Forces, or  
• Died while performing inactive duty training in the US Military or Naval Forces  
“The Real Property Department will run various reports that will include individuals who already have the deductions in place or

who had these deductions, but were disqualified due to past assessed value limitations,” explained Sadie Eldridge, Lead Real Property Deductions Deputy. “For everyone who qualifies with the increased assessed value, we will automatically apply the benefits. However, we want to encourage everyone to follow up with our office after they receive their tax bill in August to see if they qualify or if they have any questions about the new limitations.”

# Online bullying is a bigger issue than you think

send inappropriate pictures.  
When I asked Sheridan students if they see drama on social media, one student replied with, “All the time, like, ALL THE TIME”.

People are so concerned about plastic, saving animals, and so many other things, but what about bullying and suicide? People say our generation can make a difference, but we can’t if we don’t act on it. Even a small action like sitting with someone who is alone or starting a conversation with a new person will help. We need to report if we see or hear something going on.

Another replied that she sees a lot of middle schoolers being petty more than anything. The college student said: “I definitely see drama on social media and I also think that social media can start drama outside of a screen.”

Out of all six students, five said they have experienced some sort of depression from social media, and two said they have been bullied on it.  
The last question I asked everyone was, what age did you start social media? The answers I received: 13 or 14, a makeup account at 14 and a normal account around 16, 13, fifth grade, 13, and third grade.

Sadly, social media is a huge magnet for bullying that sometimes leads to suicide. Something that makes this worse is that children are getting phones and social media so early on in their lives. I didn’t get my phone until I was 14, and at the time I was so embarrassed. I felt like I was the only one in my grade who didn’t have a phone. Now, looking back, I’m relieved that I avoided a lot of bullying and drama. Once I got my phone, I still didn’t have a lot of social media, and I am thankful that I avoided a lot of drama from it.

I also asked a few of the students how many kids they knew that they felt were just too young to be on social media. One student, who started social media at the age of 13 said: “Yes, there are WAY too many young people on social media. I think I even started a little early.”

One thing I noticed in the answers I received were that the two students who said they started social media in elementary school were also the ones that felt most strongly that there is definitely drama, depression and bullying. Two students said they just block people, and one even said she has deleted the app before to take a break. It turns out, however, that most students said the drama doesn’t really bother them.  
I am very lucky that I have never been bullied to the point of considering suicide. However, there are so many people who don’t only consider it, but act on it and even succeed in it. You can think you’re joking with someone and they take it seriously. I know no one would ever want to find out that they were the reason for someone else’s suicide because they were just “joking” with them.  
We hear the expression “put yourself in someone else’s shoes,” but have we ever really tried that? It’s easier said than done.  
I would just like to end by saying that, even though we’ve all heard it so many times, it is truly so much easier to say something behind a screen than it is to say it to someone’s face. This is the exact reason why cyberbullying is such a big deal.

Statistics show that bullying and suicide have increased recently, especially in the last few years since smartphones and social media have become more popular. According to Business Insider, smartphones were invented in 1992, and according to Small Business Trends, social media was really introduced in 1997. According to American Psychological Association, suicide rates increased 33 percent from 1999 to 2017 and from the 2000s to 2012 went up 24.2 percent.

There are so many studies that show high school students talking about how they have felt more depressed from social media, so I asked some students what their thoughts were. I asked five high school students, one homeschooled and four in Sheridan High School, and then I asked one freshman in college.

I asked the same questions to all the students: Do you see drama on social media? Does it affect you in any way? Have you ever been bullied, felt depressed, or been involved from drama on social media? Do you know what age you started getting social media?

The homeschooler said she doesn’t really see drama on social media and she’s never felt bullied or depressed from it. However, she said she has had people messaging her requesting to

# Fishers Redevelopment Commission elects officers, acts on three projects

Dan Canan will serve as president of the Fishers Redevelopment Commission in 2020, following a vote taken during last week’s meeting. Tony Bonacuse was voted vice president of the commission and Damon Grothe will be secretary.  
The commission approved an amendment to the project agreement approved by the commission last year to the Flexware Innovations AMP West building, under construction near the Nickel Plate Amphitheater.  
Economic Development Director Megan Baumgartner says the original plan

was for an 8,000 square-foot facility, but the project is facing some construction "challenges," and as a result, will increase the building space to about 12,000 square feet to maximize the plans. As part of the amendment approved by commission members, AMP West will be allowed access to some additional parking.  
The closing date has been pushed back to June first of this year, due to these changes.  
An agreement was approved for the developers of the new Nickel Plate Hotel, part of the large project underway along 116th Street near City Hall. The 116-room facility will be part of

the Hilton Tapestry brand.  
After a lengthy series of negotiation sessions with the city, Baumgartner told commission members the city will reimburse \$2.1 million of the construction costs, which are estimated to total \$21 million. The reimbursement will come from the city's Tax Increment Financing (TIF) reserves.  
Included in this agreement is a \$100,000 contingency fund, should there be additional costs in constructing this building next to the Nickel Plate Trail, Baumgartner says. The hotel will have access to the parking garage, and hotel guests will not pay for the

parking privilege. The hotel is projected to be finished at about the same time as the First Internet Bank headquarters.  
In one more action, the commission approved an amendment to the development project to the north of 116th Street downtown, east of the municipal complex. This will postpone the closing date by two months due to delays in the design process. Construction on this part of the plan should begin in about two months, Baumgartner says. The agreement also deals with the projects interface with the Nickel Plate Trail construction, which will be adjacent to the development.

includes a CRC commitment to have more than \$12 million reimbursed out of anticipated hotel revenues.

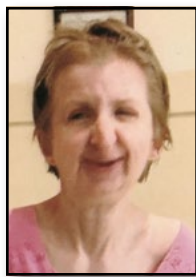

# Rep. Tony Cook co-authors bill to remove Annual School Reports from newspapers

A bill, co-authored by State Rep. Tony Cook (R-Cicero), seeking to remove publication of school districts' Annual Performance Reports from newspapers has been sent to the Senate after passing the Indiana House of Representatives.

The Annual School Performance Report is arguably the most important report produced by school districts. The report includes information such as student enrollment, number of certified teachers, teacher salary ranges, attendance rates, A-F ratings, percentages of students passing standardized tests, and school suspensions including suspensions and expulsions for weapons, drugs and alcohol.

If the bill passes the Senate, school districts will only be required to publish a summary of the report with an explanation on how the report can be found on

the Department of Education's website.

I mentioned Cook co-authored the bill; however, the bill was supported by State Representatives Goodrich, Schai-bley, Huston and

Torr – all repre-sent portions of Hamilton County.

If Cook and the other lawmakers believe placing the report on the DOE's website will provide for more exposure, I'll argue they are wrong.

According to the Hoosier State Press Association (HSPA), 3 million adult Hoosiers read newspapers at least once per week. Also, according to the HSPA, the Department of Education's website, where the performance reports are recorded, only received 14,500 unique page views last year. To put that in perspective, the Hamilton County Reporter's website, which publishes school reports, received

730,664 unique page visits over the last year.

Accessing the report could be troublesome for some internet users.

There are areas of the state that do not have high speed internet, as well as areas without adequate internet service making it difficult to obtain the report.

An older generation of Hoosiers simply do not use the internet and only read print news. This generation of Hoosiers are taxpayers, homeowners and voters, who have spent much of their adult lives engaging in politics and investing in the health of their school districts.

Some low-income Hoosier taxpayers simply can't afford internet service.

If Cook and the other lawmakers believe there is a significant cost savings in not publishing the report in newspapers, I'll again argue they are wrong.

The average cost of a school report published last year in the Reporter was \$600. Many of those

reports were more than a page long. The cost is much less than a business would pay to place the same size ad, and the advertising rate to publish the report is dictated by a state law passed by Indiana lawmakers.

Hamilton County schools are continuously receiving accolades for being some of the best in state. Attracting students to their schools is a competitive process for districts. According to local realtors, people looking to relocate to Hamilton County have used the reports in their decision as to what community they will reside in.

Indiana lawmakers are gradually chipping away at the public's right to know through their attempts to eliminate public notice advertising. Lawmakers that seek to limit the number of people able to access public notice advertising should be held accountable.

Remember 2020 is an election year, and many of our state representatives have opponents on the primary election ballot.

# Shamrocks take care of Zionsville, Royals hold off Greyhounds

In last Tuesday night’s two first-round Sectional 8 games, host Westfield took to the court first, and the Shamrocks defended their home gym with a 54-44 win over Zionsville. In the second game, No. 5-ranked Hamilton Southeastern held off a late surge from No. 10 Carmel to get a 51-44 victory.

**THREE-FOR-ALL**

The Westfield-Zionsville game started as a “three-for-all.” The Eagles used a pair of 3-pointers to take an 10-5 lead with 4:30 left in the first period. Jessica Castor also made a 3 during the early part of the quarter.

But the Shamrocks let loose from beyond the arc in the later part of the period. Alyssa Crockett hit a 3, then Ava Henson drained back-to-back triples, giving Westfield a 14-10 lead. The run continued into the second quarter, with Crockett’s basket putting the ‘Rocks ahead 16-10.

“We did a lot of mental training before and just this whole wee Westfield never trailed again, although Zionsville would remain close for the entire game. The Shamrocks led 27-25 at halftime, but Crockett quickly pushed that lead to 32-25 just a few seconds into the third quarter, making a layin and a 3-pointer.

Westfield coach Ginny Smith said her team had been talking about being mentally tough, “that in this sectional, probably every game’s going to be close,” she said. “We got to be able to take some punches and be able to come back from those. And I felt like to-night we had a really good game plan defensively. I felt like we stuck to the game plan.”

Henson said the team did “a lot of mental training” while preparing for the game. “And I think because of our preparation, that gave us confidence and just to not panic and be calm and play our game, because when we play our game, it doesn’t matter what the other team’s doing. We know that we can come back. They make a shot, that’s over with, we can come back and get the next one. So that’s our mentality. When stuff like that happens, just keep playing and just fix what happens.”

Henson hit a 3 to give the ‘Rocks their largest lead of the game, 35-27, early in the third. Ashtin DeCraene stepped up in the later part of the period, with a triple and two foul shots, making

the free throws with 2:06 left. Neither team scored for the remainder of the quarter, which ended with Westfield up 41-33.

“I think we had a great third quarter, and that’s not been the norm for us this year,” said Smith. “We’ve always struggled somewhat in the third. It was really good to see the kids come out with a level of just grittiness to them. They resolved to not let down. I think it showed in the end.”

The Shamrocks maintained a four- to eight-point lead for most of the fourth period, pulling away in the final minute as the Eagles were forced to foul. Henson made 3 of 4 free throws in the final 18.2 seconds, with Castor and DeCraene both chipping in two.

Henson, a senior, finished the game with 18 points, including three 3s, and led the rebounding with four. Crockett added 16 points and DeCraene scored 10. Olivia Robey helped out with five steals and four assists.

**FIGHT TO THE FINISH**

The Southeastern-Carmel game started in similar fashion to the first contest, with a back-and-forth first quarter. The Greyhounds’ Hannah Lach opened things up with a 3-pointer, then Jackie Maulucci answered with five straight points, a layin and a 3.

Kiara Gill tied the game with a basket, and Bridget Dunn hit a 3-pointer, but HSE’s Lydia Self made a 3 to tie the game again. Lach drained a second triple to put Carmel up 11-8.

Sydney Parrish then scored seven straight points for the Royals, ending the first period with a jumper, then opening the second with a 3 and a layin. Lauren Morris made the run 10-0 with a 3-pointer; that put Southeastern up 18-11 and it would stay in front the rest of the way.

“We knew coming over here that this wasn’t going to be easy,” said HSE coach Chris Huppenthal. “They got some really, really good players and they battled the whole game.”

The Royals led 27-20 at halftime, with Parrish making a 3 to finish the half. Southeastern then took a 42-29 lead late in the third quarter; Parrish added another nine points, with Self and Morris each hitting another 3-pointer.

Carmel made a 9-0 run that bridged the third and fourth quarters. Kate Clarke started it with a triple, then Dunn’s layin was the final

basket of the third period. Clarke opened the fourth with two foul shots, and a putback from Dunn got the ‘Hounds within 42-38.

“We knew they’d make runs,” said Parrish. “We knew it was going to be a game of runs. I give credit to them for making that run. It’s really hard to come back in the fourth quarter and do that. But credit to our team and our defensive end. We were able to get stops, score, stop, score and handle the ball under the pressure and I think that’s what won us the game.”

Parrish ended the run with a layin, then added two free throws to give HSE a 46-38 lead. Lach cut it to 46-40 with a basket. Southeastern began to drain the clock, and ran it down before Self was fouled in a 1-and-1 situation with 1:39 left. She made both foul shots to put the Royals up 48-40, and HSE was able to hang on from there.

“Something that we’ve talked about all year is, you don’t try to win this game in February,” said Huppenthal. “You start preparing for this back in June and July and get your kids ready to play basketball.”

Parrish finished the game with 25 points, including three 3-pointers, and broke the Hamilton County girls scoring record with a second-quarter putback.

“A lot of it’s my teammates,” said Parrish. “You can’t put up that many points without getting the ball from your teammates and setting you up, so big credit to them.”

“It’s good she has the record,” said Huppenthal. “You look at one of the best players ever to come out of this county as well as the state.”

Parrish was named as one of the 10 semi-finalists for the Naismith High School Girls Trophy, presented to the top girls player in the United States.

“What people get to see here and what we’ve got to see for the last four years is special with her,” said Huppenthal. “She’s obviously a great basketball player. She’s a heck of a teammate.”

Self scored eight points; she and Morris both had two 3s. Parrish led the rebounds with eight, while Maulucci collected seven rebounds and handed out five assists. Parrish also blocked two shots.

Dunn scored 15 points for Carmel and pulled nine rebounds, with Clarke adding 10 points. Dunn had two blocks.

“I am just so proud of them,” said Greyhounds coach Erin Trimpe. “They never quit.” She credited her team with fighting back after getting down by 13 points.

“But HSE is just such a good team, so you have to credit the things that they did,” said Trimpe. “But I was really proud of our effort and the way we fought back and the way we kept in it and didn’t quit, ever.”

The Greyhounds finished their season 15-8.

**DEFENSE TAKES OVER**

Noblesville started the second semi-final game strong, leading Southeastern 12-7 after the first quarter. Ashlynn Shade scored nine of those points, including a 3-pointer that gave the Miller a 7-5 lead midway through the period.

But the Royals took control in the second quarter, outscoring Noblesville 16-2. Jackie Maulucci got Southeastern within one after hitting a 3-pointer, then a layin moved HSE ahead 13-12. The Royals would not trail again. Lauren Morris made a 3-pointer, then Makayla Hinshaw scored on back-to-back baskets, following that up with a 3.

Labus led the Guerin Catholic scoring with 13 points, while Cunningham added 10 points, including three 3-pointers. The Golden Eagles finished their season with a 9-15 record.

University's first foray in to Class 2A sectional play came to an abrupt end last Friday night, as the second ranked Trailblazers fell to 14th-ranked Covenant Christian 54-48 at Western Boone.

University struggled to get their offense moving against the battled tested Warriors and fell behind by 13 points entering the fourth quarter. The Trailblazers held Covenant Christian without a fourth quarter field goal and battled back to have a chance to tie the game in the last ten seconds, but a three point attempt was blocked and the Warriors made the last three of their 12 fourth quarter foul shots in the last five seconds to ice the game.

The Blazers were led by their seniors, Maddi Sears and Lindsey Syrek who each had 12 points. Syrek had 10 rebounds and seven blocked shots before fouling out in the closing seconds. Freshman Payton Seay had 10 points, five rebounds and three assists. Kelsey DuBois had nine points and five rebounds.

Trailing 42-29 after the third quarter, University's comeback began with a rebound basket by DuBois and a Syrek field goal. Two Covenant Christian free throws reset the lead at 11 before University scored seven points in less than a minute on field goals by DuBois and Syrek and a three pointer by Sears.

The Blazers hit another offensive lull, not scoring for nearly two minutes while the Warriors added three foul shots. Sierra Hinds scored with 2:45 left then Jordan Patterson stole the ball and made a layin and University was within 47-44 with 2:33 left.

Three more Covenant Christian free throws gave the Warriors a 50-44 lead with 1:36 remaining. After a DuBois steal, Sears hit another three pointer for to cut the lead to 50-47. Covenant Christian added a foul shot with 50 seconds left before Hinds split a pair of foul shots with 38 seconds remaining to bring University within 51-48.

The Blazers defense forced a turnover with 30 seconds remaining. After a timeout with 10.7 seconds remaining, Sears' three point attempt from the right corner was deflected. The Warriors grabbed the rebound and added three more foul shots in the final seconds.

University finishes 22-2 on the season. Covenant Christian beat host Western Boone at Saturday's championship game to win the sectional title.

The Warriors won the game at the foul

line, making 24 of 26 attempts, including 12 of 17 in the fourth quarter. University was 7 of 9 at the charity stripe for the game.

Syrek ends her University career with 1,812 points, good for third all-time among Hamilton County girls. The New Jersey Institute of Technology recruit finishes with 458 blocked shots, fourth best in Indiana history per the Hickory Husker Record Book of Indiana High School Basketball. Syrek finished with 1,161 career rebounds, good for seventh all time in state history. She made 53.6 percent of her field goals over four years, 10th best in state history. Syrek is University's first NCAA Division I basketball recruit and first Indiana Junior All-Star.

University's seniors led the way. Syrek had 21 points and Sears had 13 points and 11 assists. Syrek's final basket of the night gave her 1,800 points in the 100th game of her career, just the third girl in Hamilton County history to reach the milestone. Syrek made 9 of 12 field goals for the game.

Patterson came off the bench to contribute 10 points. DuBois had eight points and eight rebounds, Seay had seven points, seven rebounds and four steals. Sierra Hinds rounded out the scoring for University with six points and chipped in with six rebounds and three steals.

A 19-0 run over a nine-minute stretch of the second and third quarters was the decisive stretch for University. The Blazers led just 18-15 with five minutes left in the first half. University scored the last 11 points of the half to lead 29-15 at the break. Syrek started the run off a pass from Hinds. Patterson hit a three pointer off a Sears assist and Seay had a steal and layin to get the lead to 25-15. DuBois followed with a rebound basket and Syrek scored before the half.

The 8-0 start to the third quarter included a pair of Syrek foul shots, a DuBois basket, a Sears basket and another Patterson bucket after DuBois grabbed an offensive rebound. 13 of University's 31 rebounds came on the offensive glass. The University lead was as high as 25 at 45-20 and the Trailblazers led 47-26 after three periods.

Cascade cut the lead to 16 on three occasions in the fourth quarter, but could not get closer.

Cascade was led by Carley Gibbs with 12 points. The Cadets finish 12-11.
