

People of faith in Fishers gather for Black Lives Matter

It was a religious gathering to work for justice and peace at the Central Green in downtown Fishers. Representatives from various faiths spoke before a crowd of about 60 people. They came together as Christians, Muslims and those of the Jewish faith to declare that Black Lives Matter.

"Justice is what God is all about," Bishop Andrea Williams, the organizer of the Monday evening event, told the crowd. "Righteousness is what God is all about. Without truth there can be no justice, and without justice there can be no truth."

Muzaffar Ahmad, a 20-year resident of Fishers and a Muslim, said as an immigrant to the United States, he can practice his religion freely here. But, as with all other nations on the planet, there are injustices here.

"My humble request to everybody here is, do not let this momentum go away until we make this a better place," Ahmad told those assembled. "Keep coming back to these events, keep writing, keep yelling Black Lives Matter."

The crowd observed 8 minutes and 46 seconds of silence, symbolizing the amount of time a knee was on George Floyd's neck. The crowd then marched from Liberty Plaza down the Central Green, past City Hall to the Amphitheater.

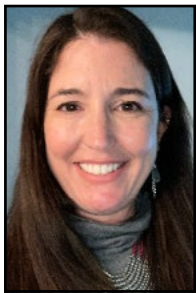
Fishers Mayor Scott Fadness has announced his appointment of Monica Heltz, DNP, MPH, APRN as Public Health Director of the Fishers Health Department. The Fishers Health Department Board approved the hire and appointment of Heltz at its last board meeting.

In her role as Public Health Director, Heltz will lead the development of the Fishers Health Department which was established in April 2020. The full-service health department is completing its transition of duties from the Hamilton County Health Department.

Since April 24, the

Fishers Health Department has, in parallel, launched Hamilton County's first dedicated, free COVID-19 testing center in addition to traditional health department services to support Fishers residents.

Heltz has two decades of public health experience, with experience in environmental health, tuberculosis, immunizations, home visiting, and sexually transmitted infections. Heltz joins the Fishers Health Department from the Marion County Public Health Department where she held

There has been a lot in the news lately, but one consistent fact centers on the novel coronavirus – it is still here and continues to be a threat. Let's review the latest numbers.

In Indiana, as of this Sunday afternoon writing, the COVID-19 death toll stands at 2,121. The death toll in Hamilton County is 94. We still do not know how many of those 94 deaths are Fishers residents. The City of Fishers has promised that number will be released, but has not done so yet.

The numbers we do have for Fishers show 2,406 COVID-19 tests have been conducted, representing just under 2.6 percent of the city's population. 30 of those tests came back positive. Of the 30 positives, five of those residents were asymptomatic.

In the United States, 112,000 deaths have been recorded. Worldwide, the number of fatalities stands at 393,000. As you can see, our nation has 28 percent of the world's COVID-19 deaths. The U.S. has 4.4 percent of the world's population.

Health experts urge anyone who has participated in recent public demonstrations to get tested for novel coronavirus. Residents of Fishers have free testing available. To begin the process of obtaining a free test from the City of Fishers, use [this link](#).

More to CARES Act than stimulus checks

The Coronavirus Aid, Relief, and Economic Relief Act (CARES Act) provides many provisions for individuals above and beyond the well-publicized recovery rebate for individual taxpayers. Here are some of the additional provisions that could be beneficial to you depending on your personal situation:

Charitable Contributions

For tax years beginning in 2020, you can now deduct an additional \$300 in charitable contributions in addition to the standard deduction as a deduction against your income. If you itemize your deductions, there is no limitation on the amount of charitable contributions.

Retirement Plans

The CARES Act makes several changes to retirement accounts. To allow taxpayers access to their funds, the 10 percent additional tax on early distributions is waived for any qualified coronavirus-related distributions from a retirement plan. Eligible individuals who take such distributions can include them in gross income over a three-year span and have three years to repay the amount. The aggregate amount of distributions received by an individual which may be treated as coronavirus-related distributions for any tax year shall not exceed \$100,000.

To qualify as a coronavirus-related distribution, the distribution must be from an eligible retirement plan and be made on or after the date of the enactment of the CARES Act and before Dec. 31, 2020. In addition, it must be made to an individual who is diagnosed with the virus SARS-CoV-2 or with coronavirus disease 2019 (COVID-19) by a test approved by the Centers for Disease Control and Prevention, or whose spouse

or dependent is diagnosed with such virus or disease by such a test, or who experiences adverse financial consequences as a result of the coronavirus. Adverse financial consequences can include consequences from being quarantined; being furloughed or laid off or having work hours reduced due to such virus or disease; being unable to work due to lack of child care due to such virus or disease; closing or reducing hours of a business owned or operated by the individual due to such virus or disease.

In addition, for the 2020 calendar year, the required minimum distribution (RMD) requirements generally applicable to retirement plans are suspended with respect to defined contribution retirement plans, including IRAs. As a result, plan participants and beneficiaries will not be required by law to take RMDs for the year. If the participant dies before minimum distributions have begun, and the entire remaining interest must be distributed within five years of the participant's death, then 2020 will be excluded from the five-year period.

Educational Assistance

Payments made before Jan. 1, 2021, by an employer to either an employee or a lender to be applied toward an employee's student loans can be excluded from the employee's income. The payments can be of principal or interest on any qualified education loan. An employer may pay up to \$5,250 each tax year toward an employee's student loans, and that amount would be excludable from the employee's income. The \$5,250 cap applies to the new benefit for student loan repayment assistance and other educational assistance already provided, such as for tuition, fees and books. Any excess of benefits is subject to income and employment taxes.

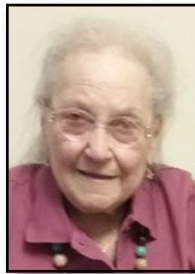

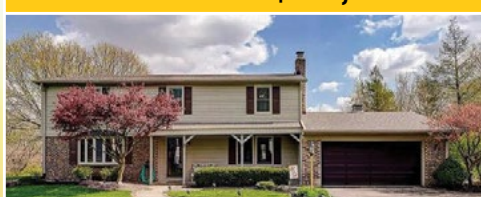

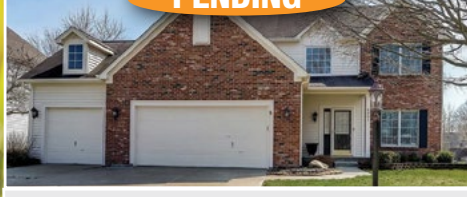

From "Straight Off The Couch" to state . . .

Teams from Carmel, Guerin Catholic, Westfield qualify for Team Finals

ULEN - Indiana's high school boys golfers are getting to play in their state tournament, and it is inspiring some creativity.

On Monday, the 2020 Boys Team State Qualifier took place at several golf courses around Indiana. Three Hamilton County programs – Carmel, Guerin Catholic and Westfield - had players competing at Ulen Country Club in Lebanon.

Since this isn't a school-sponsored event, it allowed the programs to field multiple teams, which GC and Westfield did. Guerin Catholic's teams competed under the name Pebble Brook Junior Golf, while Westfield formed the Rocks Junior Golf Club. As for Carmel? It only had one team, but it probably had the most creative name of the bunch: Straight Off The Couch.

Senior Clay Stirrsman explained the origin of the name.

"Throughout quarantine, you're not playing as much golf as you're used to," said Stirrsman. "I got the text that the guys wanted to play in this event. We tried to qualify when I was on the couch, and I said 'You know what? Why not 'Straight Off The Couch,' because that's kind of how it was."

For coming off the couch, the Carmel team did pretty well. SOTC had the low score of the Ulen qualifier with a 294. Junior Sam Booth led the way with a 68, the lowest individual score of the day. Luke Prall carded a 73 and Stirrsman, serving as the coach of the team, had a 74.

"I think we did well," said Stirrsman. "I think we weren't expecting too much, just come out here and have fun with four of the seniors, and Sam got to tag along. We had a great day and for Sam

to show up and lead the team is great. I think everyone enjoyed it, even though we haven't all been playing too much golf. We all had a good day and we're looking forward to Wednesday and Thursday."

The top three teams at the qualifier advance to the Boys Team Finals, which take place today and Thursday at Purdue University's Ackerman-Allen Course.

Guerin's Pebble Brook Junior Golf Team 1 finished in second place with a team total of 298. Andrew White was Pebble Brook's low man with a 72, followed by Connor McNeely with a 73 and Jacob Modleski with a 74.

Westfield's RJGC Shamrocks earned the third spot with a 312. Drake Biggs led the team with a 74.

The Team Finals begin at 11 a.m. today, with 18 teams competing in the event. The Shamrocks tee off between 11:50 a.m. and 12:30 p.m., with SOTC going off between 2:20 and 3 p.m. Pebble Brook starts between 3:10 and 3:50 p.m.

Several other teams with county players competed at other qualifiers across the state. Carmel sent a second team to Harrison Hills in Attica, Fox Prairie Noblesville and Golf Royals (Hamilton Southeastern) competed at The Players Club in Yorktown, as did two more Pebble Brook teams. RJGC had a team play at Brookwood in Fort Wayne.

Indiana Women's Player of the Year ready to say "I'm back" . . .

Brittany Kelly nears return to Woodland Country Club after ovarian cancer fight

Brittany Kelly is walking down the fairway at Ironwood Golf Club, just a 3 wood away from her parents' backyard, with a completely new perspective on life.

"I want to make sure I'm here for a reason, to help as many people as I can through this journey that I have had to go through," Kelly said.

Kelly, a former prep golf standout at Hamilton Southeastern High School and collegiate star at Ball State University, is a gift to golf and to aspiring young girls everywhere.

Kelly is the PGA assistant golf professional at Woodland Country Club in Carmel — coming off an incredible run of golf herself in 2019.

Quickly, let me rattle off what Kelly just pulled off:

- Indiana Women's Open Champion.
- Indiana Women's Player of the Year.
- Key member of the United States inaugural PGA Cup Championship team.
- Qualified for LPGA Championship at Hazeltine National Golf Club.

Those were just the major achievements.

Behind the scenes during the PGA Cup event this past fall, however, another battle was brewing. Kelly was dealing with a pain that wouldn't go away and after undergoing surgery during the winter to remove a mass half the size of a football, her worst fear was confirmed: cancer.

After an incredible run of golf in 2019, Brittany Kelly faced ovarian cancer this year. She began treatments in February, but her final treatment is scheduled for later this June, and she can't wait to return to her job as assistant golf professional at Woodland Country Club.

"It was Stage 1, Grade 3, clear-cell ovarian cancer," Kelly said. "They decided to start my first treatment at the end of February, six cycles (in total)."

Kelly quickly shared her story and the fight ahead. A battle cry of "BK Strong" spread across the central Indiana golf community via social media.

These days, she can get a few swings in ahead of the home stretch at the hospital. Her final treatment is right around the corner later this June.

"Oh, my gosh, she has been through a ton and she has handled it so well," said Brittany's mother, Joni Kelly. "Much better than I could have ever handled it."

Brittany's father, Ken Kelly, said, "Brittany, all of her life, has been a competitor and a fighter."

A few weeks after her final treatment, Kelly hopes to return to her home away from home, Woodland Country Club. July 1 is her target date to get back to helping members improve their

games and to start tinkering again with her own swing.

During our recent visit together, Kelly's boss at Woodland, Patrick White, put together a pump-up video for her treatment. It is clear, those closest to Brittany Kelly can't wait to hear her yell out a simple phrase — "I'm back."

"That is what I've been waiting for," Kelly said. "I want to get back. I want to see them (Woodland members). I want to be back to normal."

"They're awesome people and Woodland is a special club. I have a great staff, my boss is absolutely amazing."

There is a leaderboard out there of folks who show us how to live. And Brittany Kelly — is right near the top.
