# Looking back 59 years

Time capsule from 1962 found in cornerstone of Noblesville church

Last Tuesday afternoon, a time capsule from 1962 was opened in the cornerstone of the First Church of God located off Field Drive across from Noblesville East Middle School. Community members, including members of the 1962 congregation, gathered to open the time capsule and revisit the history of the church and of Noblesville.

The church was disbanded 12 years ago, and the property was purchased five years ago, initially for storage, and the land will now be used to construct the new Noblesville High School tennis facility.

Noblesville Schools Director of Communications Marnie Cooke told The Reporter she had heard rumors of a time capsule being present in the cornerstone. When it was found and opened on Tuesday, rumor became fact.

Betty Clark, 84, who was a congregant at the church when the time capsule was sealed and was present when it was opened, spoke to The Reporter about seeing some history from her youth.

## In spite of state cuts, county to see no income tax increase

Last Wednesday, the last day of budget hearings drew to a close with neither an increase in Local Income Tax (LIT) rates nor a reduction of the Rainy Day Fund to compensate for the shortfall of tax allocation from the state.

## Heights, Sheridan youth assistance programs receive generous donation

A group of businesses and individuals from Northern Hamilton County recently formed a charitable advocate group known as SHHAG, and the group has announced its first donation of \$65,000 to the Sheridan and Hamilton Heights Youth Assistance Programs.

The funds will be divided equally between the schools that will support the invaluable work of these programs in each district.

Hamilton Heights and Sheridan Youth Assistance Programs provide services year-round. The program is now in its seventh year at Heights and sixth year at Sheridan. It is a tremendous lifeline to services for area families in need.

Youth Assistance Early Intervention Advocates Mary Ann Haymaker (Heights) and Lisa Samuels (Sheridan) are the "go to" individuals for connecting families to resources for food, clothing, financial assistance, mental health counseling, medication management, parenting support and a little bit of everything in between. They are supported by a vast network of compassionate partners, and often work in tandem with other in-school advocates serving schools in Hamilton County.

Hamilton County Youth Assistance Program serves children ages 3 to 17 1/2. Early Intervention advocates coordinate services for the youth and families they serve. The program operates in all six public schools in Hamilton County and takes a holistic approach to coordinate the community's vast array of talents, services, and resources to help youth and empower parents and caregivers.

The Early Intervention Advocates in each community work under the appointment of County Circuit Court Judge Paul Felix and County Superior Court 1 Judge Michael Casati.

## **Carmel Clay Schools start times** change due to bus driver shortage

Last Tuesday's Hamilton County Council budget meeting, one of the topics discussed was various departments' struggles to hire and maintain staff in the current economy. At the local level, Carmel Clay Schools (CCS) is facing the same issue with a shortage of bus drivers.

Also on Tuesday, CCS announced a change to school start times because of a bus driver shortage.

In an email to parents, Carmel Clay Schools Superintendent Michael Beresford says the district is down by 30 to 40 drivers.

That means current drivers will have to handle three to four routes each day, instead of the normal two.



# Help when you need it most

## Hamilton County Trustee Association working to prevent evictions

The CDC eviction moratorium order has been extended through Oct. 3, but not for everyone. It applies only to individual counties experiencing substantial or high COVID-19 positivity rates.

That means the eviction moratorium can and start and stop repeatedly through

Hamilton County rates are on the rise, and the county has recently been in the substantial category, though that is based on the state coronavirus map, which updates weekly. If you need help, the time to seek assistance is now, before eviction proceedings begin, and the Hamilton County Rental Assistance Pro-

**Tolan** gram can help those struggling to pay rent, utilities, or both.

Hamilton County Trustee Association (HCTA) President Danielle Carey Tolan told The Reporter, "People who are not getting help may not even know what is out there for them. It is not just affecting renters; it is affecting landlords, which is a huge economic driver for our community."

According to their website, HCTA is made up of all nine townships in Hamilton County. Their mission is to help families and strengthen the community.

The organization will soon be working with probate courts, judges and magistrates about evictions and how they can help through the Hamilton County Emergency Rental Assistance Program (HCERAP).

"If we aren't all working together, they [the courts] are going to get overrun and people are going to get evicted," Tolan said. "We have been lucky enough that here in Hamilton County we don't have the tent cities or people living under bridges. Most of our homeless are living in their cars or are couch surfing, so we don't see it like we would in downtown Indy or Chicago or Seattle. But if we don't work together to help fix the problem and help these renters that really do need help, it's going to become a big nightmare for everybody in Hamilton

"We have amazing success stories of people getting out of situations they could never imagine getting out of," Tolan said. "Some were truly affected by COVID. One was hospitalized, lost her voice box and now has some mental problems because of all the medications, and we helped her. She's able to stay on her feet, but she got so far behind because of not being able to work for eight months. There are

amazing stories out there.'

This program is not just for people who are either diagnosed currently or have been in the past.

"As long as you can show that COVID affected you financially in one way or another ... You lost your job. You were furloughed. You had to take care of your kids because of schools

closing or their kids got contact-traced with COVID in the classroom or they got trace contacted at work. If you can show anyone in your household was financially affected by COVID and are under 80 percent of the Hamilton County area medium income, you can apply."

HCERAP opened the program March 15. The Hamilton County Commissioners applied for the program through the U.S. Treasury and it is administered by HCTA.

"It makes sense for the HCTA to do it because this is what we do day in and day out," Tolan said. "This is our bailiwick. We saw the need immediately. We have had over 1,300 applicants to date since March 15. We have awarded over \$3.1 million of the \$10 million available."

In 2018, there were 26,000 renters in Hamilton County. While that number has certainly increased, 2018 is the last set of official numbers HCTA had to work with in structuring this program.

"Based on the 2018 numbers we knew we would be able to help approximately 3,000 renters," Tolan said. "Out of that, 14 percent of those renters are house-burdened. They can barely pay their rent and utilities - their basic needs. Fourteen perliving paycheck to paycheck."





# Bitcoin: Investing or speculating?

Many people have decided that bitcoin is the next big thing - and they are backing up their enthusiasm with dollars. Should you, too, consider ting money into bitcoin or other cryptocurrencies?



an essential piece of financial advice: Don't invest in something you don't understand. And bitcoin is not easily understandable. There's no physical bitcoin, nor is it backed by a bank or government. It's a digital currency, used for transactions on a decentralized network of computers. The market's demand for bitcoin largely determines its price, though other factors are also involved

And this price can vary widely. Since bitcoin was introduced in 2009, it has gone through periods of enormous gains and precipitous declines. Its short history has reminded market watchers of the bursting of the "dotcom" bubble in 2000 and the housing market bubble in 2007. These results have raised the following question about purchasing bitcoin: Is it investing or speculating?

There's a big difference between the two. Speculators engage in risky transactions with the hope of profiting from short-term price fluctuations in various financial vehicles. Investors, on the other hand, stick with these practices:

• They follow a longterm strategy. Real investors follow a long-term strategy based on their goals, risk tolerance and time horizon. Generally speaking, longterm investors don't do a lot of buying and selling, saving on fees and potential taxes. But this "buy and hold" approach doesn't mean investors put their portfolios on autopilot. Instead, they review their portfolios at least once a year to make sure their investment mix is still appropriate for their needs.

· They focus on quality. Long-term investors stay away from the flashier – and





## IHSAA releases Fall Bulletin . . .

# Soccer regionals will see changes

County soccer teams that win sectional championships this season will see a change when the regional comes around in

The IHSAA released its Fall Bulletin last Thursday, which details the rules and protocols for each of the organization's sponsored sports, including soccer. While the sectional format is unchanged, the regional round will be different.

Sectional games are scheduled to take place the week of Oct. 4. Class 3A Sectional 8 includes Anderson, Fishers, Hamilton Southeastern, Muncie Central, Noblesville and Pendleton Heights. The girls sectional takes place at Southeastern, while the boys sectional will be contested at Noblesville.

In Sectional 10, the girls list features Arsenal Tech, Carmel, Guerin Catholic, North Central, Pike, Westfield and Zionsville, with the Greyhounds hosting. The boys' list is slightly different: Carmel, North Central, Pike, Shortridge, Westfield and Zionsville. The Shamrocks will be the host

The Hamilton Heights girls will hosts Class 2A Sectional 25, a five-team group that includes Delta, Jay County, New Castle and Yorktown. As for the Class 1A schools. Sheridan and University will travel to Tipton for Sectional 37. Other schools competing are Eastern, Taylor and Tri-Central

Guerin Catholic's boys team will host 2A Sectional 26, with Hamilton Heights also playing there. Other schools in that group are Brebeuf Jesuit, Cardinal Ritter, Covenant Christian, Lebanon and Western Boone. In 1A play, Sheridan will play in Sectional 39 at Taylor, joined by Anderson Prep Academy, Liberty Christian and Tri-Central. University heads to Park Tudor for Sectional 40, along with Heritage Christian, International, Park Tudor and Scecina.

Keep a note of the sectional number for your favorite school, because that is a direct factor as to where the winner plays in the regional semi-final. This year, the semi-finals will be played on a different date than the championship game. The girls will play their semi-finals on Wednesday, Oct. 13, while the boys play on Thursday, Oct. 14.

As usual, there will be four regional championships

Some of the Hamilton crowned in each class, for both boys and girls. This year, however, a team will likely have to play at two different sites in order to win the regional.

In the semi-finals, the winner of an even-numbered sectional will play at a school that wins an odd-numbered sectional. Each semi-final has its own number as well. Here is how that would work for sectionals involving county teams:

Regional semi-final 20: Sectional 40 winner at Sectional 39 winner

Once the regional semi-final games are finished, the winners will go to a pre-determined site on Saturday, Oct. 16 to play for the championship, with both girls and boys playing at the same place. Games are scheduled for 2 p.m. and 4 p.m.

#### **GIRLS GOLF**

As for the other fall sports, the first to have its state tournament will be girls golf.

Hamilton County schools will be split among two courses. Noblesville will host Sectional 13 at Harbour Trees Golf Club, also welcoming Alexandria, Anderson, Elwood, Fishers, Frankton, Hamilton Heights, Hamilton Southeastern, Lapel, Pendleton Heights and Shenandoah.

Guerin Catholic will host Sectional 19, which will be played at Pebble Brook Golf Club. Other schools competing there will be Ben Davis, Brebeuf Jesuit, Cardinal Ritter, Carmel, Covenant Christian, Pike, Speedway and University.

Both sectionals are scheduled to be played this year on Monday, Sept. 20. The top three teams and top three individuals not on an advancing team will qualify for the regional, which is set for Saturday, Sept. 25.

Qualifiers from Harbour Trees will play at Edgewood Golf Club for the Lapel regional championship. Pebble Brook qualifiers travel to Smock Golf Club on the south side of Indianapolis for the Roncalli regional. The top three teams and top five individuals not on an advancing team at each regional qualify for the state tournament.

The state finals will once again take place at Prairie View Golf Club in Carmel. The 36hole, two-day tournament is set for Friday, Oct. 1 and Saturday,

Fishers will host Sectional 45, welcoming Hamilton Heights, Hamilton Southeastern and Noblesville. Carmel's Todd Witsken Tennis Center will be the location of Sectional 53, with Guerin Catholic, University and Westfield also playing

The Carmel sectional champion will play at the Kokomo regional; the winner at Kokomo qualifies for the La Porte semi-state.
