




## Case rates up, death rates down Auto-renewing

Hamilton County's Advisory level back to red due to spike in cases



(Above center) As of Thursday night, the county's positive test rate stood at 27.6 percent. (Above right) Also as of Thursdsay night, a total of 521 deaths were attributed to COVID-19 in Hamilton County, three of which are classified as "new." (Below) The good news, though, is that despite the increase in positive case rates, deaths in Indiana are on the decline over the past several days. 'The LSA (Legislative Services Agency) attorney who drafted the bill gave me this summation of what the legislation does:





He absolutely loved family cookouts and celebrating birthdays – piling everybody into the car, year after year, and heading down to the track to take in everything the Month of May could dish out – or teaching his children, usually through a pick-up basketball game, how to gracefully loose to dad, especially against his trademark left-handed hook shot. Norman was an avid sports fan. In addition to the 500, he followed Notre Dame football and the Indianapolis Colts, and he was a diehard, never-miss-a-game Sheridan Blackhawk fan. When it was game time, his standing order was always a pizza and some of Leon's famous iced tea. No matter who tried to make it, Leon seemed to be the only one who could do it the way he liked it. He enjoyed playing a good round of golf as much as just cruising around in his blue (even though red was his favorite color) 1992 Buick Riviera, which he still drove. Norman was also a supporter of the 2nd Amendment and of the NRA.




