

Town and the citizens of the Town of Sheridan; and WHEREAS, Exhibit A, attached hereto and incorporated herein, represents the 2022 Town of Sheridan Fee Schedule.

NOW, THEREFORE, be it ordained by the Town Council of the Town of Sheridan, Indiana:

Section 1: The 2022 Town of Sheridan Fee Schedule, attached hereto as Exhibit A and incorporated herein, is hereby adopted.

Section 2: Any existing Ordinances, or portions thereof, conflicting with the attached 2022 Town of Sheridan Fee Schedule are hereby repealed. Section 3: Upon codification of the Town of Sheridan Code of Ordinances, the code sections listed on the attached fee schedule shall be amended to delete reference to the specific fee and instead include a reference to the Town of Sheridan Fee Schedule, which may be amended from time to time.

Section 4: The attached 2022 Town of Sheridan Fee Schedule may be amended throughout the year, as determined to be appropriate by the Town, to reflect any changes in the fees referenced therein or to include additional fees currently not isted in the fee schedule.

Section 5: This Ordinance shall be in full force and effect beginning August 1,

If you have ever dropped a technical device like your phone, iPad or laptop, you know the sudden panic you feel when you realize you might have cracked your screen - or worse, caused damage to the functionality of the computer. Noble Geeks are taking the panic out of that moment.





Garrison has Dem opponent; most of GOP unopposed

The surprise filing of a candidate for Hamilton County prosecutor was one of a handful of last-minute Democratic candidates reported to the county elections office Tuesday. The deadline for filing was noon Tuesday.



Jessica D. Paxson,

currently a deputy in the office of Prosecutor Lee Buckingham, was chosen to oppose Republican candidate Greg Garrison, who upset Buckingham in the May primary. years, archaeologists Paxson is a Noblesville resident with several years' experience as a deputy prosecutor.

The candidate has been voting in the Republican primary in recent years but was endorsed by the Democratic leadership. The party has the option of filling their ticket when there was no candidate filed in their party's primary.

There are few other county-level Democratic candidates, so Republicans for judge, sheriff, county clerk, assessor, recorder, coroner, county commissioner and all but one county council member will be re-elected in November without opposition, barring any independent or write-in candidacies. Democrat Nathan Bullock will square off against Republican incumbent Amy Massillamany for County Council District 2.

At the state legislative level, Democrats also announced candidates against Republicans Jerry Torr, Carmel, who represents most of Clay Township, and James Buck, Kokomo, whose district includes portions of Hamilton County.

Josh Lowry, an attorney with offices in Carmel, will oppose Buck in Senate District 21, and Matt McNally, whose website indicates he lives in Westfield, will oppose Torr in House District 39.

The only other candidates fielded by Democrats in the last day for filing were Pam Williams for Adams Township Board and Julia Keller for Clay Township Board.

Republicans are guaranteed eight of nine township trustee positions. In Fall Creek Township, Republican incumbent Doug Allman will face Democratic challenger Nicole Tredup.





ogist every year at least. Remember, and this is quite important, be vigilant about wearing sunscreen, checking your skin, and see your doctor because, thankfully, most skin cancer issues can be resolved early if you follow the recommendations. There is a plethora of "bottle tans" now available on the market, so that may be option for you to explore while in search of a "healthy" tan!

Lastly, I did learn something very surprising from my dermatologist: Most skin cancer issues you may have related to nutriamong adults result from sun exposure at a young age: childhood through early teen years.

Well, for me and others, there is little I can do about that, but I encourage you to make sure that all children in your care or over whom you may have influence are regularly wearing sunscreen and limiting time in the sun. I know – easier said than done, but it is vital to their health and well-being as well as their future. (And, please, do not allow your dogs to "enjoy" the hot summer sun; they cannot perspire as we do, and the hot pavement will burn their sensitive footpads.)

Seekers of sweetness

It is a joyful thrill for me to see a hummingbird. There is something charming about a visit from one of these gentle, delicate, vivid, shy, dainty and miniature birds. Their beautiful swiftness is captivating how they flutter from one flower to the next,



drinking sweet nectar before vanishing to their next destination.

There is an old expression that says, "Time passes as fast as a hummingbird flutters."

My children are one and three years old right now. Everything is so exciting to them. Little things that most adults do not even notice are new experiences for them, and I treasure this so much.

I was outside with my three-year-old and we were looking at our flowers. In my head, I was surveying the damage the bunnies had done to my plants and assessing if I needed to water when she said, "Mommy! I hear the birds singing. So many birds are singing!" She was so excited to proclaim this to me.

I know I will blink and they will both be graduating high school, ready to embark on their next adventure that life has for them; I am sure it will feel like time will have passed as fleeting as a hummingbird landing on my flower.

Hummingbirds are more than beautiful would have to wait for another fixtures in a garden. They are vital pollinators and essential to our wildlife habitats. They are often referred to as "feathered bees" in a garden because of their ability to pollinate I'm telling you I can't make flowers at a staggering rate. The hummingbird drinks nectar while pollinating a plant in a beautiful coexisting relationship between these intriguing birds and our treasured flowers. Many of the same flowers that attract butterflies will also draw hummingbirds.

The more appealing you can make your urday and we fly home tonight. I garden to these darting creatures, the more just got a text saying that ... you pleasure they will offer. Providing a hummingbird feeder is a wonderful addition to any garden. According to audubon.org, one can very easily make hummingbird mixture at home by mixing four parts water to one part refined white sugar, bringing to a boil and letting cool before filling your feeder at home. "Do not substitute honey, which can promote dangerous fungal growth, or use red food coloring, which is not necessary and could also prove harmful to birds."

> I have never once bought commercial hummingbird nectar, and trust me - hummingbirds will flock to your feeder with this homemade recipe. It is very important to change the nectar in your feeder frequently, especially in the summer!

> Hummingbirds are very small in stature and have nests that match their petite size. Their nests are no larger than a ping-pong ball. Hummingbirds are predominantly migratory birds. According to britannica. com, "The architecture of the wing permits hummingbirds to fly not only forward but also straight up and down, sideways, and backward and to hover in front of flowers as they obtain nectar and insects from them." Their rapid speed of pollination makes them a wonderful visitor to frequent your flowers. Hummingbirds are drawn to brightly colored flowers. They like things shaped as a bell that allow their long beaks to drink nectar. If the flower provides a place for them to perch while they drink, they will like it even more!

> Some flowers that I happen to love that will attract hummingbirds include Trumpet Vine, Coral Bells, Salvia, Bee Balm (you cannot have enough of this in your garden, trust me!), Fuchsia, Petunias and if you're looking for a wonderful native plant to add that will attract them, check out Cardinal Flower! Unlike butterflies and bees that are attracted to sun-loving plants and rely on them for nectar, hummingbirds are attracted to both shade-loving and sun-loving plants, which is great for pollination if you have a primarily shaded garden.

> "I always loved those little creatures, always feeling blessed when they appeared nearby. There's a magical quality to them." The words of Leonard Cohen so beautifully capture exactly how I feel when I look up and see one of these tiny winged beauties.

> Children have a way of naturally noticing things and reminding us to stop and notice them, too. I am grateful for the reminder to stop and listen for the birds singing. That same childlike excitement that my daughter felt when she heard the birds singing is still how I feel whenever I see one of those magical little birds.







Bryan Hanan has spent the past six years with the Carmel High School tennis program, helping many young people achieve their goals of winning state championships.

Now, Hanan is heading to Franklin Central, where he will be working toward his goal - teaching at the high school level. And helping the Flashes tennis program along the way.

Hanan stepped down from the Greyhounds teams several days ago to accept a teaching job in the Franklin Central school system. He will also become the Flashes' high school tennis coach.

"This all started out with a teaching move, and I wasn't going to go anywhere without a teaching opportunity," said Hanan.

Hanan will be teaching seventh-grade Project Lead The Way in Franklin Central schools, and he hopes to eventually move up into the high-school teaching ranks.

IHSAA changes rules on post-season golf

The REPORTER

school golf, it's not just tee times, it's team time.

That's the message coming from the IHSAA and the Indiana High School Golf Coaches Association (IHSGCA), and the reason behind a change in the format of the golf post-season, which goes into effect this September for girls golf and in the spring for boys golf. The result will be three more teams qualifying for the state finals.

That change will be accomplished by adding a regional to the post-season. The current format, which has been in use since 2012, has the top three teams in each of the 30 sectionals advance to one of five regionals across the state. Then, each regional advance to the state finals, for a total of 15 qualifying teams.

Beginning this season, there will still be 30 sectionals, but this time the top three teams advance to one of six regionals. The advancement from regionals to state also remains the same: The top three qualify for state, for a total of 18 teams.

The proposal was approved by the IHSAA during the organization's May Executive Committee meeting. Josh Bryant, Westfield's golf coach and past president of the IHSGCA, said the proposal was generated by the IHSAA and its executive board.

"The Coaches Association was involved in committee meetings and supported the framework of the final proposal from the executive board after a few meetings," said Bryant. "The Coaches Association is very thankful the relationship with the IHSAA and their willingness to allow us to have a voice in decision making."

The IHSAA stated the rationale in its published min-

utes of the meeting: "(The When it comes to high IHSGCA's) view is many student-athletes play tournaments throughout the year that are completely individual. While golf is an individual sport, it is the team aspect to golf that sets the IHSAA state tournament apart from everything they compete in."

Bryant expanded on those comments: "The vast majority of coaches feel that school golf is team golf," he said. "It is the only time of year that our players can participate in a team setting and compete for a championship. They are afforded individual opportunities locally, regionally and nationally to compete as individuals." Bryant also said that by adding a regional while keeping the advancement rule the same, "you will see the top three teams from new faces from areas around the state that now have an opportunity to compete."

> The change in the format will also mean a change in how individuals advance. The top three individuals not on an advancing team will move on to the regional level from the sectional; that is unchanged from the previous format.

But in the new format, only the top two individuals on a non-advancing team qualify for state. The reason is mathematics: Under the previous format, 100 players qualified for state, 75 on a team and 25 individuals. Now, the total will be 102 players, 90 on a team and 12 individuals. Since 102 is divisible by three, it will allow for exactly 34 threesomes to will welcome eight other take to the course during the teams to Pebble Brook Golf state finals.

Fall football match-ups revealed

It looks as if 2022 will be the year of conference consistency when it comes to Hamilton County football schedules.

All eight of the county's football-playing schools have their schedules up and ready to go on the venerable John Harrell's Indiana High School Football website. While there are a few changes in the schedules of five of the schools, none of them involve conference opponents.

The four Hoosier Crossroads Conference schools have the same league schedule as last season, as does Hamilton Heights in the Hoosier Conference East Division. Guerin Catholic's schedule in the Circle City Conference is the same, as is Sheridan's in the Hoosier Heartland Conference.

Carmel is no longer playing in the Metropolitan Conference, but it is still playing each of the six remaining MIC teams this season, and at the same spots on the schedule as the previous season. The Greyhounds still have the other former MIC team, Center Grove on their schedule, but their game with the Trojans has been moved up to Week 2 from Week 3.

Center Grove replaces Detroit King, who Carmel played in Week 2 last year. The Greyhounds host another Detroit school, Cass Tech, in Week 3 this season. Carmel opens its season by hosting another out-of-state team, Louisville Trinity.

OUT OF THEIR LEAGUE

Four other county schools have schedule changes, but they all involve non-league games. Hamilton Heights and Westfield have made the most adjustments, replacing two non-conference games during the first two weeks of the season.

The Huskies will play both of their first two games on the road, traveling to Lapel for Week 1 and to North Montgomery for Week 2. Those contests respectively replace Monroe Central and Bluffton.




