No injuries when Carmel-launched hot air balloon comes down on Noblesville power lines

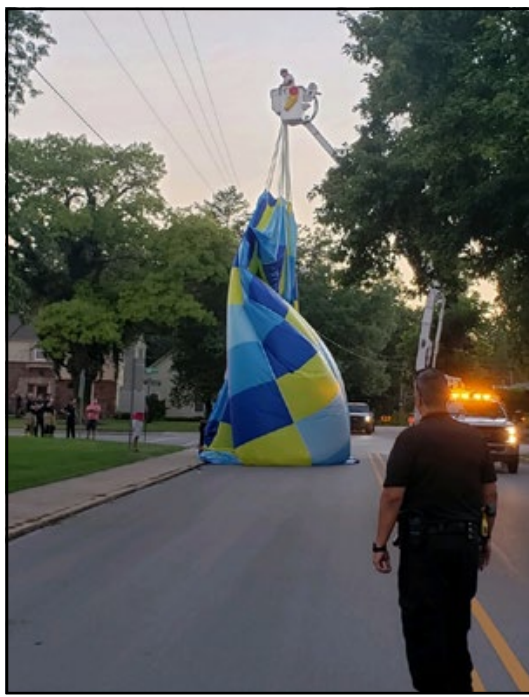
Look! Up in the sky! It's a bird! It's a plane! Meanwhile, down on the ground in some powerlines in Noblesville, it's a hot air balloon.

On Tuesday evening, the Reporter's own Janet Hart Leonard caught some photos of a hot air balloon coming down near 10th and Monument streets in Noblesville. According to Leonard, it looked to her like the balloon was going to attempt a landing at North Elementary School when things went awry. She put on her best Lois Lane face and rushed out to snap photos for Hamilton County's Hometown Newspaper.

According to our news-gathering partners at WISH-TV Channel 8, the balloon had launched near the intersection of East Main Street and Hazel Dell Parkway in Carmel.

Hoosier Weather Daddy and Reporter Owner Paul Poteet tells us Tuesday's high temps topped 85 degrees. The obvious assumption is that hot air and hot air balloons may not be best friends, but The Reporter has learned otherwise.

Indy Hot Air Owner Jack Semlar said atmospheric conditions had nothing to do with this incident. He also told The

Reporter this is the first time a balloon from his company has been involved in an emergency landing.

According to Semlar, one pilot and four passengers were ending a one-hour scenic flight 20 minutes from sunset on Tuesday and were on approach to land at the school. Semlar said they did not see the powerlines until they were already

coming down.

Semlar told The Reporter the pilot pulled a "smart vent" on the balloon to safely deflate it. The balloon instantly deflated and "just draped over the powerlines, causing a spark, but the basket was already down, and no one was in any danger."

Leonard said she saw Indy Hot Air's truck and trailer on the scene within two minutes

of the strange touchdown and that Duke Energy had a bucket truck on sight shortly thereafter to help. Noblesville Police and Fire responded.

According to one Duke spokesperson, "Duke Energy line workers responded Tuesday evening. Minimal customers were affected between the hours

Honoring Officer Noah Shahnnavaz

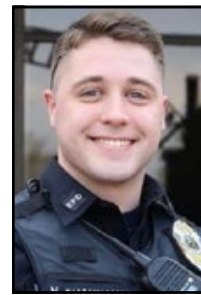
Elwood PD announces service details & procession route

Our old house

There are several old houses in the county.

The R. L. Wilson house is located in the historic district of Noblesville, just south of the square, at 293 S. 8th St. It was constructed circa 1900. Some of the homes on South 10th Street were constructed around that same time.

9th Street was originally known as Catherine Street and the area is known as the South 9th Street Historic District. It is roughly bounded by Maple, Division, 10th, and the west side of 9th Street, with 39 contributing buildings. 197 S. 9th St. was built in 1870. 307 S. 9th was built in 1899. 395 S. 9th was built in 1870. 105 S. 10th St. was built 1864 in the Greek revival style with a low pitch gable roof. 195 S. 10th was built in 1875 and is a two-story Italianate T plan house. A newspaper article reports that it was painted by James Whitcomb Riley before he was famous as a poet.

My wife and I own a home that was built in 1858 according to her family history and in 1860 according to the taxing authorities. A family great-great-grandfather, Daniel Waltz, was reportedly one of the founders

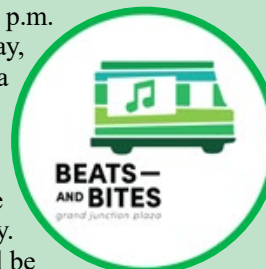

The procession route is as follows:

- ITOWN Church to Brooks School Road
- North (left) on Brooks School Road to Campus Parkway
- East (right) onto Campus Parkway to Interstate 69 North
- East (left) onto Interstate 69 North to State Road 13 (214 Exit)
- North (left) on State Road 13 to County Road 300 S
- West (left) on County Road 300 S to Atlantic Road
- North (right) on Atlantic Road / State Road 13 to State Road 37
- Continue north (right) on State Road 37 to State Road 128
- East (right) onto State Road 128 to County Road 900 West
- North (left) onto County Road 900 West / Anderson Street to South B Street
- Continue on South B Street to 16th Street (Elwood)
- North (left) onto 16th Street to Main Street / State Road 28
- West (left) on Main Street / State Road 28 to U.S. 31 South (Meridian Street)
- South (left) onto U.S. 31 South (Meridian Street) to 34th Street
- West (right) onto 34th Street into Crown Hill Cemetery

The procession will pause in front of the Elwood Police Department, 1505 S. B St., Elwood, for the final 10-42 call. The procession will then continue under a Garrison Flag, which will be located at South 16th and Main Street.

of the town of Arcadia. Early settlers began to move in that area circa 1833. On December 12, 1836, John and Harriet Schaefer purchased 160 acres of land adjacent to the plot owned by Daniel and Matilda Waltz, which was later to become the heart of downtown Arcadia. Daniel's son, not wanting to live in the big city, moved out to the edge of town and built the house where our family still lives.

One Thanksgiving, great-grandpa John Chenoweth remarked to my son Thomas that he had had Thanksgiving dinner in the same room with his great-grandfather. 164 years in the same house. I married into a very stable family. Pastor Tim Brock once told me that he believed he married up. However, he said he was sure that I married outside of my species.


I found a large potato board in the cellar when we took possession. It was native cherry approximately 30 feet long, three feet wide and almost three inches thick. I took it to craftsman Dave Pickett who made a china cabinet for my wife.

The home has nothing new or valuable from a monetary standpoint; just family history and memories. The early part of the house had supporting logs that were only hued on top. The bark is still visible on the bottom. Later supporting beams were squared on all four sides with the ax marks clearly visible. A rock wall basement and large cisterns were features when we acquired the property.

Conner Prairie has the Conner house built circa 1823. When we took the children there, they asked what was so special about that house. It looked just like ours! Sugar glass windows. Faux marble wainscoting. No doorknobs, just thumb latches. Vegetable cellar. Potato board. Hand-dug well. Horse carriage with cinders floor. Barn with rock floor. Large garden. Indeed, the two homes do look alike.

With all the new construction and development in Hamilton County, it is certainly special to live in a home with such a rich history.

AG Rokita announces formation of nationwide bipartisan Anti-Robocall Litigation Task Force

After years of fighting intrusive robocalls, Indiana Attorney General Todd Rokita announced on Tuesday that Indiana is a leader of the nationwide Anti-Robocall Litigation Task Force, which will include 50 attorneys general.

The task force will investigate and take legal action against the telecommunications companies responsible for bringing a majority of foreign robocalls into the country. This bipartisan national task force has one goal: to stop illegal robocalls.

"Robocalls aren't just a Hoosier problem. They are a nationwide problem," Rokita said. "That is why I am proud to lead my fellow attorneys general in the fight against these scammers and robocallers. If the telecom industry won't police itself, this unprecedented task force will."

The new task force, led by the attorneys general of Indiana, Ohio, and North Carolina,

has issued 20 civil investigative demands to 20 gateway providers and other entities that are allegedly responsible for a majority of foreign robocall traffic. Gateway providers that bring foreign traffic into the U.S. telephone network have a responsibility to ensure the traffic is legal, but these providers are not taking sufficient action to stop robocall traffic. In many cases, they appear to be intentionally turning a blind eye in exchange for steady revenue. The task force will focus on the bad actors throughout the telecommunications industry to help reduce robocallers' assault on Hoosiers.

Rokita says he is committed to stopping illegal and unwanted calls. According to the National Consumer Law Center and Electronic Privacy Information Center, over 33 million scam robo-

calls are made to Americans every day. These scam calls include Social Security Administration fraud targeting seniors, Amazon scams targeting consumers, and many other scams harassing all consumers, including the country's most vulnerable citizens. An estimated \$29.8 billion was stolen through scam calls in 2021. Most of this scam robocall traffic originates overseas.

"I am a strong defender of our nation's borders in every aspect," Rokita said. "This philosophy applies to foreign robocallers and scammers who also attack our country through telecommunication and attempt to take advantage of our people's good nature."

The task force is focused on shutting down the providers that profit from this illegal scam traffic and refuse to take steps to otherwise

mitigate these scam calls. The targeted entities are responsible for 60 percent of robocalls.

Rokita offers the following tips to avoid scams and unwanted calls:

- Be wary of callers who specifically ask you to pay by gift card, wire transfer, or cryptocurrency. For example, the Internal Revenue Service does not accept iTunes gift cards.

- Look out for prerecorded calls from imposters posing as government agencies. Typically, the Social Security Administration does not make phone calls to individuals.

- If you suspect fraudulent activity, immediately hang up and do not provide any personal information.

jsha Dicken of Seymour, Indiana here on the Senate floor today for defending himself and others in an act of bravery in the face of danger."

"On July 17, a tragic shooting occurred in my home county at the Greenwood Park Mall, resulting in the deaths of three innocent victims," Sen. Young said. "As we condemn the shooting and continue to grieve the lives lost in this horrific incident, we are thankful for the quick actions taken by Eli Dicken and first responders.

There is no doubt that Eli's bravery and decisive actions saved countless lives."

Noblesville mom aims for world archery title

Hello, I am Mandy Boggs!

My daughter and I travel around the United States doing competitive archery. We practice out of our home archery range right here in Noblesville, Koteewi Archery Range. Together, we compete just about every weekend, so just shooting in my team jersey is one thing, but getting to wear your country's name and colors is something completely unbelievable.

I have been shooting a recurve for over seven years now, but really began taking it seriously in the past four years – and it shows.

Now, after years of hard work and determination, it has become a lifestyle: whether it's shooting for fun, co-running a traditional archery club, coaching the Koteewi Archery youth team, or competing for Team USA wearing red, white and blue.

The World 3D Archery Championships are held every two years at different locations around the world. The last was held in 2019, and it was shortly after that tournament that some of the team approached me and asked if I would consider preparing for the 2021 Championship. I started

working hard and beginning to prepare, but the tournament was postponed due to COVID restrictions.

I continued training and was able to take second place at this year's trials to make Team USA. I am one of only 24 archers: 12 men and 12 women, representing Team USA this Sept. 4 to 10 at the Rinehart World Archery 3D Championships in Terni, Italy. This specific tournament will consist of seven days of shooting with open practice, two qualification days of 48 arrows each day, then a mixed team event with one male and one female from each style

of shooting, quarter finals, semifinals and the actual finals that will be held upon Roman ruins.

Not only will the trip consist of the shooting events, but there will be opening and closing ceremonies, a couple of tourist days to travel the beautiful towns, and even a gala in the ancient streets of the town of Stroncone, Italy.

As I have only three months from trials to the time the plane takes off, I am feeling all kinds of emotions, but I could not be more excited to represent Team USA doing something I love!

Lang files as District 3 candidate for Hamilton Southeastern school board

On July 27, longtime resident and community leader, Dawn Lang, filed for Hamilton Southeastern (HSE) School Board District 3 to strengthen the Fishers community through education by focusing on education excellence, parents' rights in education, curriculum transparency, and fiscal responsibility.

"Our schools are one of the most important institutions that help advance economic prosperity for our citizens and communities," Lang said. "If they fail to prepare our students with the necessary life skills to be successful, independent

citizens – we all lose."

Lang never thought she would run for school board.

"I trusted our schools and administrators to provide 'best in the state' education with rigorous curriculum, not political activism, and ideology. I trusted our schools to challenge my kids to be critical thinkers and excel in math, reading, science, arts, and civics. Somewhere along the way our schools lost their focus," Lang said. "HSE rankings prove there is a direct correlation of our once top 5 school system that has fallen drastically, with the loss of focus from our current administration and board. It's time to get back on track with the core education principles."

Lang says she believes students must successfully graduate from HSE Schools with skills and competencies necessary to be prepared for job opportunities or post-secondary education, and ultimately be ready for employment.

"It's time to set political ideology aside and focus on the state of education in Indiana and our school district and direct energy, time, and financial resources toward those efforts that improve the outcome of our students," Lang said. "Educational attainment is paramount to the well-being of our students and community. We can, and must, do better for our children, our students, and our community."

Lang has lived in Fishers with her husband and three children for over 28 years. Her family has seen Fishers grow from 30,000 to over 95,000 residents during that time, while HSE Schools has taken on similar growth accommodating increases in students, teachers, administrators, and budget.

All three of Lang's children have attended HSE

Schools. Her two oldest graduated in 2017 (Jack) and 2019 (Nicole) and continued their post-secondary education at Purdue Fort Wayne and Rose-Hulman. Lang's youngest child, Christian, attended the same HSE elementary school as his older siblings ... then COVID hit.

"Like many parents and teachers, we endured remote learning the best we could," Lang said, "however, the 10-plus year age span between our older kids gave me a unique lens to see how the administrative policies of our school district have negatively impacted our children and teachers."

For over 25 years, Lang has worked with a variety of companies, from startups to Fortune 500s, in various sectors of education, workforce development, government, life science, healthcare, and IT/technology. As a public servant and community leader, Lang is actively involved with organizations such as Rotary (member of Fishers Club), Commissioner with the City of Fishers Advisory Plan Commission, Fishers Housing Task Force, Precinct Vice Committeeman, elected Republican State Convention Delegate (2022), and Civic Leadership Engagement Roadmap Program with The Policy Circle. Lang is a member and serves many leadership groups, including the Richard Lugar Excellence in Public Service Leadership Series (2021-2022 class alumni), Hamilton County Federation of Republican Women and Indiana Federation of Republican Women, Women & Hi Tech, and Executive Advisory Board member for the Indiana Chapter of the Healthcare Businesswomen's Association.

Sens. Braun & Young introduce legislation to recognize American Discovery Trail

The REPORTER

U.S. Senators Todd Young (R-Ind.), Chris Coons (D-Del.), and Mike Braun (R-Ind.) introduced bipartisan legislation this week to increase national recognition to the American Discovery Trail – the nation's only coast-to-coast, non-motorized recreational trail.

The National Discovery Trails Act would make the American Discovery Trail part of the National Trails System, which will bring greater visibility to the trail and boost tourism in local communities across 15 states and the District of Columbia. The House companion is led by Rep. Mark DeSaulnier (D-Calif.-11) and is cosponsored by 64 members, including Indiana delegation members Reps. Trey Hollingsworth (R-Ind.-09) and Greg Pence (R-Ind.-06).

"Volunteers are a driving force for conservation and play a vital role in preserving and restoring our land," Sen. Braun said. "I'm proud to introduce legislation with Sen. Coons and Sen. Young to create the first coast-to-coast trail and empower volunteer groups to designate and maintain trails of regional significance in the Hoosier State and across the country!"

"The Hoosier state is fortunate enough to have two routes of the American Discovery Trail (ADT) to provide hikers and bicyclists a great outdoor adventure through both northern and southern Indiana," Sen. Young said. "I'm glad to join my colleagues to recognize the importance of this trail which connects small towns, cities, and historical sites at no cost to the taxpayer."

The 1968 National Trails System Act created a framework for a national network of connected scenic, historic, and recreational trails. Today, the National Trails System includes eight National Scenic Trails, 15 National Historic Trails, and more than 1000 National Recreational Trails. However, it does not include any trail linking the network from coast to coast.

The National Discovery Trails Act would create a new category within the National Trails System for long-distance trails that connect urban areas with outdoor resources, public lands, rural areas, and other communities. The bill would designate the American Discovery Trail the first of this new category of "Discovery Trails."

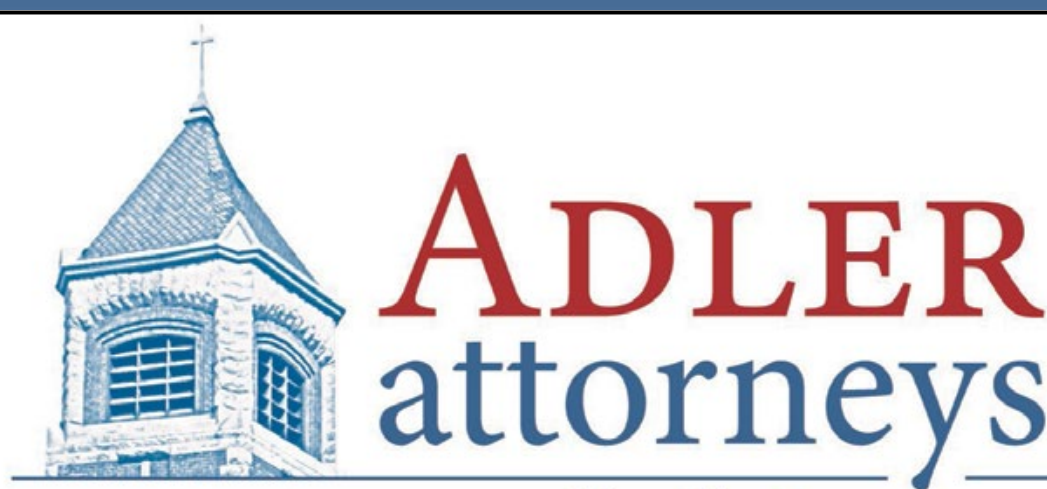

Major traffic shifts, ramps changes begin soon on I-465 & I-69 in northeast Indy

The REPORTER

Clear Path 465 contractors are preparing to rebuild and add lanes to Interstate 465 between Interstate 69/Binford Boulevard and the White River on the city's northeast side. The work will be completed in phases and require several traffic shifts, closures and changes to ramp access on I-465 beginning in early August.

I-465 eastbound shift and on-ramp closures

One weekend of traffic pattern changes will affect the I-465 eastbound lanes. It is expected to begin Friday evening, Aug. 5 and be completed before the Monday morning commute. Crews will restrict I-465 eastbound to one lane to restripe the pavement and shift traffic toward the outside shoulder.

The weekend traffic pattern changes include short-term and long-term ramp closures. The Keystone Avenue on-ramps to eastbound I-465 will close during the weekend restriping work and reopen before the Monday morning commute.

The long-term closure of the Allisonville Road on-ramp to eastbound I-465 is expected to begin during the weekend and the ramp will remain closed through 2024. The long-term closure is needed to allow room for construction, allow crews space to safely work, help crews work efficiently and to help keep traffic flowing during the Clear Path 465 project.

I-465 westbound shift and express lane

Traffic pattern changes affecting the I-465 westbound lanes are expected to begin the following weekend – Friday evening, Aug. 12 through early Monday morning, Aug. 15.

Crews will restrict I-465 westbound to one lane to restripe the pavement and shift traffic closer to the eastbound lanes. The weekend work will also restrict three ramps to one lane:

- 1. The I-69 southbound ramp to I-465 westbound
- 2. The I-465 westbound exit ramp to Allisonville Road
- 3. The I-465 westbound exit ramp to Keystone Avenue

When completed, the left lane of I-465 westbound

will shift across the center median for a temporary express lane from I-69/Binford Boulevard to Keystone Avenue. No large trucks will be allowed and the first exit ramp access out of the express lane will be at U.S. 31/Meridian Street.

The I-465 traffic pattern and temporary express lane are expected to remain in place for the rest of 2022. Three lanes will remain open in each direction for I-465 traffic.

I-69 southbound ramps to I-465

A temporary ramp will open for southbound I-69 traffic exiting onto westbound I-465, allowing the existing ramp to be closed and rebuilt. The ramp switch is expected to occur over one night on or after Friday, Aug. 12 and affect the southbound I-69 lanes.

Southbound I-69 traffic will be restricted to one lane with stoppages of up to 20

minutes as overhead signs and pavement markings are changed. The 96th Street and 82nd Street on-ramps to southbound I-69 will also close overnight.

When the southbound I-69 lanes and ramps reopen for the morning commute, a new traffic pattern will be in effect. **Traffic will exit to the right for southbound**

I-465 and from the center lanes for westbound I-465.

Adjusting to traffic changes

Drivers are urged to observe the signs and pavement markings and stay alert for other vehicles as they adjust to the new traffic patterns. Handsfree use of mobile mapping apps with real-time traffic is encour-

aged for local drivers seeking alternate routes.

Police are enforcing the reduced speed limits of 45 mph and other traffic violations in the work zone.

Heights’ own Sterling Weatherford, now a Colt, welcomes young Husky footballers

Everything came full circle for Sterling Weatherford on Wednesday.

The 2017 Hamilton Heights graduate is also one of the newest members of the Indianapolis Colts. Weatherford is participating with the team at Colts Camp, which is currently taking place at Grand Park. On Wednesday, Weatherford got a chance to see some of his fans, as team moms from the Hamilton Heights Youth Football League took some of the young Huskies to Grand Park for the camp.

“It was awesome,” said Weatherford. “It reminded me of when I was a kid and I came up to the training camp with my family.”

Weatherford said that 10 to 15 years ago, he was one of those kids, standing in their shoes. Now, he’s on the field.

“It’s hard to dream that big when you’re a kid, but for that dream to come true, it’s just super special and unbelievable,” said Weatherford.

The trip was organized by four of the HHYFL’s team moms: Stacia Renbarger, Susan Baber, Yumi Whitaker and Julia Schlatter. In addition to getting to watch the camp and meet Weatherford, the kids got have a little tailgate party and eat beforehand.

“They had a blast,” said Renbarger. “They had such a good time supporting him. It’s really good for them to watch and see how the hard work they’re putting in today could lead to something like that, even though we’re from a small school.”

Weatherford played college football at Miami University of Ohio and got quite a bit of attention as he progressed through school. He signed with the Colts at the end of the NFL Draft as an undrafted free agent, and is playing as a linebacker.

“It’s awesome,” said Weatherford. It means something to him to represent the city he grew up in.

“We have a great group of guys in the linebacker room that definitely have been very helpful, as you could imagine. Just giving advice and really just

showing how to play the right way.”

Weatherford was told by his fiancée Lydia Landwehr, also a 2017 Hamilton Heights graduate, about the planned trip.

“I knew that after practice, I would see a couple kids, but they definitely showed out,” said Weatherford.

“At Hamilton Heights, we have a very strong football program and a very strong youth football program,” said Renbarger. “The league is a very-tight knit group. Our sixth grade has done very well. These boys have followed Sterling’s story, and I used to teach Lydia dance, so I know her very well.”

The HHYFL moms invited some of the members of the third and fourth grade teams, the entire sixth-grade team and a few of the flag football team members to the trip to Grand Park to see Weatherford.

“He seemed like he was really thrilled,” said Renbarger. “He took pictures and gave hugs to the little ones. Signed the footballs and jerseys. Everybody was just really happy to see him, and he was really happy to see the boys, too.”

“Every single one of those kids, I saw myself in,” said Weatherford. He said that seeing the young Huskies brought everything full circle, and he also understands that those players are looking up to him. He said he recognizes “that it’s my responsibility to be that role model for those kids, and just lead them in the right direction” in how he acts, speaks and lives.

And while he is a role model to the young Huskies, Weatherford is finding role models on his new team.

“We got an awesome linebacker group, a bunch of amazing guys to look up to,” said Weatherford. “They definitely are helping us rookies figure out what it means to be in the NFL. They show us how to play, how to react, how to respond. They’re our role models.”

“People are always just trying to give back, pay it forward to the rookie classes coming in,” said Weatherford. “It’s a special bond.”

Reddick blasts at Verizon 200

Tyler Reddick celebrated a big victory at the Verizon 200 at the Brickyard on July 31 at the Indianapolis Motor Speedway. Reddick started from the pole, dropped back, then regained the lead on Lap 62 of the race, staying out front from there.

The two-lap overtime session was created when the caution flag flew on Lap 81 of the scheduled 82 laps. On a restart on Lap 80, multiple cars made contact in Turn 4, with the No. 3 BetMGM Chevrolet of Austin Dillon getting beached in the gravel trap.

Reddick, who took the lead for good on Lap 62 when the off-sequence Joey Hand pitted, led the field to the green-white-checked overtime restart on Lap 85, followed by AJ Allmendinger, Ryan Blaney, Ross Chastain and Daniel Suarez.

The field fanned out four-wide on the final re-

start heading into Turn 1, with Chastain pinned against the outside wall. Chastain decided to avoid a collision and Turn 1, instead taking the access road that bypassed the corner. He rejoined the circuit next to leader Reddick, taking the lead in Turn 6.

“I was just trying not to be in the carnage there in Turn 1,” Chastain said. “I thought we were four-wide and couldn’t go any farther right, so I decided to take the NASCAR access lane out there. Just pure reaction there.”

Reddick then powered past Chastain to regain the lead in Turn 14 with the white flag in the air, with Chastain, Cindric and Burton never making another challenge for the lead. Reddick crossed the finish line .576 of a second ahead of Chastain before Chastain was demoted by the penalty. The official margin of victory between Reddick and Cindric was 1.065 seconds.

Young driver leaves them all in the dust

Dominic Gorden couldn’t have debuted any better Wednesday at Indianapolis Motor Speedway, delivering a flag-to-flag victory in the preliminary event of the Drive2SaveLives BC39 Presented by WeatherTech at The Dirt Track at IMS.

The 16-year-old driver from Clovis, Calif., executed a deft last-lap pass on NASCAR Cup Series race winner Chase Briscoe to capture a heat race, then won the night’s featured event, the 25-lap Stoops Pursuit, from the No. 1 starting position.

Gorden was never seriously challenged in the nightcap, planting his No. 71K Keith Kunz/Curb-Agajanian Motorsports machine in the bottom groove as a host of others tried to run him down. The win in US-AC’s National Midget Series was arguably the biggest of the young driver’s career, and it doesn’t figure to be his last.

Not bad for someone who, prior to Wednesday, had never been to IMS and doesn’t have his official driver’s license.

“I was pretty nervous going into (the Stoops Pur-

suit), but after we got past the first and second yellow, I got a little more comfortable,” Gorden said.

The youngster’s next challenge comes Thursday night when the fourth BC39 is held with an 86-driver field that includes Kyle Larson, the 2021 NASCAR Cup Series champion who claimed victory in both nights of last year’s event in honor of the late Bryan Clauson, a Noblesville native who helped inspire the construction of this quarter-mile dirt track inside Turn 3 of the iconic oval.

The Stoops Pursuit capped an exciting first night of grassroots racing at the Racing Capital of the World. The evening began with hot lap sessions, followed by heat races, which help set the field for Thursday’s qualifying.

The process of setting the Stoops Pursuit starting lineup was straightforward, with the winners of each of the 10 heat races and the drivers passing the most cars in each heat advancing to the night’s main event. Four additional drivers were added to round out the 24-car field.

Jade Avedisian won the second heat, noteworthy be-

cause she is six weeks shy of her 16th birthday. Other heat winners included Chris Windom, Buddy Kofoid, Chance Crum, Michael Fac-cinto, Mitchel Moles, Tyler Courtney, Ethan Mitchell, Gorden and Zach Daum.

Included in the night’s featured race were NASCAR Cup Series stars Larson, Briscoe, Ryan Newman, Ricky Stenhouse Jr. and J.J. Yeley, plus 10-time World of Outlaws champion Donny Schatz.

The process of determining the night’s winner was unique. At the end of each five-lap segment, drivers who had been passed were eliminated, leaving eight to battle for the checkered flag.

While Gorden was largely alone in front, the action behind him was hectic, with Daum charging to second place with Trey Gropp third and Cannon McIntosh fourth.

A mid-evening rain delay forced a postponement of Tony Kanaan’s exhibition laps in a midget. The winner of the 2013 Indianapolis 500 presented by Gainbridge agreed to return Thursday night for his laps. He climbed in a midget for the first time just last month, turning 21 solo laps.

The NTT INDYCAR SERIES driver vowed to return to The Dirt Track next year to compete in the fifth BC39 event.

“I put a lot of pressure on (Clauson Marshall Racing to provide a car),” Kanaan said. “I want to do this next year.”

The Driven2SaveLives BC39 Presented by WeatherTech continues Thursday with another jam-packed day of racing at The Dirt Track at IMS. Public gates open at 4 p.m., with hot laps starting at 5 p.m.

Qualifying races begin at 6 p.m., and Main races at 7:45 p.m. will whittle the massive field down to 26 starters for the 39-lap feature event honoring Clauson at 9:30 p.m.

Tickets are still available at [IMS.com](https://www.ims.com) and at the gates. All Shaw Grandstand seats are reserved, and tickets start at \$45.
