My cousin and I were about four or five years old. I thought it was my turn to write on her chalkboard. She would not give up her place in front of the chalkboard. It was hers, after all. Apparently, she had not been taught to take turns, but neither had I. I bullied her out of the way.



A loud argument ensued. She was a pincher. I was a hairpuller. We expressed our feelings loudly and with a bit of physical aggression.

I can still hear my mother's gentle but admonishing words, "Girls, don't be ugly."

She separated us into "time out" corners and explained that we would not always agree, but we needed to treat each other nicely and respectfully.

Neither one of us would give up our chalk. We backed away from the chalkboard. I remember having to say I was sorry, as did my cousin. I don't think we grasped precisely what my mother was trying to teach us. Neither do I think we were all that sorry.

This lesson was taught many years ago, and I will always hear my mother's voice saying, "Don't be ugly."

It took time and a few more admonitions from my mother to fully understand that when I believe I am right, I can be very wrong if I do not treat others with respect and civility when I disagree with them. I had to learn to disagree agreeably. I can stand my ground with grace and kindness. I can never bully someone into agreeing with me.

Mom was never one to raise her voice, but it had a bit of an edge as she got her point across. She also had the "Audrey look" whenever she had had enough. Neither my cousin nor I ever wanted to cross that look.

Mom taught me never to get into an argument with someone who is shouting or name-calling. Just because I am louder

In 1991, the well-known Red Bridge Park Car Show began, and it has grown over the last 32 years to more than 200 cars participating annually.
















CHAMP Camp champions children

The truth is that it is very difficult to change anyone's mind once it is set. Read that again. Reaching a compromise is a lost virtue ... so it seems. Mom said that when people learn to compromise... everyone wins. Hmmm.

When it came to name-calling, that was also a big no-no in my mother's do-not-be-ugly rule book. She said name-calling is like mud. Whenever you sling it, you will get some on you as well. She did say she thought a few people were funny-turned.

As I got older, she would also say, "Don't stir manure because if you do, you will find yourself stinking as well.'

Mom said that a person's true character rises to the top or sinks to the bottom when people disagree. Mom taught me that sowing discord only grows resentment and anger.

I miss my mom ... and I miss her wisdom.

Who knew the power of her teaching me and my cousin not to be ugly ...

Please Lord, help me see others with eyes of grace and kindness. Let my words heal and encourage. I pray my opinions never harm the heart of anyone.

I'm tired of the loud voices. I'm tired of the ugliness.

If only the loud and angry voices could be put in "time out" until they can learn not to be ugly. It worked for my cousin and me. I think it could make this world a lot kinder and less ugly.

The board indicated anyone still can file a reconsideration form to flag books in the young adult section, and the titles would be moved to the adult section until the board updates its policy.

Waterman asked, "So just to clarify from an operational standpoint, there is a paragraph in the policy that relates to placement, age-appropriate placement. Are we suspending that until we figure it out?"

The controversy over reshelving young adult titles caused a large crowd to show up at last Thursday's meeting. The board had to set up an overflow room for people to participate in the meeting.

The updated policy has been under scrutiny from community members after it was revised in December 2022 and reviewed this year in January and April. The policy became more widely discussed after Indiana author John Green posted about the policy calling out the decision to move his most popular novel The Fault in Our Stars from the young adult section to the adult section.

Board member Ray Maddalone at the meeting said Green's book did not need to be moved because the sex scene in the "young adult" novel was not explicit and instead was "vague." He made a motion to move the book back to the Teen Zone, but later withdrew his motion.

Waterman told the board at the meeting that she disagrees that the discussion of sex in Green's novel is not explicit enough to require it to be moved to the adult section.

Waterman said the policy for reviewing books written for teens and young

adults is too vague. "Give us a clear policy

plement it," Waterman said.

Library staff had been operating with a zero-tolerance policy, but board secretary Ray Maddalone walked back that notion. "If something is on the fence, we want it to be left," he said.

"Absolutely the opposite," Waterman responded. "The operational response plan is clear, that if there is any question, we age it up and that would mean moving The Fault in Our Stars to the adult collection."

Board member Andre Miksha agreed with Waterman's understanding of the policy. "My understanding is yes, while there would be some grace extended, the policy itself is looking to be applied very specifically. Obviously, it was a message to me and seemed like to Edra (Waterman) and her staff it would be reasonable to say all of those terms should be narrowly construed and

The Collection Development Policy (hepl.lib.in.us/ policies) requires strict attention be given to nudity, alcohol and drug use, profanity, violence, and sexual content before a book is placed in the children or teen sections. If a book discusses any of those topics, it is then reshelved in the adult section.

The policy overrides recommendations from the publishers, authors, and librarians on where to shelve

Laura Aledring, former library board president, is also a member of the Noblesville School Board. The school board had appointed Alerding to the library board, but, on Aug. 15, voted to replace her with Noblesville teacher Bill Kenley. Alerding's term on the board ended last Saturday.

As a result, the library board's nominating committee met at 2 p.m. last Thursday, an hour before the full board meeting. The full library board has seven members.

During the nominating committee meeting, Alerding suggested Ditlevson replace her as president. Maddalone suggested Miksha or Craig Siebe as president. A discussion occurred about whether Ditlevson can serve on the Fishers City Council and the Hamilton East Library Board at the same time, but an attorney said the library board can discuss that prospect if she's elected in November.

The committee suggested new board officers: Ditlevson for president, Craig Siebe for vice president, Maddalone for secretary, and Miksha for assistant secretary and treasurer. The full board later approved the recommendation in a 4-3 vote.





Artificial sweeteners may not offer a much healthier option than sugar. Reductions in body fat are minimal. Current studies are somewhat concerning but are far from conclusive as many are underpowered, of sub-optimal study design, or based on non-clinical data. Many are observational rather than randomized-controlled prospective trials; there are undoubtedly confounding factors affecting the results including "reverse causation" wherenaturally consume more artificial sweeteners. Studies have conflicting results depending on study-design type. My best counsel is to limit sugar consumption, especially sugary drinks. If you are pleased with artificial sweeteners and find them beneficial, continue their use, but consider moderation in amount.



The first was very bright. He lived in Hong Kong and knew more American movies than I did. As an

We've seen homicide rates on the rise vey shows similar trends. for a number of years in Indianapolis. 

Overdose Lifeline provides training to combat substance use disorder & overdose at Guerin Catholic & Sheridan Community Schools

The REPORTER

Overdose Lifeline, a nonprofit dedicated to helping individuals, families, and communities affected by substance use disorder, is releasing first-year results from its School Naloxon and Emergency Preparedness Project, in partnership with CareSource.

The goal for the program is to reduce stigma around substance use disorder and improve preparedness of Indiana schools to respond to an overdose situation.

A year after the implementation of the program, 88 school districts across the state of Indiana now have at least one person

trained to respond to an overdose, with 505 total participants now trained. In Hamilton County, school staff at Guerin Catholic School and Sheridan Community Schools have been trained to recognize symptoms and administer naloxone safely to anyone experiencing an overdose.

"Around 90 percent of addictions in the U.S. originate during the teenage years. With this reality, it's essential that Indiana schools are prepared to know the signs of an overdose and respond accordingly," Overdose Lifeline Executive Director Justin Phillips said. "With our training

programs, we've already seen encourages an individual to conprogress in reducing stigma and educating school staff on appro-

priate responses to an overdose." In a survey given to participants before and after completing their training, they are asked questions about their education and skill perception regarding opioid overdose and naloxone distribution. After taking the training, 99 percent of participants were correctly able to describe how naloxone stops an overdose. The survey also shows improved responses around the misconception that the opioid training and overdose resources, overdose reversal drug naloxone visit OverdoseLifeline.org.



"Education is the best thing we can do to remove the stigma around substance use disorder," CareSource Indiana President Steve Smitherman said. "Seeing schools across the state embrace training for their staff and continue to support children affected by SUD after this first year is a rewarding part of our partnership. We're looking forward to seeing the impact to come over the next two years."

Carmel mourning death of boys lacrosse coach Jack Meachum

Carmel High School is mourning the unexpected passing of head boys lacrosse coach Jack Meachum.

Meachum, 31, died in a vehicle crash last Tuesday evening, Carmel Clay Schools confirmed to News 8

Hamilton County Sheriff's deputies were called around 7:30 p.m. last Tuesday to a two-vehicle crash at State Road 38 and Six Points Road near Sheridan. Upon arrival, deputies found Meachum's SUV in a ditch and a second vehicle on its roof on the side of the road.

Meachum died at the scene. The driver of the other vehicle, Brennan Smith, 26, Sheridan, died shortly after arriving at an Indianapolis hospital.

"For six years, Jack poured his heart and soul into the Carmel Lacrosse program, achieving the remarkable feat of securing a state title just last year. Jack's impact reached far mentored our student-athletes and dedicated significant time to working with youth," Carmel Clay Schools said in a letter to parents.

Meachum coached Carmel to its first boys lacrosse state championship in eight years when it beat Hamilton Southeastern 9-7 in the state championship game this past June at Roncalli.

In addition to his role at Carmel High School, Meacham served as the state chair for Maryland-based USA Lacrosse and was a member of the Indiana High School Lacrosse Association's executive committee, according to his LinkedIn profile. He was a graduate of Carthage College and, more recently, the University of Indianapolis.

In a statement on Twitter, Carmel Men's Lacrosse said, "We are saddened by the passing of Coach Jack Meachum. 





Carmel boys basketball Walt Morris getting the word out on aortic dissection symptoms

Last summer, Walt Morris learned a lesson that he now wants to teach other

The longtime basketball coach and Noblesville native was having several episodes of neck and jaw pain, and it came to a breaking point on July 25, 2022. Morris soon learned he had an aortic dissection, which required a lengthy surgery.

But Morris got through the surgery, and now wants to spread the word about the symptoms, and the need to get help right away - something that saved his life.

"I don't want anybody else to go through what I did," said Morris. "I'm fortunate to be here."

Early symptoms

A couple months prior to his diagnosis, Morris said he was having episodes where he was having trouble swallowing and started sweating. He was also having neck pain and "a lot of jaw pain."

"I blew it off, which wasn't smart," he said.

On that fateful day, Morris said he had just finished a three-mile walk/ run. When he got home, he was experiencing "jaw pain from my ear to my jaw," that he said knocked him to the ground. A man tried to help him up, but he walked back to his house.

Once he got home, he told his wife Lisa, who immediately got her husband to Riverview Health in No-

Morris participated in a series of tests that lasted the brother had. entire day. The doctors kept him overnight so he could have an ultrasound electrocardiogram (EKG) test. What was supposed to be a diagnosed Morris with an aortic dissection, in which a tear occurs in the inner layer of the aorta, which is the body's main artery. The ensuing rush of blood through the tear causes the inner and middle layers of the aorta to split, or dissect. (More information from the Mayo Clinic tinyurl.com/Mayo-AorticDissection.)

Minutes later, Morris was in an ambulance for a drive to Ascension St. Vincent Heart Hospital in Carmel.

"That was a bit surreal," said Morris. He remained calm and said prayers for his family during the ambulance ride, which Morris estimated took about 15 to 20 minutes.

The surgeons and staff were waiting for Morris when he arrived. The resulting surgery took 11 hours, but when it was done, Morris said "those incredible doctors somehow saved my life. Most men, you find them somewhere."

While the surgery was a success, it also required a few months for Morris to recover. That included getting back to his assistant coach duties with the Carmel boys basketball team, helping head coach Ryan Osborn.

"I thought I wasn't going to be able to coach and a lot of things were over," said Morris. "Coach Osborn was very patient."

"It was definitely a scary situation," said Osborn. "I think we're very fortunate that his wife was home and knowledgeable to get him the care that he

But by late September, Morris was able to get message out, hopefully back to business with the save some people," he said.

Greyhounds.

"It takes a while," said Morris. "You get your body opened up like that. It was scary for a while."

The 63-year-old Morris' main message with his story is that if anyone is having these symptoms, they need to get checked out right away. Morris was going through his daily routine in the months prior to his aortic dissection, but ignored the symptoms.

"I was physically active, worked the whole month of June," said Morris. Meanwhile, he felt those symptoms and "blew it off." He noted that the same condition can happen to "very active people, some of them in much better shape than I am. If you have this, it doesn't matter."

Another important aspect is family history. If patients mention that someone in their family have a history of this condition, a test will be set up quickly.

"If they don't say anything doctors and physicians aren't going to bring it up," said Morris. Patients have to be willing to go to bat for themselves in order to get the test.

"My father had an anuerysm at age 69," said Morris. "That's the other part, it was in my family history. I never told my doctor about it or my cardiologist. I didn't let them know, so there was no way to set me up for the EKG that I needed.'

After Morris' episode, everyone in his family got tested. His sister also had the exact same condition as Morris, and she had the same surgery that her

"They did her surgery in February," said Morris. "She's doing great now."

One year later

Almost one year to the half-hour test lasted a min- day after Morris' surgery, ute and a half, after which he put out a video that was posted on the Carmel boys' basketball Twitter account. The video lasts 1 minute and 23 seconds, but it makes its point very con-

Morris talked to Osborn, who said that if he could "put a good quality, short video together, we'll put it on our Twitter.'

"It was Ryan's idea to do that," said Morris.

"I think as teachers and coaches, we talk about the negative impacts of social media, and it's also proven in this scenario that it's a positive," said Osborn. Since it was posted on July 26, the tweet has received over 28,300 views. (You can view the video at tinyurl.com/CoachMorrisVideo.)

"He sat on it and really felt compelled to use it as a way to make an impact, and it's just the type of guy that Walt is, super positive and always wanting to help people," said Osborn. "Through this, he's been able to accomplish that."

Now ready to go for another season of Carmel boys basketball, Morris is happy to be back to his regular routine.

"I'm walking four and a half miles a day now, doing all of my normal part-time jobs, feeling better than I ever felt in a long time," he

And with this new lease on life, Morris also wants other people to be aware of the symptoms and to make sure they are ready to take action to save their own

"I'm never going to of the situation, and able know if this helps anybody," said Morris. "My job's to get it out."
