“I felt like I was always in fight or flight,” she said.

With the help of Family Nurse Practitioner Susan Julian, McDivitt recovered from more than just her stress fracture. Julian pointed her toward the Institute for Functional Medicine, through which McDivitt has become a certified practitioner.

In August, McDivitt opened her practice, Spark Vital Health, where she is committed to providing a patient-centered, collaborative approach to health care. Providing in-person and telehealth consultations, McDivitt tailors treatment plans to each individual patient.

In traditional medicine, a practitioner may diagnose a patient with a specific condition and offer treatment.

“It’s not that simple,” McDivitt said. “I ask why a person has that condition. I like to look at the root.”

In order to find the root cause of a medical condition, McDivitt takes a very detailed approach.

“I look at history, going back to when they were in their mother’s womb,” she said. “I look at the pillars of their health: brain, sleep, bowel habits, movement, nutrition.”

While traditional medical practitioners may be hesitant to run expensive tests, McDivitt has access to extensive testing of gut flora, pathogens, and inflammatory

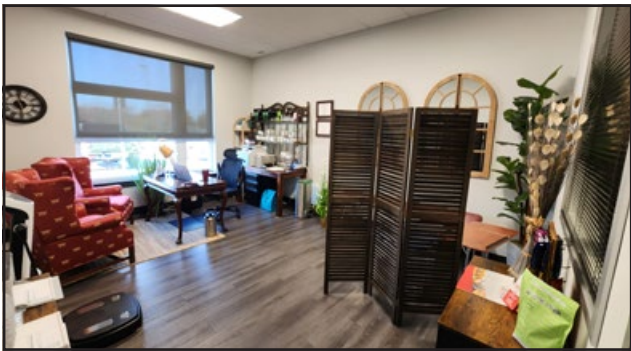

ry markers.

Knowledgeable in bioenergetics, which is the study of how your body converts food into energy, McDivitt can help patients identify disruptors to their mitochondrial function. Those disruptors can lead to conditions such as insulin resistance or adrenal issues in athletes. Proper treatment can help patients recover energy levels and relieve fatigue, brain fog, and chronic pain.

McDivitt utilizes InBody Scans, an advanced technology that assesses body composition and tracks progress. These scans can tell patients their visceral fat levels, or the amount of fat around their vital organs and shows body mass index (BMI).

“It’s very insightful,” she said. “It gives you more to work with than a regular scale and leads to improved results.”

“Eat whole foods and not processed foods,” McDivitt said. “Eat the rainbow. Eat fish twice a week. Drink plenty of water and sleep. These are all important.”

I grow nervous when he pops open the car hood. My father talks about V-6 and V-8. And I grow thirsty. “Do you know the difference between the two,” he asks. “Sure,” I say. “V-6 has a less variety of vegetables.”

I tend to joke around a lot when I’m in my father’s shop. It calms my nerves, but it shoots his all to hell. Still, he tries, my father does, and still he hopes that I will learn something useful. I really don’t see where he gets the patience. I really don’t. There is just too much automation going on under the hood. Too many moving parts to feel safe around.

My father warns me of the danger of battery acid. So I avoid the car battery. And then there’s those crazy fan blades promising the amputation of digits. And some things are very hot. And the turning of fan belts could snap a tie-wearing man’s neck if he’s not careful. Not that I wear ties ... but just saying. There are too many things to watch out for under a hood. Too much danger. I only have two eyes. I’d like to keep it that way.

I just don’t see how he does it. I really don’t. He can lie inside the damn thing, under the hood, his legs dangling out, making it look as if he’s being devoured by *Jaws*, and still get the job done.

I stand a safe distance away, praying for a nuclear war to begin. Or maybe for a 747 to come crashing down in our backyard. I

hope for anything horrible to happen before he can request that I hand him a tool that I can’t identify.

One time, my father jacked up the rear of my ’74 Ford Mustang II. The rear tires were in the air a good foot or so. It was an opportunity I couldn’t pass up. While he removed a hubcap, I pointed at the raised rear tires and said, “You know Dad, at first I thought these tires were running low, but now they seem high.” I expected the hubcap to spin at me full force, frisbee-like, in response. He could do without smartasses on his sacred grounds.

I can recall only one incident that bonded us in his garage. He needed me to help bleed the car’s brakes. After pumping the damn brake pedal a million times upon Dad’s command, the job was done. The brakes had run out of blood, I guess. My foot was numb. I felt that I had really accomplished

something.

My father smiled. He looked happy. He really did, my father. And then he did something that he’d never done before. He faced me and said, “Here, Son, use my hand goop to clean your hands.”

My hands weren’t dirty at all. All I had done was use my right foot to pump the brake. But I dipped my soft hands in the creamy stuff anyways. Just for Pops. The white goop squished between my fingers. It was a high point in father-son relations.

“You’re a man now,” his lone tear told me.

And I felt like one. I really did.

It was the last time I was called into his garage. We both knew something so grand could never be repeated.

My father seemed proud of me. He really did.

through the month of November. Its rounded, rising shape – just like the sun that shines after every storm – is a metaphor for the cause at the heart of Movember: men’s health.

“I am very proud of this piece,” Howe said. “I’m honored and delighted that it will be used for such an important campaign.”

This year, every \$5 received for Movember will go towards the placement of a white flag in the center of the roundabout. These flags will represent survivors, loved ones, and supporters and will create a visible and powerful display of unity and shared courage.

The hope is that the center of the roundabout will be a sea of flags that tell stories of triumph over the health challenges Movember shines a light on and will serve as reminders that overcoming them is not

just a personal victory, but a shared one.

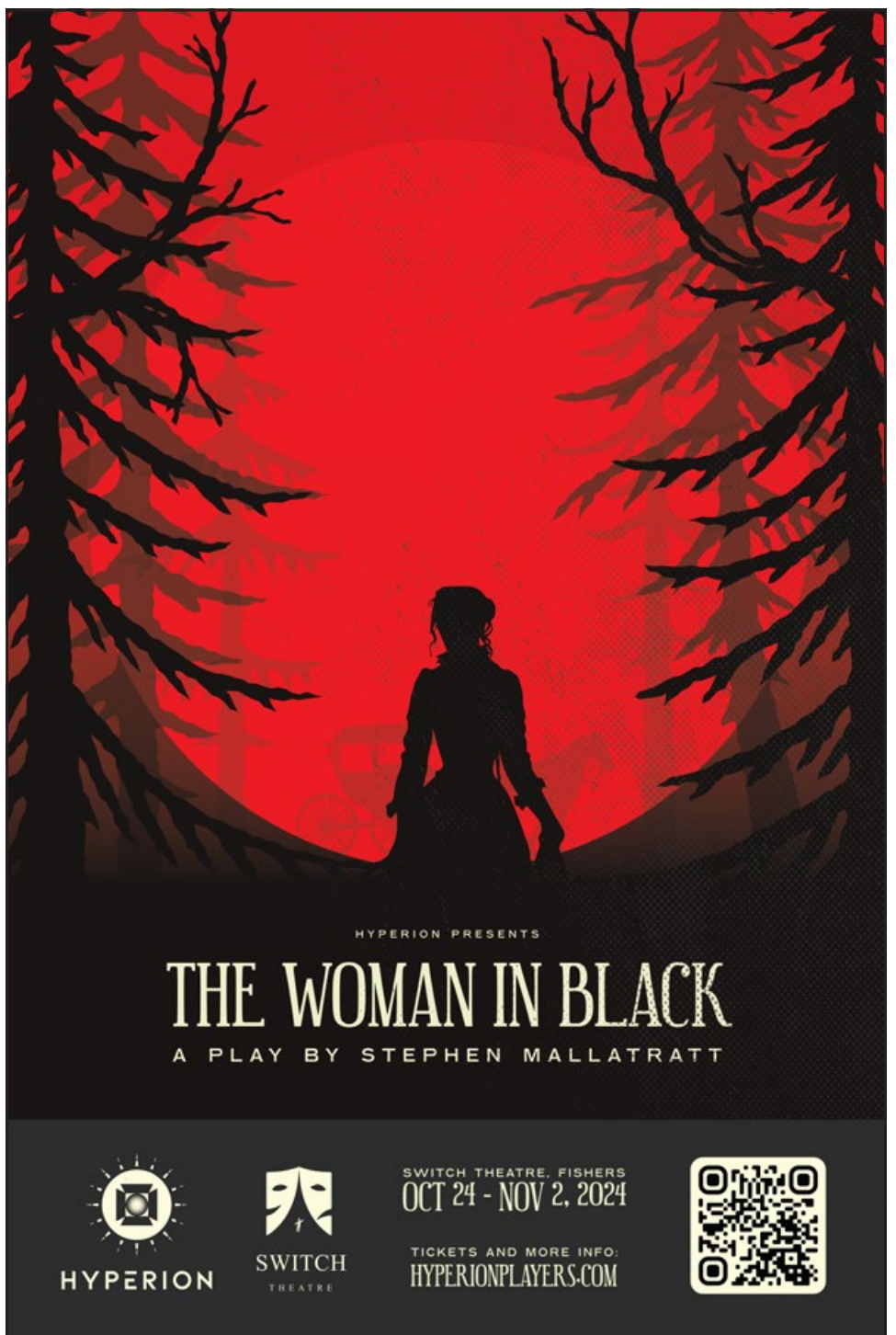

TODAY: Carmel hosts first Diwali festival, highlighting growth of Indian community

The Carmel city government soon will host its first **Diwali: Festival of Lights** at **Midtown Plaza**.

The festival is from 5 to 8 p.m. Saturday. The city’s Diwali Festival will mark more than just a holiday, but also nod to the growth and influence of the Indian com-

munity in Carmel.

Diwali — a major cultural event for the Hindu, Sikh, and Jain diaspora — typically falls in late October or early November. This year, the festival will be from 6:22 a.m. Oct. 31 to 8:46 a.m. Nov. 1.

Dr. Anita Joshi, a Carmel City Council member, said, “It’s celebrating light, the power of light over darkness, the power of knowledge over ignorance, and the power of good over evil.”

The first Diwali: Festi-

val of Lights in Carmel will have a mix of music, dance performances, traditional food from five local Indian vendors representing regions in India, fireworks, and a giveaway of ceramic tealights.

“This is that opportunity to bring that light out and so the diyas are the beautiful lights that we’ll be handing out at the festival,” the medical doctor and city council member said.

Joshi also said the Indian community has significantly grown in Carm-

el over the last five to 10 years. “I’ve certainly seen that growth tremendously. I think the community is super excited about having the opportunity to share the culture. Carmel has done a great job I think of promoting cultural festivals.”

The free event also was designed to let people give back to the community. “Charity is also a big part of the celebration as well, so we will be collecting canned goods.”

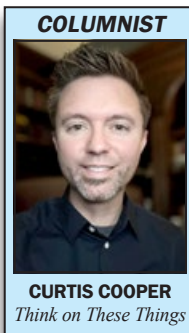
Is the Bible a blessing or a burden?

Some of you grew up hearing a preacher say, “Thou shalt ... thou shalt not.” Then your parents would tell you, “Do this ... don’t do that.” You were expected to follow all these rules.

But if you asked, “Why is that a rule?” they would say, “Because God said so” or “because I say so.”

Many of you grew increasingly frustrated because you never really understood WHY these were rules. Some of you did not grow up going to church, but you knew kids who did and never understood WHY so many rules. Because of that, many think God’s commandments are just a burden rather than a blessing.

However, the truth is that God is God, and we are not. He has both the right and the ability to command us because He is our Creator and understands what is best for us. Please know there are many groups who have made up their own rules and traditions they impose on their members. Additions to (or subtractions from) the word of God are not God’s rules but man’s. The Bible thoroughly equips us with every com-

mand (work) God wants us to follow (2 Tim 3:16-17). He has given us all we need for life and godliness (2 Peter 1:3).

So, why follow the Bible? Why God’s commands?

God’s rules are based on principles of God’s character.

God did not write a bunch of arbitrary rules, but every precept (general rules intended to regulate behavior or thought) is based upon a characteristic of God Himself. For instance, in Ephesians 4:25 God commands us to put away lying and to speak truth. Why truth? Because honesty and truth come from a real place. Truthfulness is not some concept developed in someone’s mind but of an actual Being. The Bible says, “God is truth.” Jesus says, “I am the truth.” Honesty exists in creation because it is a characteristic of its Creator, and that is why God gives rules about being truthful.

That is why mercy is right, and being merciless is wrong because God is merciful. Fairness is commanded because God is just. Purity is right, and promiscuity is wrong because God is holy and pure. Love is right

and hate is wrong because God is love. That is true of nearly every precept God gives us.

God’s rules are given to provide and protect us.

We have talked about God’s moral laws. Now let us look at other laws like assembling with saints, partaking of the Lord’s Supper, etc. These laws are intended to do one of two things for us: provide or protect.

Ever noticed the devil came on the scene for the purpose of challenging that? In Genesis 2:15-17 God gave man positive commands: Tend this. Eat from all these trees. If you cultivate this garden, you can have substance to live. If you eat from the Tree of Life, you will live forever. He was trying to provide something for them. But He also gave them a negative command: Do not eat from this tree because when you do you will die. In Genesis 3:1-5, the devil’s lie is this: No, you will not. God either does not care about you, or he is lying to you. He is just trying to keep you from something greater. Is that not the way some look at God’s rules? But the Bible begins with God telling us His commands are to provide and protect us. That is what good parents do. While there are parents more concerned

about themselves than the well-being of their children, God is NOT like that. When God gives rules, they are always for our good (cf. Dt 10:12-13).

1 John 5:3 says, “For this is the love of God, that we keep His commandments. And His commandments are not burdensome.” When I was a kid, children would make fun of me because I would not party, cuss, or do other things they did. They thought I was strange (1 Peter 4:4-5) and at that time God’s rules seemed like a huge burden in my life – until I grew up and saw God’s commandments for what they really are. God’s not a monster. God’s not trying to ruin my fun or my life. God loves me more than anyone else ever will. So, He speaks to me. He tells me some things not to do and some things to do because He wants to protect and provide for me.

He loves you and wants to do the same for you. Did you realize that?

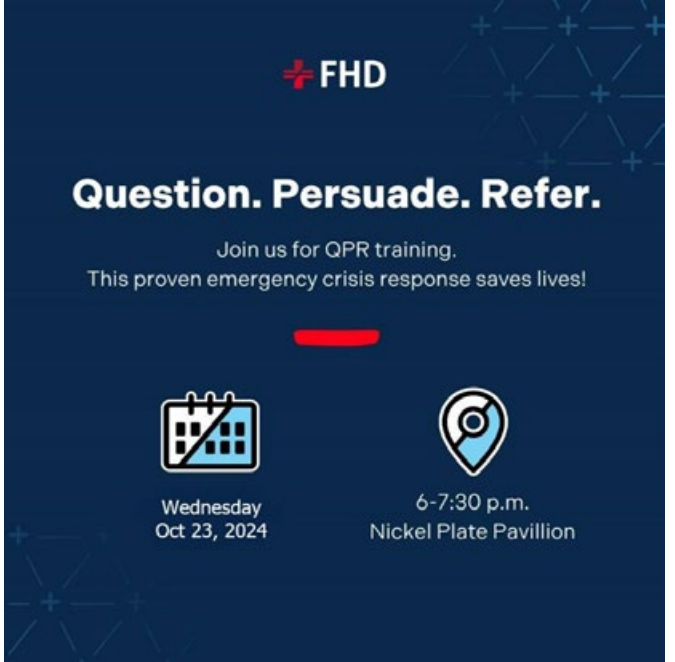

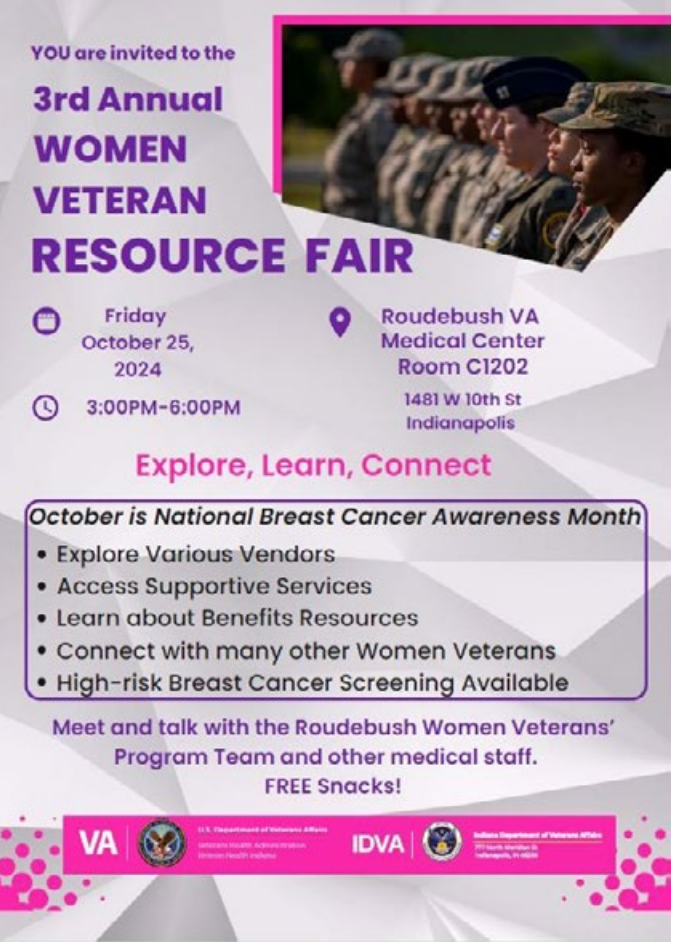

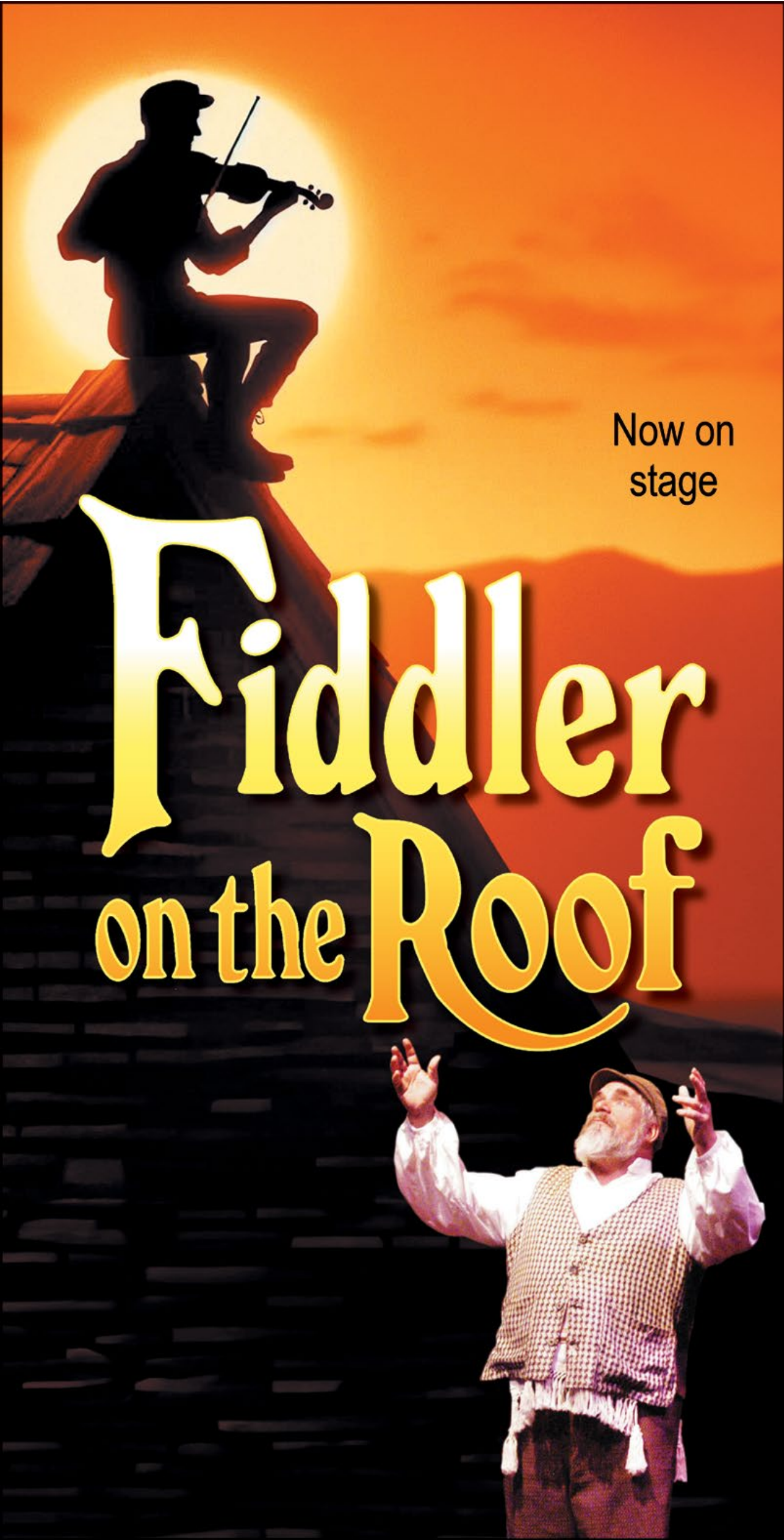

One of my favorite times of any year is around elections. For me, the news goes flat when it’s all over. I enjoy the research, discussions, and even canvassing door-to-door. thorities over their children’s lives and education, not uninformed bystanders. I want teachers on both sides of the aisle to be a part of the educational conversation. I want students to feel safe as well. As I was going door-to-door, I had a conversation with a conservative parent who tells her high schoolers to just keep their mouths shut during class, so their grades do not take a hit. What a travesty.

During a well-attended Meet and Greet with Dave Dawson, Alison Hanley, and Brad Helvey, I heard my three tenets affirmed.

So, if you are a fellow conservative, remember Dawson, Hanley, and Helvey (DHH) when you head to the polls to vote for Noblesville School Board candidates. Let’s get all three of them in office to affect the change we need.

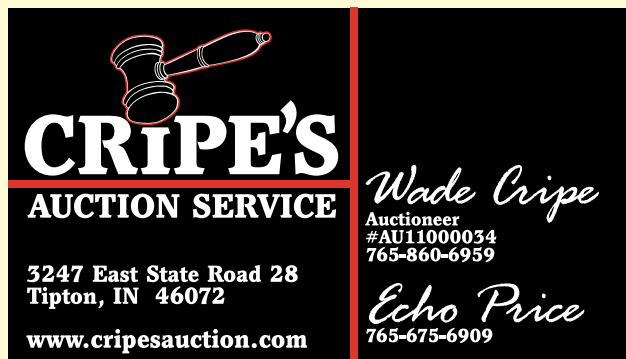

TODAY’S BIBLE READING

PROTECTION OF PROPERTY

“Whoever steals an ox or a sheep and slaughters it or sells it must pay back five head of cattle for the ox and four sheep for the sheep.

“If a thief is caught breaking in at night and is struck a fatal blow, the defender is not guilty of bloodshed; but if it happens after sunrise, the defender is guilty of bloodshed.

“Anyone who steals must certainly make restitution, but if they have nothing, they must be sold to pay for their theft. If the stolen animal is found alive in their possession—whether ox or donkey or sheep—they must pay back double.

“If anyone grazes their livestock in a field or vineyard and lets them stray and they graze in someone else’s field, the offender must make restitution from the best of their own field or vineyard.

“If a fire breaks out and spreads into thornbushes so that it burns shocks of grain or standing grain or the whole field, the one who started the fire must make restitution.

“If anyone gives a neighbor silver or goods for safekeeping and they are stolen from the neighbor’s house, the thief, if caught, must pay back double. But if the thief is not found, the owner of the house must appear before the judges, and they must determine whether the owner of the house has laid hands on the other person’s property. In all cases of illegal possession of an ox, a donkey, a sheep, a garment, or any other lost property about which somebody says, ‘This is mine,’ both parties are to bring their cases before the judges. The one whom the judges declare guilty must pay back double to the other.

—Hamilton County High School Football Sectionals, Round 1— Golden Eagles trounce West Vigo

NOBLESVILLE – The first round of the IHSAA football post-season began on Friday, and Guerin Catholic couldn’t have asked for a better start.

The Golden Eagles played solid football from start to finish in their Class 3A Sectional 29 first round game, overpowering West Vigo 49-0 at the Eagles Nest. Guerin Catholic scored touchdowns on its first five drives of the game and kept the momentum rolling in the second half with two more scores.

It was the Golden Eagles’ first shutout victory since Oct. 6, 2013, when they won a Week 8 game over Terre Haute North 42-0.

“The guys executed,” said GC coach Tom Dilley. “Certainly you want to go watch the film and there’ll be plenty of mistakes to correct. But I thought in general, they had a great game plan, the offensive coaches, and carried it out. And defensively, for the most part, did what we were supposed to do and tackled pretty well. The kids played hard.”

The tone was set right away. The Golden Eagles held the Vikings to a three-and-out to begin the game, then only needed five plays to score. Malcolm Houze picked up the first touchdown with a 21-yard run at the 8:45 mark.

Minutes later, Grant Beard recovered a fumble for Guerin Catholic on the West Vigo 32. Again, the Golden Eagles wasted no time scoring: Houze connected with Kolbe Klee to get GC to the 12, then Jack Linden made two runs to score, finishing with a three-yard trip to the end zone.

The pattern repeated itself in the next drive. Deklyn Frazer intercepted a Vi-

kings pass, which resulted in another Guerin march to the end zone. Linden finished the drive with a five-yard TD run with less than a minute left in the first quarter.

James Moody got his turn to make a big defensive play, grabbing an interception at the beginning of the second quarter. That resulted in a two-play drive: Houze connected with Julian Melendez for a 25-yard pass to the six, and Linden ran it in from there for his third score of the game.

West Vigo then made its deepest drive into GC territory, getting to the 40-yard line, but the Golden Eagles defense stopped it there, forcing a turnover on downs. Guerin Catholic turned that into points, with Houze throwing to Trevor Macey for a six-yard touchdown.

The Golden Eagles led 35-0 at halftime, so the entire second half was played with a running clock. But Guerin Catholic kept its foot on the gas. Houze found Melendez for a 20-yard touchdown early in the third quarter, then Linden ran in his fourth TD of the game with 2:58 left in the third.

“A guy like Julian Melendez, number 12, he had a bunch of key catches and big plays,” said Dilley. “He’s a senior, but he’s kind of a football rookie, so he needs those reps and those confidence-building moments, too.”

Golden Eagles kicker Nick Wilson was a busy man during the game, making all seven of his extra point attempts. Houze was highly efficient, completing 10 of 13 passes for 151 yards. Melendez had five of those catches. Linden led the rushing with 94 yards.

Guerin Catholic is 5-5 and plays at Hamilton Heights next Friday in the semifinals of Sectional 29.

Checkers to Wreckers

Joey was back in. In what has come to be classic Joey Logano fashion, he went out and won last week at Las Vegas Motor Speedway to grab a spot in the Championship 4. But it was not merely that Joey won that has people in an uproar, it was how he won.

In a race dominated by Christopher Bell, Logano gambled on fuel and put just enough distance between him and Bell to steal the win. Despite qualifying in the top five for Las Vegas, Joey hung around the back of the top 10 for most of the race. He made his move in the last 40 laps when, contrary to nearly every car on the racetrack, he stayed out, attempting to stretch his fuel and tires to the end of the race. With plenty of fuel and four fresh tires, Christopher Bell rocketed through the field, looking like he would catch Joey with one or two laps left. Ultimately, Bell came up about a half a lap short and Joey went to victory lap.

A stunned Bell could not believe what had happened. He had been perfect all day. He team made the correct strategy calls. Joey and crew chief Paul Wolfe’s strategy, however, was just a hair better. Don’t forget that this same scenario played out

when Logano won at Nashville this summer, stretching his fuel far beyond anyone thought possible.

He snuck into the playoffs. He snuck into the round of eight. And he stole a race to sneak into the Championship 4. Do not for a second count Joey Logano out of this 2024 Championship. Unquestionably, Joey Logano and Team Penske have lacked speed all year. He and his team have simply not had the speed to compete with Hendrick or Gibbs and have not been serious contenders on pure race-pace. All his three points-paying wins this year were strategy wins.

So, if he wins the Championship, is he a deserving champion? Is the current playoff system a legitimate way to crown a champion?

I guess my answer to those questions are yes and no. Logano would certainly be a deserving champion because he will have won according to the established rules. If he prevails at Phoenix, he will deserve a Cup Series Champion. Was he the best car (or even top five) all season? No, certainly not, but rarely does the fastest car win, especially in the Chase/Playoff era.

The second question: is the current playoff system legitimate? That’s not easy to say. It is hard to argue that there is not some arbitrariness to deciding the cham-

pion. Theoretically, a driver could win nine playoff races and lose the championship. As unlikely as that would be, if such circumstances became a reality, NASCAR would surely change the championship format. In fact, that very thing happened when Matt Kenseth won the 2003 Championship after winning only one race. NASCAR, rightly, concluded that more emphasis must be placed on wins.

Now it seems that the championship format has swung in the opposite direction. Too much emphasis is placed on wins. Logano surely will remember that from the summer Richmond race when he got bulldozed out of the lead by Austin Dillion.

If NASCAR is going to keep a playoff system, it must work to eliminate some of the randomness associated with crowning a champion. There were a lot of great championship battles in the mid-2000s. The problem was Jimmie Johnson won all of them. Perhaps it’s time give some thought to reimplementing a mid-2000s style points system. It does not have to look exactly the same, but the current knock-out style playoff system may have run its course.

Bao and Mu cruised past Bloomington South juniors Connor Couch and Joshua

Sang 6-1, 6-0.

“Came out a little shy, but loosened up probably five games in, and from there they were in a rhythm,” said Greyhounds coach Dan Brunette. “A lot of combination points, high serve percentage, some pretty tricky plays. And that shows you the confidence the two of them have.”

Bao and Mu are 17-3 for the season.

“They’ve played a lot of matches together,” said Brunette. “We had a lot of practices last two weeks.”

Rich and Osswald breezed to a 6-2, 6-3 win over Western juniors Aidan Mawbey and Kaleb York, improving their record to 21-7.

“I think they played great,” said Royals coach

Doug Gernert. “They had a rough start to the season, but they’ve been getting better every time and I think we’re starting to peak right at the right time. It’s actually a perfect time for this, to come to the state finals and be playing some of your best tennis and playing together as well.”

The other semifinal features Jasper seniors Caleb Schnarr and Eli Flick (27-1) taking on Brownsburg sophomores Ethan Cougill and Skyler Rose (24-5). The Jasper team received a bye into the semifinals, while the Bulldogs won in straight sets over the Peru team of senior Gavin Eldridge and junior Jackson Boswell 7-5, 6-4.

Today’s semifinal winners will play for the state championship at 2 p.m. at Park Tudor.

Candidate for Noblesville School Board, At Large

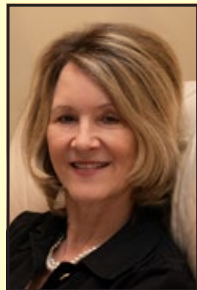

Candidate for Noblesville School Board, At Large

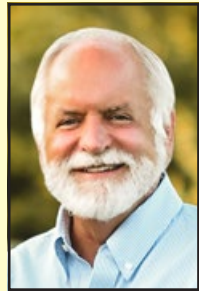

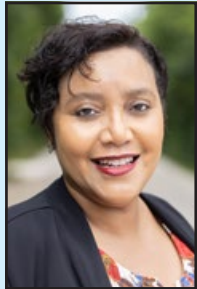

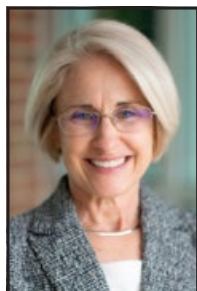


Dina Ferchmin

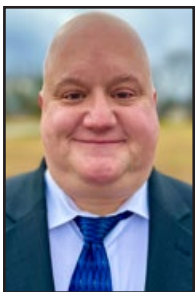
